Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Princeton Tool, Inc. 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

The following is a summary of certain provisions of the Princeton Tool, Inc. 401(k) Retirement Savings Plan (the "Plan"). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Participation – The Plan is a defined contribution plan, established January 1, 2010, covering all eligible employees of Princeton Tool, Inc. (the "Company") who meet the minimum service requirements. Employees are eligible to participate in the Plan after 6 months of service and attaining age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan is administered by the Company which is responsible for controlling and managing the operations and administration of the Plan.

Contributions – Participants may elect to make contributions of a specific percentage or dollar amount of their eligible earnings on a "pre-tax" or Roth basis subject to certain limitations of the Plan and the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan allows for safe-harbor Company matching contributions for eligible Plan participants who make salary deferrals including Roth and catch-up contributions. For the years ended December 31, 2024 and 2023, the Company's safe-harbor matching contribution was 100% of the first 3% and 50% of the next 2% contributed by employees to the Plan. All contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts – Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are at all times vested in their elective and voluntary contributions and the Company's safe-harbor matching contributions and earnings thereon. Vesting in existing balances of non-safe harbor Company contributions is based on years of continuous service. A participant is credited with 20% vesting per year of service starting after one year of service has been established and reaching 100% vested after six years of credited service. In the event of termination due to disability, a participant's Company contributions become 100% vested.

Payment of Benefits – A participant, upon retirement, termination, disability or the attainment of age 59½ or a participant's beneficiary upon the participant's death, may elect to receive a lump-sum amount equal to the value of his or her vested account balance. In the case of a severe financial hardship, the administrator, in its sole discretion, may direct distribution of all or a portion of the participant's voluntary contributions, subject to certain restrictions.

Note 1. Plan Description (Continued)

Forfeitures – Forfeitures may be used to pay any plan expenses or to reduce any employer contributions. There were \$10,442 and \$7,156 of forfeitures applied to reduce employer contributions during 2024 and 2023, respectively. Unallocated forfeitures at December 31, 2024 and 2023 were \$108 and \$52, respectively.

Notes Receivable From Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the plan administrator based on prevailing interest rates charged for loans which would be made under similar circumstances. Principal and interest is paid ratably through payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting – The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation and income recognition policies utilizing information provided by the custodian and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023 associated with defaulted loans.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of the Plan are paid by the Company or the Plan at the Company's discretion. Fees related to benefit payments and the administration of notes receivable from participants are charged directly to the affected participant's account and are included in administrative expenses.

Subsequent Events – The Plan has evaluated subsequent events through October 8, 2025, the date on which the financial statements were available to be issued.

Note 3. Unaudited Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The plan administrator received a certification from Fidelity Management Trust Company, the trustee of the Plan, acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the statements of net assets available for benefits at December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) at December 31, 2024, the related investment and loan interest activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 and investment related information in the accompanying notes to the financial statements. The information is unaudited by independent accountants.

Note 4. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodology used for plan assets measured at fair value:

- *Mutual funds and money market funds:* The fair value of investments held in these accounts is based on their quoted closing market prices in active markets for identical investments, and is classified as Level 1.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodology used from 2023 to 2024. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Party-in-Interest Transactions

Fidelity Management Trust Company is Trustee as defined by the Plan and is related to Fidelity Investments Institutional Operations Company, Inc. (the "Recordkeeper") and Fidelity Investments. Certain Plan investments are in a money market fund and mutual funds managed by Fidelity Investments, and certain administrative expenses are paid to the Recordkeeper. These transactions qualify as party-in-interest transactions.

Note 6. Plan Termination

The Company anticipates and believes that the Plan will continue indefinitely; however, the Company reserves the right to terminate the Plan at any time by an action of its Board of Directors subject to provisions of ERISA. In the event of termination of the Plan, participants would become 100% vested in their respective accounts, and the assets then remaining in the funds will be allocated and distributed to participants in accordance with the terms and provisions of the Plan.

Note 7. Income Tax Status

The Plan has adopted an approved volume submitter plan document. This plan document has obtained an opinion letter dated June 30, 2020 from the IRS in which the IRS stated that the document, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting the volume submitter document. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

Note 8. Risks and Uncertainties

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan allows for safe-harbor Company matching contributions for eligible Plan participants who make salary deferrals including Roth and catch-up contributions. For the years ended December 31, 2024 and 2023, the Company's safe-harbor matching contribution was 100% of the first 3% and 50% of the next 2% contributed by employees to the Plan. All contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts – Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are at all times vested in their elective and voluntary contributions and the Company's safe-harbor matching contributions and earnings thereon. Vesting in existing balances of non-safe harbor Company contributions is based on years of continuous service. A participant is credited with 20% vesting per year of service starting after one year of service has been established and reaching 100% vested after six years of credited service. In the event of termination due to disability, a participant's Company contributions become 100% vested.

Payment of Benefits – A participant, upon retirement, termination, disability or the attainment of age 59½ or a participant's beneficiary upon the participant's death, may elect to receive a lump-sum amount equal to the value of his or her vested account balance. In the case of a severe financial hardship, the administrator, in its sole discretion, may direct distribution of all or a portion of the participant's voluntary contributions, subject to certain restrictions.

Note 1. Plan Description (Continued)

Forfeitures – Forfeitures may be used to pay any plan expenses or to reduce any employer contributions. There were \$10,442 and \$7,156 of forfeitures applied to reduce employer contributions during 2024 and 2023, respectively. Unallocated forfeitures at December 31, 2024 and 2023 were \$108 and \$52, respectively.

Notes Receivable From Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the plan administrator based on prevailing interest rates charged for loans which would be made under similar circumstances. Principal and interest is paid ratably through payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting – The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation and income recognition policies utilizing information provided by the custodian and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023 associated with defaulted loans.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of the Plan are paid by the Company or the Plan at the Company's discretion. Fees related to benefit payments and the administration of notes receivable from participants are charged directly to the affected participant's account and are included in administrative expenses.

Subsequent Events – The Plan has evaluated subsequent events through October 8, 2025, the date on which the financial statements were available to be issued.

Note 3. Unaudited Information

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The plan administrator received a certification from Fidelity Management Trust Company, the trustee of the Plan, acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the statements of net assets available for benefits at December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) at December 31, 2024, the related investment and loan interest activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 and investment related information in the accompanying notes to the financial statements. The information is unaudited by independent accountants.

Note 4. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodology used for plan assets measured at fair value:

- *Mutual funds and money market funds:* The fair value of investments held in these accounts is based on their quoted closing market prices in active markets for identical investments, and is classified as Level 1.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodology used from 2023 to 2024. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Party-in-Interest Transactions

Fidelity Management Trust Company is Trustee as defined by the Plan and is related to Fidelity Investments Institutional Operations Company, Inc. (the "Recordkeeper") and Fidelity Investments. Certain Plan investments are in a money market fund and mutual funds managed by Fidelity Investments, and certain administrative expenses are paid to the Recordkeeper. These transactions qualify as party-in-interest transactions.

Note 6. Plan Termination

The Company anticipates and believes that the Plan will continue indefinitely; however, the Company reserves the right to terminate the Plan at any time by an action of its Board of Directors subject to provisions of ERISA. In the event of termination of the Plan, participants would become 100% vested in their respective accounts, and the assets then remaining in the funds will be allocated and distributed to participants in accordance with the terms and provisions of the Plan.

Note 7. Income Tax Status

The Plan has adopted an approved volume submitter plan document. This plan document has obtained an opinion letter dated June 30, 2020 from the IRS in which the IRS stated that the document, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting the volume submitter document. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

Note 8. Risks and Uncertainties

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
