## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the St. James Hospital 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan available to all employees of St. James Hospital (the Hospital) who meet certain eligibility requirements as defined by the Plan document. The Plan is administered by the Hospital who has elected a Retirement Plan Committee to oversee operations and management of the Plan. Newport Trust Company, LLC (Newport) is the custodian and recordkeeper of the Plan. The USI Consulting Group also provides recordkeeping and administrative functions for the Plan. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974. The initial effective date of the Plan was January 1, 2020. Prior to this date, employees of the Hospital participated in a different, multi-employer plan. Upon inception of the Plan, participant balances for Hospital employees were transferred into the newly formed Plan.

#### **Eligibility**

Employees who are not a union employee, nonresident alien, leased employee, part-time employee scheduled to work less than 1,000 hours, temporary employee, or seasonal employee and that have attained the age of 21 are eligible to participate in the Plan after completing one month of service. All eligible employees can begin salary deferrals on the first day of the month coinciding with or next following the date requirements are met. Participants are eligible to receive Hospital contributions upon reaching age 21 and completing one month of service for employer matching contributions, or upon reaching age 21 and completing one year of service for employer profit sharing contributions.

#### **Contributions**

Active participants may make voluntary contributions in the form of salary reductions. Pre-tax contributions are limited to a maximum contribution of the lesser of 100% of the participant's total compensation for the Plan year or the maximum amount permitted by the Internal Revenue Code (IRC) and any applicable rollovers from other qualified Plans, subject to certain limitations of the Plan and IRC. Eligible participants, that attain the age of 50 before the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the IRC.

The Hospital makes matching contributions equal to 3.0% of the participant's compensation, plus 50% of the amount of the participant's elective deferral that exceeds 3.0% but does not exceed 5% of their compensation. In addition, the Hospital may make discretionary profit-sharing contributions if approved by the Hospital Board of Directors. There were no discretionary profit-sharing contributions approved for the years ended December 31, 2024 and 2023.

Eligible employees are automatically enrolled in the Plan at a 3% deferral rate. There are currently no annual escalation provisions.

## 1. DESCRIPTION OF PLAN (Continued)

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Hospital's contribution and an allocation of Plan earnings (losses) on all contributions. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings/(losses) or account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are fully vested in their elective deferrals and actual earnings thereon immediately upon participating in the Plan. Participants are subject to a vesting schedule relative to the Plan's employer matching contribution – 20% each year over a five-year span, at which time they are 100% vested, and profit-sharing contributions – 20% after two years and fully vested after three years.

### **Payment of Benefits**

Vested funds are paid to the participants when they retire or terminate employment with the Hospital, upon attaining early retirement age of 55 and completing at least 5 years of service, or normal retirement age of 65. Benefits may be paid out in a single lump-sum or in periodic installments over a period that is not greater than or equal to the life expectancy of the participant.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued interest. Participants may borrow from funds attributable to the participants' employee elective deferral contributions, vested Hospital contributions and rollover contributions. Participants may borrow a minimum of \$1,000 and have a maximum of two loans at one time. Loans are repayable through a payroll deduction or check for prepayment purposes for a term of five years, except for the purchase of a principal residence which is ten years. All loans bear interest at the prime rate + 1%. All outstanding loan balances will become due and payable in their entirety upon severance of employment unless directly rolled over to another employer's plan.

### **Hardship Withdrawals**

Prior to age 59 ½, a participant may withdraw his or her participant contributions for reasons of hardship. All hardship withdrawals must comply with the rules relating to hardships which are uniformly applicable to all participants.

### **Forfeited Accounts**

Forfeitures are used to reduce employer matching or profit-sharing contributions. Forfeited accounts were \$750 and \$2,388, respectively, for the years ended December 31, 2024 and 2023 and were allocated per Plan provisions.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States of America.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Investments**

Investments are reported at fair value (except for fully benefit responsive guaranteed investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments sold, as well as held, during the year.

All investments are participant directed.

### **Fair Value**

Generally acceptable accounting principles establish a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable assets (Level 3). The three levels of fair value hierarchy are as follows:

- Level 1 - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Registered investment companies:* Fair value is determined using market quotations or prices obtained from independent pricing services. Included in registered investment companies are variable annuity contracts, which are valued based on each account's daily net asset value corroborated against individual underlying holdings that are primarily valued using market quotations.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, political, currency, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Payment of Benefits

Benefit payments to participants are recorded when paid.

### Administrative Expenses

Substantially all administrative expenses associated with the Plan are paid by plan participants. Management fees and operating expenses charged to the Plan are deducted from earnings daily and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in the fair value of investments.

### Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### 5. COLLECTIVE INVESTMENT TRUST

The Putnam Stable Value Fund (the Fund) is a collective investment trust. The fund is designed to provide a stable fixed income and invests in cash alternatives, traditional GICs, and wrapped, actively managed strategies and similar contracts issued by insurance companies, banks and other financial institutions. Stable value funds purchase contracts from insurance companies and banks that are considered "benefit responsive," allowing participant transactions at contract value regardless of market value.

Each individual book value contract has an associated crediting rate (or interest rate). The portfolio is valued daily, and the crediting rate is calculated based on the weighted average of the crediting rates of all of the book value instruments of the fund. The portfolio calculates interest on a daily accrual basis, and the crediting rate fluctuates daily. The overall portfolio crediting rate will fluctuate based on contract crediting rates as well as trading and cash flow activity.

Unlike an insurance company general account product, stable value third-party pooled funds (including Putnam Stable Value Fund) and segregated accounts do not guarantee principal and interest, and there is no guaranteed floor for the interest rate at the fund level. Insurance company general account and separate account contracts only guarantee principal and interest to the extent of the creditworthiness of the issuing insurance company. The actual rate of return for the years ended December 31, 2024 and 2023 was 3.81% and 3.32%, respectively.

Withdrawals from the Fund will generally be permitted daily at contract value, however if the Fund determines, in its sole discretion, that the fund does not have sufficient liquidity to meet any withdrawal request, the fund may defer honoring any payment request or other obligation, if, as a result of the closing or other disruption of financial markets or exchanges, the fund is unable to settle the necessary transaction prudently in order to honor on a timely basis such payment request or other payment obligation. The Fund may defer honoring employer withdrawal requests (e.g., a withdrawal due to plan termination) or an asset allocation fund's withdrawal request, for up to 12 months. Notwithstanding such 12-month deferral, qualified employee-initiated benefit payments generally will continue.

The Fund negotiates contracts with certain employer-initiated transaction provisions including percentage allowances for targeted layoffs, bankruptcy resulting in employee job loss, reorganizations, spin-offs, and plan terminations. Due to the size of the Fund and the specific percentage allowances negotiated by the Fund, it is highly unlikely (not probable) that any event would occur that would limit the Fund's ability to transact at contract value with each issuer under these events.

## **5. COLLECTIVE INVESTMENT TRUST (Continued)**

The only event or circumstance that would allow issuers to immediately terminate a fully benefit-responsive wrap contract with the Fund at an amount different from contract value would be if they were provided with willingly fraudulent information about the Fund by the Trustee. This would constitute a breach of contract and would allow for termination at a value that could be different from contract value.

## **6. PARTY-IN-INTEREST TRANSACTIONS**

The following are considered parties-in-interest based upon their relationship and services they provide to the Plan:

- Plan Participants with outstanding notes
- St James. Hospital, Inc. - Plan Sponsor
- USI Consulting Group - Third Party Administrator
- Newport Trust Company -Trustee and Custodian of Plan Assets
- Bonadio & Co., LLP - Plan Auditor

As such, transactions involving any of the above qualify as party-in-interest transactions.

## **7. TAX STATUS**

The Plan adopted a pre-approved plan offered by Newport Group Inc. The pre-approved plan received an IRS Opinion Letter dated November 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is exempt.

## **8. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

## **9. RECONCILIATION TO FORM 5500**

Certain items may be classified differently between the accompanying financial statements and Form 5500. Net assets available for benefits and the change in net assets available for benefits per the financial statements agree to Form 5500 in total as of December 31, 2024 and 2023, and for the years then ended.

## **10. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through September 25, 2025, which is the date the financial statements were available to be issued.
