We have performed audits of the accompanying financial statements of the North Central Mental Health Services, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the North Central Mental Health Services, Inc. (the Organization) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all eligible employees of the Organization who have at least one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Plan participants may contribute up to 100% of their annual compensation, limited to the maximum salary deferral permitted by the Internal Revenue Code (IRC). The Organization contributes 50 percent of the first 6 percent of base compensation that a participant contributes to the Plan. In addition, the Organization will make a standard contribution equal to 1 percent of each employee's compensation, whether they contribute to the Plan or not. Additional Organization contributions may be made at the option of the Organization's board of directors.

Participant accounts - Each participant's account is credited with the participant's contribution, the employer matching contribution and standard contribution, and allocations of (a) Plan earnings, and (b) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting - Participants are immediately vested in their voluntary contributions, the one percent standard Organization contribution, and actual earnings thereon. Vesting in the Organization's matching and discretionary contributions, and actual earnings thereon, is based on years of continuous service. Participants become vested in the Organization's matching and discretionary contributions based on the following schedule:

Forfeitures - At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,729 and \$14,442, respectively. Forfeitures remain in the plan and are applied to reduce employer contributions, in accordance with the plan provisions.

Payment of benefits - Upon termination of service, a participant may elect to have his or her vested account balance distributed before the date that it would normally be distributed. If the participant so elects, he or she is entitled to receive his or her vested account balance paid in a lump-sum, which is normally subject to income taxes, or rolled over into an Individual Retirement Account (IRA) or another qualified employer plan.

Notes receivable - participants - Generally, participants may borrow amounts up to 50% of their vested account balances, but not more than \$50,000. Loan transactions are treated as directed investments of a participant's account under the plan. Repayments of principal and interest are credited to the participant's account. The withdrawals will not be considered a termination withdrawal, as long as a systematic repayment schedule is maintained. Terms of the notes are generally less than 5 years, and interest rates are determined by the administrator by reviewing the interest rates charged by similar types of loans by other lenders. The balance of notes receivable from participants for the years ended December 31, 2024 and 2023 were \$174,932 and \$190,287, respectively.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

Investment Valuation and Income Recognition - The Plan's assets are held and invested by the Trustee until needed to pay benefits. A share of investment gains and losses is allocated to the account of each Plan participant. All investments are participant-directed. Investments are comprised of mutual funds. The Plan's investments are stated at fair value, in which shares of registered investment companies and U.S. government securities are valued at quoted market prices that represent the net assets value of shares held by the Plan at year-end. Participant loans are stated at cost, which approximate fair value. Investment transactions are recorded on a trade-date basis.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as, interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Payment of Benefits - Benefits are recorded when paid. Included in distributions on the statement of changes in net assets are corrective distributions of \$2,933 and \$17,502 for the years ended December 31, 2024 and 2023, respectively. These distributions represent payments to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan for the prior year 2024 and 2023, respectively.

**NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE**

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan has filed an Application for Determination for Employee Benefit Plan to obtain a favorable tax determination letter from the IRS, and the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

**NOTE 5 - TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of plan year end, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions. There are currently no audits for any tax periods in progress.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

**NOTE 8 - RELATED PARTY TRANSACTIONS**

Certain investments held by the Plan are managed by Fidelity, an affiliate of the Plan's trustee, and therefore qualify as party-in-interest transactions as defined under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan paid recordkeeping fees totaling \$69,365 and \$63,847 for the year ended December 31, 2024 and 2023. All such transactions are permitted by the Plan and are exempt from the prohibited transaction rules under ERISA.

**NOTE 9 – RESTATEMENT OF BEGINNING NET ASSETS AVAILABLE FOR BENEFITS**

The beginning net assets available for benefits have been restated to correct for an error in reported deemed distributed loans. Prior financials reflected defaulted loans that were deemed distributed for non-payment as a distribution. However, for generally accepted accounting principles (GAAP), these loans should not have been reported as a distribution but continued to be carried as notes receivable plan assets until a distributable event occurs (employment termination, death or disability).
