Report on Audit of the Financial Statements

Opinion

We have audited the financial statements of Confederated Tribes of Grand Ronde Employee Health Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and fiduciary net position available for benefits as of December 31, 2024 and 2023, the related statement of changes in benefit obligations and fiduciary net position available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the benefit obligations and fiduciary net position available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its benefit obligations and fiduciary net position available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS) and *Government Auditing Standards*. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS and *Government Auditing Standards* will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Other Matter-Required Supplementary Information

Management has omitted management's discussion and analysis that accounting principles generally accepted in the United States of America require to be presented to supplement the Plan's financial statements. Such missing information, although not a part of the Plan's financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the Plan's financial statements in an appropriate operational, economic, or historical context. Our report on the Plan's financial statements is not affected by this missing information.

Other Matter-Supplemental Schedule Required by ERISA

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of schedule H, part IV, line 4i – schedule of assets held at end of year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements, or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.

1) Description of Plan

The following description of Confederated Tribes of Grand Ronde Employee Health Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

General

The Confederated Tribes of the Grand Ronde Community of Oregon Welfare Benefits Master Trust (the “Trust”) was formed effective March 1, 2004, as a Voluntary Employee Beneficiary Association (VEBA) Trust. The Trust agreement provides that a bank or other qualified financial institution may serve as a custodian for all or part of the Trust assets. The Plan is sponsored by the Confederated Tribes of the Grand Ronde Community of Oregon (the “Tribe”). The Trust is actively managed by the Tribe. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. As of December 31, 2024 and 2023, there were 1,495 and 1,410 employees participating in the Plan, respectively. Effective July 1, 2024, the Plan changed their third party administration (TPA) services from Shasta Administrative Services, Inc., to Forest County Potawatomi Insurance Department.

Eligibility and Benefits

All active, full-time employees of the Tribe, Spirit Mountain Gaming (SMGI), Grand Ronde Food and Fuel (GRFFCO) (collectively, the “Employer”), who are scheduled to work at least 30 hours per week, are eligible to participate in this Plan. For employees of the Tribe, coverage begins on the first day of the month following 30 days from the date of hire, provided the employee is actively at work and has submitted a completed enrollment form to the Benefits Department within 31 days of that date. For employees of SMGI and GRFFCO, coverage begins on the first day of the month following 60 days from the date of hire, provided the employee is actively at work and has submitted a completed enrollment form to the Benefits Department within 31 days of that date.

An employee who is absent due to a health factor is considered to be actively at work for eligibility purposes of the Plan; however, they must have actually reported for their first day of employment in order to be eligible for any benefits, even if all other eligibility requirements have been met. Temporary employees, leased employees, independent contractors, and seasonal employees are not eligible to participate in the Plan. The exception to this, under the Affordable Care Act, is temporary and seasonal workers who meet the above requirements of the company they are employed by. Former employees may elect coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions, if they experience a qualifying event as defined in COBRA.

The Plan is a group health plan that offers preventive care; medical, vision, dental and mental health services; substance abuse treatment and prescription drug benefits. Other than the preventive care and allowable health management services, the Plan provides benefits covering procedures, services and supplies that are medically necessary for the diagnosis or treatment of an illness or injury (not covered by workers' compensation) at an appropriate level.

Self-Insured Benefits

All benefits under the Plan are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims administrators under administrative services only (ASO) arrangements. The claims administrators pay claims directly to or on behalf of participants and are then reimbursed by through the Trust or the general assets of the Tribe. Despite the Plan's utilization of third-party claims administrators, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan has a flexible spending account (FSA) that is funded solely through participant contributions. The FSA allows eligible participants to be reimbursed tax-free for qualified medical expenses, subject to a specified ceiling. Amounts remaining at the end of the year can be used up to 90 days after the year-end to pay for claims incurred during the year. In addition, participants may carry up to \$500 over to the next year. The Employer is not permitted to refund any part of the balance to the employee, and the account cannot be used for anything other than reimbursements for qualified medical expenses. Upon termination of employment, the participant must submit claims within 90 days for reimbursement of any claims that were incurred prior to termination.

Contributions

Employees contribute specified amounts to the Plan through payroll deductions, based on their benefit elections and coverage elected for spouses and eligible dependents. The Employer makes contributions to the Plan as needed to fund claims in excess of employee contributions. Any deficiency of the Plan's fiduciary net position over benefit obligations is funded by the Employer as needed.

Employee and employer contributions to the Plan are deposited to the Plan's bank account. Contributions are made to the Trust, after consideration of contributions by participants, which are intended to fund future Plan obligations, participant benefits and certain administrative costs of the Plan.

Plan Administration

Effective July 1, 2024, the Plan utilizes a third-party administrator (TPA), Forest County Potawatomi Insurance Department, to provide administration, recordkeeping and claims processing services to the Plan. Prior to July 1, 2024, the TPA services were provided by Shasta Administrative Services, Inc. Certain administrative expenses are paid by the Plan. Other administrative expenses are paid by the Employer and are excluded from these financial statements.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles promulgated by the Governmental Accounting Standards Board (GASB).

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. The fair value of the Plan's interest in the pooled investments held by the Tribe is based on the specific interest in the pooled investment accounts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Allocated net income (loss) from pooled investments held by the tribe includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of benefit obligations and fiduciary net position available for benefits.

Payment of Benefits

Claim payments are recorded when paid by the third-party claims administrators. Amounts due to the claims administrators that have yet to be reimbursed by the Plan are recorded as claims payable in the accompanying statement of benefit obligations and fiduciary net position available for benefits.

Benefit Obligations

An estimate for claims incurred but not reported (IBNR) is based on actual claims filed subsequent to year-end. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of fees paid to the third-party claims administrators. Administrative expenses that are paid by the Employer are not included in the accompanying financial statements.

Subsequent Event

Management has evaluated subsequent events for reporting or disclosure for the Plan through October 6, 2025, the date which the financial statements were available to be issued.

3) Cash

Cash consists of bank checking accounts. The Plan maintains its cash balances at a financial institution that, at times, exceed federally insured limits. The Plan has not experienced losses in these accounts and believes it is not exposed to any significant custodial credit risk.

4) Investments and Investment Risk Disclosures

The Governmental Accounting Standards Board (GASB) issued Statement No. 72, *Fair Value Measurements and Applications*, which provides the framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan participates in an investment pool offered by the Tribe. The Plan purchases units of the investment pool that represent the Plan's relative percentage ownership in the entire pool. Pooled investments are held by the trustees in the name of the Tribe and are managed by outside managers, with oversight by the Tribe and a third-party investment advisor. Pooled investments include obligations of the federal government and its sponsored organizations, money market funds, mutual funds, corporate stocks and bonds, real estate funds, and notes and contracts invested pursuant to Tribal investment policies. Investments are stated at fair value as determined by quoted market prices, where available. The Plan's share of the Tribe's pooled investments were all held in money market funds, mutual funds, and corporate stocks and bonds.

Investment income earned on the assets of the investment pool is distributed to appropriate funds and participating component units based on the month-end equity balance in accordance with Tribal policy.

Although the pooled investments are valued based on the net asset value (NAV) of underlying assets, which are publicly available, the unit prices of the accounts within the investment pool are not traded in the public exchange market. Assets measured using NAV as a practical expedient are not assigned a level in the fair value hierarchy. Management has determined that the investments using NAV as a practical expedient do not have published prices; therefore, the investments are not included in the fair value hierarchy.

Investment Policy

The Plan invests in investments to construct a portfolio with aggregate risk and return characteristics in a desired range. Adherence to the specific investment objectives and criteria contained herein will be evaluated over a full-market cycle, which historically has been three to five years.

Interest Rate Risk

This is the risk that changes in market interest rates will adversely affect the fair value of an investment. Investments with longer maturities have greater sensitivity to fair value changes based on market interest rates. All Plan investments are exposed to this risk.

Credit Risk

Credit risk exists when there is a possibility that the issuer or other counterparty to an investment may be unable to fulfill its payments on a security under the original term. All Plan investments are exposed to this risk.

5) Plan Termination

Although it has not expressed any intention to do so, the Trust has the right under the Plan to modify the benefits provided to active employees and other participants, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions set forth in ERISA.

6) Tax Status

The Trust established under the Plan to hold the Plan's assets applied for tax-exempt status pursuant to section 501(c)(9) of the Internal Revenue Code (IRC). The Internal Revenue Service has determined and informed the Tribe by a letter dated July 21, 2008, that the Plan, as then designed, was in accordance with applicable sections of the IRC.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC; therefore, believes that the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.

7) Related-Party and Party-In-Interest Transactions

Lamatsin, LLC is the sole shareholder in Shasta Administrative Services, Inc., the third-party administrator of the Plan through June 30, 2024. Lamatsin, LLC is majority-owned by the Tribe. Effective July 1, 2024, the Plan changed the third-party administrator to Forest County Potawatomi Insurance Department. Administrative fees paid for third party administration for the year ended December 31, 2024, to Shasta Administrative Services, Inc. were approximately \$466,500. Administrative fees paid for third party administration for the year ended December 31, 2023, to Forest County Potawatomi Insurance Department were approximately \$438,800.

Certain accounting and management services are provided to the Plan by the Tribe for which no fees are charged which qualify as party-in-interest transactions and are exempt from the prohibited transactions rules.
