## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of  
the Mimaki USA 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mimaki USA 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mimaki USA 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Mimaki USA 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Mimaki USA 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1: Description of the Plan**

The following description of Mimaki USA (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document and *Summary Plan Description* for a more complete description of the Plan’s provisions, which are available from the plan administrator.

***General***

The Plan is a defined contribution plan sponsored by the Company for the benefit of its employees and their beneficiaries. The purpose of the Plan is to enable participants and their beneficiaries to share in the Company’s profits and to encourage the loyalty and continuity of service of the participants. An employee becomes eligible to participate in the Plan upon obtaining age 18 and completing 30 days of continuous employment, as defined by the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

The Plan’s custodian is Nationwide Trust Company, FSB and the Plan’s record keeper is Nationwide Financial Services, Inc. Private Sector Retirement Plan Administration.

***Contributions***

Eligible participants may make annual contributions to the Plan through salary deferral elections, up to a percentage of compensation or a dollar amount not exceeding the annual limit established by law. Participants may contribute on a pre-tax or Roth basis. Rollover contributions from other qualified plans are also permitted. Employees aged 50 and older are eligible to make catch-up contributions. The Plan includes an automatic enrollment feature for newly eligible participants, defaulting to 4% of compensation. Beginning in 2024, the automatic deferral amount escalates by 1% annually.

The Company provides matching contributions for eligible participants. For the plan year beginning January 1, 2024, the Company matches 50% of participant elective deferrals, up to 8% of a participant’s compensation, on a per-pay-period basis, with no annual true-up. In prior years, the Company matched 50% of participant deferrals, up to 4% of compensation. Contributions are subject to certain limitations. Forfeitures are used to pay Plan expenses or reduce Company contributions.

***Participant Investment Account Options***

Investment account options include various types of investment securities offered by the Plan. Each participant has the option of directing his or her contributions into any of these investment securities and may change their allocations daily.

***Participant Accounts***

Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, the Company’s discretionary matching contributions (if any) and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their deferral and rollover contributions, plus earnings thereon. Vesting in the Company’s matching contributions portion of their accounts, plus earnings thereon, is based on years of credited service. Under the 5-year graded vesting schedule, a participant becomes vested in the Company’s matching contributions incrementally, with 20% vesting after one year of service, increasing by 20% each year thereafter, until reaching 100% after five years of service, as defined by the Plan.

**Note 1: Description of the Plan (continued)**

***Notes Receivable from Participants***

The plan document includes provisions authorizing loans from the Plan to active eligible participants. A participant may only have one outstanding loan. The minimum amount of a loan is \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repaid over a period not to exceed five years (unless the loan is used for the purchase of a primary residence in which case the Administrator may permit a longer repayment term). Loan repayments are made through payroll deductions. The interest rate will be 2% above the prime rate. The interest rate shall remain fixed throughout the duration of the loan. Participants will be deemed to have defaulted on their loan if they fail to remit payments in a timely manner as required under the loan agreement, breach any of their obligations or duties under the loan agreement or terminate employment.

***Payment of Benefits***

Hardship withdrawals may be requested for medical expenses, purchase of a principal residence, prevention of eviction from or foreclosure on a principal residence, pay for post-secondary education, payments for burial or funeral expenses, pay expenses for the repair or damage to a principal residence, or any other immediate and heavy financial need as determined based on Internal Revenue Service regulations.

Starting in the calendar year in which a participant reaches the age of 72, an election must be made to receive distributions calculated in the same manner as Minimum Required Distributions.

Certain types of in-service withdrawals may be obtained.

Upon termination of service due to death, disability, or retirement, a participant is entitled to 100% of his account balance. For termination of service due to other reasons, a participant is entitled to the value of his vested account balance.

***Forfeited Accounts***

Forfeitures consist of unvested company contributions in participants' accounts at the conclusion of their participation in the Plan. Forfeitures are held in the Plan and are used to either pay administrative expenses or reduce future Company contributions. At December 31, 2024 and 2023, there were \$14,514 and \$11,537, respectively, in forfeited non-vested accounts.

**Note 2: Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting, except for benefit payments, which are recorded when paid.

Investment held by a defined contribution plan are required to be reported at fair value. Fair value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to mutual fund accounts and the general account because fair value less a surrender or withdrawal charge is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Note 2: Summary of Significant Accounting Policies (continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investments Valuation and Income Recognition***

The Plan's investments are stated at fair value with the exception of fully benefit-responsive investment contracts, which are stated at contract value.

Contract value is the relevant measurement for that portion of the net assets available for benefits because contract value is the amount participants normally would receive if they initiate permitted transactions under the terms of the Plan. The Fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability to an orderly transaction between market participants at the measurement date (the exit price).

For detailed information on each fund's investments and concentrations of credit risk, the Prospectus and the Annual Report are available from Nationwide Trust Company, FSB.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Net Appreciation in Fair Value of Investments***

Net appreciation in fair value of investments, as presented in the accompanying statements of changes in net assets available for benefits, reflects both realized and unrealized gains and losses on investments purchased, sold, and held during the year.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

**Note 3: Certification of Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company, FSB, has certified the following information for the years ended December 31, 2024 and 2023, included in the accompanying financial statements and supplemental schedule, is complete and accurate:

The Plan's independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

**Note 4: Fair Value of Plan Assets**

FASB ASC Topic 820, Fair Value Measurement ("ASC Topic 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds (Level 1):* Valued at the net asset value (NAV) of shares held by the Plan at year-end, based on quoted prices on nationally recognized securities exchanges. Mutual funds held by the Plan are open-end funds registered with the Securities and Exchange Commission, required to publish their daily NAV and transact at that price. These funds are deemed to be actively traded. Self-directed brokerage accounts primarily consist of mutual funds and common stocks valued on the basis of readily determinable market prices.

***Recurring Measurements***

The Plan's investments (including gains and losses on investments purchased and sold, as well as held during the year) appreciated in value by \$1,284,708 and \$950,310 in the years ended December 31, 2024 and 2023, respectively.

The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Note 5: Group Annuity Contract**

The Plan invests in a traditional fully benefit-responsive guaranteed investment contract with Nationwide Insurance Company totaling \$192,472 for 2024 and \$194,540 for 2023. Nationwide maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Nationwide, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

**Note 6: Party-in-Interest and Related-Party Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Participant loans are loans made to employees/participants of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Plan parties-in-interest included Pension Financial Services (“PFS”) who acted as the third-party administrator, Nationwide Trust Company, FSB who acted as the custodian, and Nationwide Financial Services, Inc. Private Sector Retirement Plan Administration who acted as the record keeper.

Direct expenses paid to service providers during the years ended December 31, 2024 and 2023 were approximately \$16,574 and \$80,487 respectively.

The Company provides certain administrative services at no cost to the Plan.

**Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the accompanying statements of net assets available for plan benefits.

**Note 8: Tax Status**

The Plan operates under a Volume Submitter 401(k) Profit Sharing Plan adoption agreement in connection with a retirement plan and trust/custodial document sponsored by Pension Financial Services, Inc. This plan document has been filed with the appropriate agency and has obtained an opinion letter dated June 30, 2020. The Plan has not obtained or requested a determination letter. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

**Note 11: SECURE ACT 2.0**

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0.
