## INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of the  
First Choice Health Centers, Inc. 401(k) Profit Sharing Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of the First Choice Health Centers, Inc. 401(k) Profit Sharing Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Notes to Financial Statements

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the First Choice Health Centers, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and amendments for a more complete description of the Plan’s provisions.

*General* - The Plan is a defined contribution plan established by First Choice Health Centers, Inc. (the “Company” or “Employer”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”) covering all employees of the Company who elect to participate and have completed six months of service and obtained the age of 21. In addition, long-term, part-time employees who complete three consecutive 12-month periods, each with at least 500 hours of service, are given the opportunity to participate in the employee deferral component of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

*Contributions* - Each year, participants may contribute a percent of pretax annual compensation, as allowed by the Plan and IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollover”). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for non-discretionary Employer matching contributions for contributing employees. The Employer’s safe harbor matching contribution is equal to 100 percent of the first 3 percent and 50 percent of the subsequent 2 percent of salary deferrals of eligible compensation for the year ended December 31, 2024. The Company may also make discretionary non-elective contributions to the Plan, as defined by the Plan, in an amount that the Company determines each Plan year.

*Participant Accounts* - Each participant’s account is credited with the participant’s contribution, as well as allocations of the Company’s discretionary contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* - Participants are vested immediately in their contributions and the Employer’s safe harbor matching contribution plus actual earnings thereon. Vesting in the Company’s discretionary contribution portion of their accounts is based on years of continuous service. After two years of service, as defined, a participant is 20 percent vested. For each subsequent year, a participant is vested an additional 20 percent. A participant is fully vested in the Company’s discretionary contributions after 6 years of credited service.

*Payment of Benefits* - On termination of service due to death, disability, retirement, or other reasons, a participant can elect to receive a lump sum amount equal to the value of the participant’s vested interest in his or her account. On termination, participants with vested account balances totaling less than \$5,000 receive an automatic distribution in accordance with the terms of the Plan. The Plan also provides for in-service withdrawals by participants who have attained the age of 59 ½. Withdrawals from a participant’s pre-tax deferral accounts may also be made in the event of a financial hardship or under other certain circumstances, in accordance with the provisions specified in the Plan.

## **NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)**

*Forfeited Accounts* - Forfeited accounts are non-vested Company discretionary contributions forfeited by employees who terminate their employment or withdraw from the Plan. These accounts may be used to reduce future Employer contributions or pay Plan expenses. At December 31, 2024 and 2023, there were no forfeited non-vested accounts. During 2024, no forfeitures were used to reduce Plan expenses or Employer contributions.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting* - The financial statements are prepared on the accrual basis of accounting.

*Use of Estimates* - The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* - Investments are reported at fair value, except for the insurance company general account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* - Benefits are recorded when paid.

*Expenses* - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

*Subsequent Events* - The Plan has monitored and evaluated any subsequent events for footnote disclosures or adjustments required in its financial statements for the year ended December 31, 2024 through October 7, 2025, the date on which financial statements were available to be issued.

## **NOTE 3 – FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements* - The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must to publish their daily net asset value (“NAV”) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Investments measured at NAV* - The Plan invests in a common/collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the NAV provided by the trustee as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common/collective trust fund, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations would be carried out in an orderly business manner. The common/collective trust fund is not required to be classified within a level on the fair value hierarchy.

There were no participant redemption restrictions for the common/collective trusts; the redemption notice period was only applicable to the Plan. As of December 31, 2024, there were no unfunded commitments, daily redemption restrictions and a 12-month redemption notice period.

#### **NOTE 4 – BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan offers an insurance company general account totaling \$46,507 and \$276,596 as of December 31, 2024 and 2023, respectively, which carries a benefit-responsiveness feature that allows Plan participants to make exchanges or request benefit payments at contract value. Voya Retirement Insurance and Annuity Company (“Voya”) maintains the contributions to the investment in a fixed account. The account is credited with earnings on the underlying investments and charge for participant withdrawals and administrative expenses. The insurance company general account investment issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Voya credited the account with 1.50% for the year ended December 31, 2024.

Because the insurance company general account has a benefit-responsiveness feature, contract value is the relevant measurement attributable for that portion of the net assets available for benefits. Contract value, as reported to the Plan by EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including partial or complete Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is probable.

#### **NOTE 5 – TAX STATUS**

The Plan is a proto-type plan. The Internal Revenue Service (“IRS”) has informed ADP, LLC (“ADP”), by a letter dated October 6, 2020, that the form of the proto-type plan is acceptable under section 401(a) of the IRC. As such, the Plan is exempt from federal income tax, and amounts contributed by the Employer will not be taxed to the participant until the participant receives a qualifying distribution from the Plan. The Plan has been amended since ADP received the opinion letter, but the Employer believes that the Plan is operating in accordance with the applicable sections of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 6 – RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Reliance Trust Company (“Reliance”). Reliance served as the trustee of the Plan’s assets and record-keeper of the Plan; therefore, these transactions qualify as party-in-interest transactions. Reliance and other parties-in-interest perform certain administrative, advisory and recordkeeping services for the Plan. For the year ended December 31, 2024, fees paid by the Plan to these firms totaled \$30,270.

#### **NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **NOTE 8 – CERTIFIED INFORMATION**

Information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance, the trustee of the Plan.

#### **NOTE 9 – RISKS AND UNCERTAINTIES**

The Plan provides for various investment options. The underlying investments held by the registered investment companies may include stocks, bonds, fixed income securities and other investment securities. Such investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
