## **INDEPENDENT AUDITORS' REPORT**

To the Investment and Benefits Committee of

### **Opinion**

We have audited the accompanying financial statements of the W. R. Grace & Co. Retirement Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the W. R. Grace & Co. Retirement Contribution Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

#### **1. Description of the Plan**

The following description of the W. R. Grace & Co. Retirement Contribution Plan (the "Plan") provides only general information. Participants should refer to the Plan document, the Summary Plan Description, and the Prospectus Supplement for the Plan for more information.

#### **General**

The Plan is a defined contribution plan established July 1, 2016. The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Fidelity Management Trust Company ("Fidelity" or "Trustee") and its related organizations administer the Plan's recordkeeping and serve as the Plan's Trustee and Custodian.

Investment management of the Fixed Income Fund and oversight of the Plan's mutual fund offerings is the responsibility of the Investment and Benefits Committee (the "Committee"), or as delegated by that Committee.

#### **Eligibility and Vesting**

Any salaried or hourly employee of W. R. Grace & Co. ("Grace" or the "Company") who is initially hired by the Company on or after January 1, 2017, or rehired by the Company on or after January 1, 2017 with five or more consecutive one year breaks in service under the W. R. Grace & Co. Retirement Plan for Salaried Employees (the "Salaried Plan") who is not vested in such retirement plan and is not eligible to participate in such retirement plan following his/her rehire by the Company, is immediately eligible to participate in the Plan effective as of the employee's first date of employment (or first date of such other eligibility).

Participants are fully vested in the Plan after 3 years of vesting service, as defined by the Plan. A participant is fully vested in the Plan regardless of years of service upon death, disability, or at age 55.

#### **Employer Contributions**

Grace contributes 4% of the participant's compensation each payroll period into the participant's elected investment fund, or the qualified default investment alternative as selected by the Committee. No contributions are permitted by employees.

Effective January 1, 2026, the Company contribution will be reduced from 4% to 3% of eligible pre-tax earnings. See the Subsequent Events footnote.

Annual contributions to each participant shall not exceed the lesser of \$69,000 and \$66,000 for the years ended December 31, 2024 and 2023, respectively, or 100% of total compensation as defined by the Plan.

Forfeitures of Company contributions are used to reduce future Company contributions or pay for Plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$891,853 and \$367,888, respectively. No forfeitures were used to offset Plan expenses or reduce Company contributions during the years ended December 31, 2024 and 2023.

As of December 31, 2024, the Plan offered 22 mutual funds and a Fixed Income Fund comprised of a stable value common/collective trust fund as investment options for participants. The Committee or its designee periodically evaluates and changes the funds offered under the Plan.

Participants may allocate their future contributions among any of the investment options and may transfer the amounts related to their existing balances among any of the investment options to other investment options. All investment options are participant-directed.

**Participant Accounts**

Each participant's account is participant-directed and credited with the Company's contributions and an appropriate allocation of Plan earnings (losses), and charged with an allocation for administrative expenses. Allocations are based on participant earnings or account balances, as defined.

The Plan does not allow for hardship withdrawals or employee loans.

**Payment of Benefits**

Upon disability, retirement, death, or other termination of service, a participant (or their beneficiary in the event of death) who is not eligible to elect or who does not elect to defer the distribution may elect to receive his/her benefit in the form of a single lump sum payment or annual, quarterly or monthly installment payments if the balance exceeds \$1,000. A terminated participant with an account balance less than \$1,000 will receive an automatic direct distribution in the form of a single lump sum payment in cash.

There were no net assets of the Plan allocated to the accounts of participants who had elected to withdraw from the Plan but had not received such distributions as of December 31, 2024 and 2023.

**Administrative Expenses**

Expenses incurred in the administration of the Plan are required to be paid with assets of the Plan unless the Company, at its discretion, elects to pay them. The Company paid a portion of Plan expenses for the years ended December 31, 2024 and 2023. Plan expenses paid by the Company are excluded from the Plan's financial statements. Distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accounts of the Plan are maintained on the accrual basis of accounting, which is acceptable under U.S. Department of Labor Regulations and is in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Investment Valuation and Income Recognition**

Investments in mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end, which is fair value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is accrued when earned.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation (depreciation) in fair value of its investments, which consists of the realized gains (losses) and the unrealized appreciation (depreciation) on those investments.

**Risks and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, credit and market risks. Investment securities change in value, and it is possible that such changes could be material.

#### Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan fiduciaries to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities on the date of the financial statements. Actual amounts may differ from the estimates used.

#### Payment of Benefits

The Plan recognizes benefits when paid.

### 3. Fair Value Measurement

Certain of the Plan's assets and liabilities are reported at fair value. See Note 2 for methods of valuation for the various investments. Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 "Fair Value Measurement" defines fair value as the value that would be received at the measurement date in the principal or "most advantageous" market. The Plan uses principal market data, whenever available, to value assets and liabilities at fair value. ASC 820 prescribes three valuation techniques that shall be used to measure fair value as follows:

1. Market Approach—uses prices or other relevant information generated by market transactions involving identical or comparable assets or liabilities.
2. Income Approach—uses valuation techniques to convert future amounts to a single present amount (discounted).
3. Cost Approach—the amount that currently would be required to replace the service capacity of an asset (i.e., current replacement cost).

One or a combination of the approaches above can be used to calculate fair value, whichever results in the most representative fair value.

In addition to the three valuation techniques, ASC 820 prescribes a fair value hierarchy in order to increase consistency and comparability in fair value measurements and related disclosures. The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three broad levels:

- Level 1 Inputs* — Quoted prices in active markets for identical assets or liabilities. A quoted price in an active market provides the most reliable evidence of fair value.
- Level 2 Inputs* — Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs* — Unobservable inputs for the asset or liability, which should reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods of investment valuation discussed in Note 2 may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Related-Party Transactions**

The Plan invests in shares of mutual funds managed by Fidelity Investments Institutional Operations Company, Inc. ("FIIOC"). FIIOC acts as Custodian for the Plan and is related to the Plan's Trustee, Fidelity Management Trust Company. The Company provides the Plan with certain accounting and administrative services for which no fees are charged.

As of December 31, 2024 and 2023, the fair value of the Fidelity investments was \$5,414,217 and \$3,645,415, respectively. Administrative fees paid by the Plan to Fidelity amounted to \$100,291 and \$110,932 for the years ended December 31, 2024 and 2023, respectively. Other administrative fees were paid directly by the Company during 2024 and 2023. All such transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

**5. Tax Status of Plan**

The Plan received a favorable determination letter from the Internal Revenue Service ("IRS") dated July 17, 2018. Although the Plan has been amended since receiving this letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740 "Income Taxes" prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have a material impact on the Plan's financial statements.

The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any tax periods in progress.

**6. Plan Termination**

Grace anticipates that the Plan will continue indefinitely, but reserves the right to amend or discontinue the Plan at any time. In the event the Plan terminates, the rights of all participants and inactive participants shall be fully vested and nonforfeitable; and participants would receive the value of their account balances at the time of distribution in accordance with the Plan and ERISA.

**7. Subsequent Events**

The Plan evaluated for disclosure any subsequent events through October 2, 2025, the date the financial statements were available to be issued. Effective January 1, 2026, the Company contribution will be reduced from 4% to 3% of eligible pre-tax earnings. Other than this item, there were no other subsequent events that warrant disclosure.
