1) Description of plan and summary of significant accounting policies -

- A) **Description of Plan:** The following description of CSA Group 401 (k) Retirement & Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of CSA Central, Inc., ANG Associates, Inc., CSA Group NY Architects & Engineers, PC., CSA Group NJ Architects & Engineers, PC. (the Companies) who have completed at least three months of service and are at least twenty-one years old. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to 25% of eligible compensation, as defined. In accordance with the United States Internal Revenue Code, as amended, (the Code), such contributions may not exceed the limits as established by Section 402 (g) (\$23,000 for 2024). The Plan allows additional contributions but in accordance with the provisions of Section 414 (v) of the Code, such contributions are limited to \$7,500 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Companies may make a discretionary matching contribution equal to a uniform percentage or a dollar amount in relation to participants contributions made. On August 1, 2024, the Companies matching contribution was changed to 25% up to 7% of participant's compensation, as defined. Additional amounts may be contributed at the option of the Companies discretion and are invested in a portfolio of investments as directed by it. Contributions are subject to certain limitations.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Companies' contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies contributions is twenty-percent after one year of service and twenty-percent for each subsequent year. A participant is one - hundred percent vested after five years of credited service.

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000. For those participants with vested balance of \$100,000 or less, the loan is limited to the lower 50% of the vested account balance or \$50,000. If participants vested balance is over \$100,000, the loan is reduced by the difference between the highest outstanding loan balance during the previous 12 months and the current outstanding balance. In no event, the maximum aggregate loan balance may exceed \$50,000 and a five years term. The loans are secured by the balance in the participant's account and bear interest at prevailing market rates at the time of the loan. Principal and interest is paid ratably through payroll deductions.

Payment of benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures - As established by the Plan document, forfeitures may be used to reduce Plan's administrative expenses or future Companies contributions. As of December 31, 2024 and 2023, forfeitures (certified by trustee) amounted to approximately \$17,000 and \$51,000, respectively.

Plan termination - Although it has not expressed any intent to do so, the Plan Sponsors have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Companies may determine.

Party-in-interest - During the year ended December 31, 2024 and 2023, the guaranteed insurance contract was issued by Mass Mutual Life Insurance Company who provided advisory services to the Plan. Accordingly, it qualify as party-in-interest transaction under ERISA regulations.

- B) Summary of significant accounting policies:** The accounting and financial reporting policies followed by the Plan conform with accounting principles generally accepted in the United States of America and to prevailing practices within its industry. The following is a description of the most significant of these policies:

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates - Preparing the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payments of benefits - Benefits are recorded when paid.

Operating expenses - The majority of expenses for maintaining the Plan are paid by the Companies.

Subsequent events - In accordance with ASC 855 - *Subsequent Events*, the Plan evaluated subsequent events through August 18, 2025, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. Level 1 fair value measurements - Separate accounts investing in mutual funds or equity securities are measured using quoted prices in active markets for identical assets. Level 2 fair value measurements - Separate accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities. Changes in economic conditions or model - based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluated the significance of the transfers between levels based upon the nature of the financial information and size of the transfer relative to total net assets available for benefits. During the years ended December 31, 2024 and 2023, there were no significant transfers in or out levels 1, 2 or 3. Plan's fiduciary of the CSA Group 401 (k) Retirement & Savings Plan set investment policies and strategies for trust. Long - term strategic investment objectives include preserving the funded status of the trust and balancing risk and return. Plan's fiduciary oversees the investment allocation process, which includes selecting investment managers, commissioning periodic asset - liability studies, setting long - term strategic targets and monitoring asset allocations.

4) Investment contract with insurance company -

The Plan has a guaranteed insurance contract (certified by trustee) with Mass Mutual Life Insurance Company. During the years ended December 31, 2024 and 2023, the average yield earned and credit to participants amounted to 3.00% and 2.97%, respectively. The insurer maintained the contributions in a separate investment account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as certified to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. As described in Note 1B, because the guaranteed insurance contract is fully benefit-responsive, contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The guaranteed insurance contracts are invested in the general account of the insurance company issuing the contract. It has no maturity value. The effective credit interest rate is set monthly and effective on the first day of the month, during which a new interest rate is applied daily to the total outstanding balance of the investment.

5) Tax status -

The United States Internal Revenue Service has determined and informed the Plan sponsors by letter dated March 31, 2014, that the Plan and the related trust, as designed, is acceptable under the provisions of Section 401 of the United States Internal Revenue Code of 1994, of 1986, as amended. Accounting principles generally accepted in the United States of America require Plan's management to evaluate tax positions taken by the Plan and recognize tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the regulatory agencies. The Plan administrator has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

6) Risk and uncertainties -

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
