Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ConvenientMD LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of the Plan

The following brief description of the ConvenientMD LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by ConvenientMD LLC (the Company, the Plan Sponsor, or Plan Administrator). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all eligible employees of the Company. The Plan's Retirement Committee is responsible for oversight of the Plan. The Plan's Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan, at certain times, is amended and restated for regulatory and certain other administrative Plan changes.

Eligibility Requirements

All employees who have completed one month of service and are aged 18 or older are eligible to make voluntary participant contributions. Eligible employees may make contributions to the Plan starting on the first day of the month following completion of eligibility requirements. Employees become eligible upon completion of 12 months of employment for the employer match and the non-elective discretionary contribution.

Contributions

Each year, participants may contribute up to 90% of their compensation, subject to limits set by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may also contribute matching contribution and allocate a discretionary contribution equal to a percentage of each eligible participants' elective deferrals. During 2024 and 2023, matching employer contributions were 25% of the first 8% that employee's deferred. There was no employer discretionary contribution in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations for the Company's contribution and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments in each participant's account are directed by the participant. The account is decreased by any participant withdrawals and an allocated share of investment expenses. Participants allocate contribution amounts to various investment choices offered by the Plan.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the employer's contributions is based on years of service. A participant is 25% vested after one year of service and 50% vested after two years of service, with 100% vesting after three years of service.

Forfeitures

Forfeitures of terminated participants' nonvested accounts may be used to pay Plan expenses or reduce future employer contributions. For the years ended 2024 and 2023, forfeitures used to offset matching employer contributions were \$52,609 and \$6,390, respectively. Unused forfeitures amounted to \$11,307 and \$34,144 as of December 31, 2024 and 2023, respectively.

Investment Options

A participant may direct their contributions to any of the various investment options available to the Plan. Fund balances may be transferred between the funds at the discretion of the participant without restriction. Participants may change their investment options at any time.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/profit-sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Participants may borrow from their account balance up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance limited by the highest loan balance in the last 12 months. The Plan requires a minimum loan of \$1,000. A participant may only have one loan outstanding at a time. Most participant loans must be repaid within five years. If the participant loan is made for the purpose of purchase or construction of the primary residence of the participant, then such participant loan may be repaid over a period more than five years, the maximum being 30 years. The participant loans are secured by the balance in the participant's account and bear interest at a fixed rate determined at the time of borrowing and fixed for the life of the loan. Principal and interest are paid through payroll deductions.

Payment of Benefits

Benefits may be distributed to participants upon attainment of age 59½, termination of employment by reason of retirement, disability, death, or other separation from service. Benefits may be paid in a lump sum or installments. Participants who terminate employment and have a vested account balance of less than \$1,000 will receive a lump-sum distribution of 100% of their vested benefits. Distributions to participants with vested account balances greater than \$1,000, but not in excess of \$5,000, who terminate employment and fail to make a timely distribution election, will be paid to an individual retirement account designated by the Plan Administrator. Participants who have a vested account balance in excess of \$5,000 may leave their funds invested in the Plan or may elect a lump-sum distribution or installment payments.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company and are excluded from these financial statements, except loan fees and expenses directly related to the management of each fund (such as investment management fees, redemption fees, commissions, and other transaction costs), which are charged against the assets of the total applicable fund to which such expenses directly relate. Participant loan fees are charged to participants borrowing from their accounts.

2. Summary of Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date (an exit price). See Note 5 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Hardship Withdrawal

In cases of financial hardship, as defined by the Plan, participants may be eligible to receive a distribution from their salary-deferral account balance.

3. Risks and Uncertainties

The Plan offers a variety of investment funds, which include mutual funds and a money market fund. The investment funds invest in U.S. equities, international equities, and fixed-income securities. Investment securities, in general, are exposed to various risks, such as interest, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

5. Fair Value Measurement

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the overall fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are actively traded.

Money Market Fund - The money market fund is valued at the unadjusted quoted market price, which represents the NAV of shares owned by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the valuation methodologies of these items held at December 31, 2024 and 2023.

The Plan had no financial assets that were measured at fair value on a nonrecurring basis during the years ended December 31, 2024 and 2023. There were no transfers between levels during the years ended December 31, 2024 and 2023.

6. Party-in-Interest Transaction

Certain Plan investments are managed by Fidelity Management Trust Company. Any purchases and sales of these funds qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Notes receivable from participants and fees paid to Fidelity Management Trust Company also qualify as exempt party-in-interest transactions.

7. Plan Termination

Although the Plan Sponsor has not expressed any intent to do so, it has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their deferral accounts and employer contributions and become 100% vested in their non-elective contribution accounts, and the net assets of the Plan would be distributed, as prescribed by ERISA.

8. Tax Status

The Plan has adopted a Prototype Non-Standardized Profit-Sharing Plan with Cash or Deferred Arrangement (CODA), of which the Internal Revenue Service (IRS) has determined and informed Fidelity Management & Research Company, by a letter dated June 30, 2020, that the Plan was designed in accordance with the applicable sections of the IRC. Although the Plan has been amended, the Plan Sponsor believes that the Plan currently is designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Late Remittances

During the Plan year ended December 2024, employee loan repayments in the amount of \$1,214 were not remitted within the appropriate time period by the Plan Sponsor. These transactions constitute prohibited transactions, as defined by ERISA. The Company intends to self-correct 2024 late remittances in the subsequent period and does not expect the amount of lost earnings to be material. The lost earnings will include the amount the participants should have earned from the date the deferred contributions were made through the date of correction.

Additionally, in 2023, the Plan Sponsor had taken appropriate steps to correct the delinquent contributions for the Plan year ended December 31, 2022 by calculating and depositing the corresponding lost earnings into the participant accounts.

11. Subsequent Events

The Plan has evaluated subsequent events through October 1, 2025, the date that the financial statements were available to be issued. There were no subsequent events identified requiring disclosure or adjustment to the financial statements.
