Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of LogRhythm, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

(1) Description of Plan

The following description of the LogRhythm, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of LogRhythm, Inc. (the “Company” and the “Plan Sponsor”), who are age twenty-one or older, excluding union, non-resident alien, leased, part-time, seasonal, or temporary employees. Part-time, seasonal, or temporary employees who complete 1,000 hours of service within the 12-month period beginning on the Employees’ Employment Commencement Date are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to the maximum amount allowed under the law based on pre-tax annual compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a collective investment trust option, a guaranteed investment contract, and various mutual funds as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Unless changed by the participant, the automatic deferral percentage will increase at the rate of 1% per year as of the first day of the second plan year up to a maximum deferral of 10%.

The Company may make discretionary matching and profit-sharing contributions to the Plan. Matching contributions for the year ended December 31, 2024 were \$1,022,045. Matching contributions are invested as directed by the participant. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary profit sharing and matching contributions is based on years of continuous service. A participant is 33% vested after one year, 66% vested after two years, 100% vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant’s account. In 2024, the annual loan interest rates were between 4.25% - 9.50%. Principal and interest is paid ratably through semi-monthly payroll deductions.

(1) Description of Plan (continued)

Payment of Benefits

On termination of service due to death, disability, retirement, or severance of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or a direct rollover to another qualified retirement plan. In addition, hardship and in-service distributions are permitted if certain criteria are met. Corrective distributions are paid in the event a participant makes excess contributions during the year.

Forfeited Accounts

As of December 31, 2024, forfeited nonvested accounts totaled \$209,537. Forfeitures from non-vested accounts may be used to pay Plan administrative expenses. During the year ended December 31, 2024 \$35,966 administrative expenses were paid from forfeited nonvested accounts.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Significant estimates include the fair value of the Plan's investments.

Investments

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for fully benefit responsive investment contracts because the contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024, distributions requested but not paid to withdrawing participants were \$0.

Investment Valuation and Income Recognition

The Plan's mutual fund investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Plan administrative fees and investment advisor fees are also included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

Notes Receivable from Participants

During the year ended December 31, 2023 the Plan adopted Accounting Standards Codification Topic 326, Measurement of Credit Losses on Financial Instruments (“ASC 326”) which requires plans to measure credit losses utilizing a methodology that reflects expected credit losses and requires a consideration of a broader range of reasonable and supportable information to inform credit loss estimates. Plans are required to apply these changes through a cumulative-effect adjustment to retained earnings as of the beginning of the first reporting period in which the guidance is effective. The adoption did not have a direct material impact on the Plan’s financial statements.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of January 1, 2023 the balance of the Plan’s note receivable from participants was \$254,646. As of January 1, 2023, December 31, 2023 and December 31, 2024, the Plan’s allowance for credit losses was \$0.

If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Deemed distributions for the year ended December 31, 2024 were \$40,463.

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board’s Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value, there have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust Funds

The Putnam Large Cap Value Common Investment Trust (the "CIT Fund") is a collective investment trust fund that is valued at the net asset value of the CIT Fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. NAV is determined by the issuer based on the fair value of the underlying investments. Participants can ordinarily direct the withdrawal or transfer of all or a portion of their investment without penalty. The CIT Fund invests in U.S. and international stocks and bonds and is designed for investors seeking long-term growth with moderate risk.

The CIT Fund is not a mutual fund and is not registered with the Securities and Exchange Commission. An investment in this CIT Fund may lose value and is not guaranteed by any governmental agency, or other financial institution. Units of beneficial interest in this Fund are not registered under the Securities Exchange Act of 1933 in reliance on an exemption under that Act for interests in a collective trust fund maintained by a bank for certain types of employee benefit trusts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Fully Benefit Responsive Investment Contract

The Capital Preservation Account is an investment contract that provides a stated rate of return, and meets the fully benefit responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents the contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The investment contract is recorded on the Statement of Net Assets Available for Benefits as investment at contract value. This investment option allows the Plan Sponsor to withdraw the contract value after a deferral period of up to 12 months.

(6) Tax Status

The Internal Revenue Service (IRS) has issued an opinion letter on the non-standard pre-approved plan dated November 14, 2022, which states that the plan document is in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan, as amended, is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and that the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (“IRS”). The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS audits for any tax periods in progress.

(7) Related Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of funds managed by Empower. Empower is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation or depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

As described in Note 2, the Plan made direct payments to Empower, the Third Party Administrator totaling \$167,519 which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

(8) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(9) Commitments, Contingencies, Risks and Uncertainties

Risk

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

(10) Subsequent Events

The plan has evaluated subsequent events through the date of the auditor's report which is the date the financial statements were available to be issued. Management determined there were no other material subsequent events that required recognition or additional disclosure in the financial statements other than the following:

During July 2024, the Company finalized a merger with Exabeam. The Plan is set to serve the employees of the merged entity. On January 1, 2025, the Plan acquired substantially all of the assets of Exabeam's plan in the amount of \$22,104,471.
