INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Peninsula Family Service 403(b) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Peninsula Family Service 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Peninsula Family Service 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Peninsula Family Service 403(b) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Peninsula Family Service 403(b) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of assets (held at end of year) as of December 31, 2024 and delinquent participant contributions for the year then ended (collectively, "supplemental schedules") are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the Peninsula Family Service 403(b) Plan (the "Plan") provides only general information. Participants should refer to the plan documents and related adoption agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Peninsula Family Service (the "Organization" or "Employer") pursuant to Section 403(b) and related provisions of the Internal Revenue Code ("IRC"), was established effective January 1, 2009, and restated effective February 1, 2018. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination, or financial hardship. The Plan covers all employees of the Organization who meet certain eligibility requirements. The Plan is subject to the provisions of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Effective March 27, 2020, the Plan administratively adopted the provisions of the Coronavirus Aid, Relief, and Economic Security ("CARES") Act, related to participant loans and distributions. The Organization has until December 31, 2026, to amend the Plan for changes allowed by the CARES Act. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Organization has until the end of the first Plan year beginning on or after January 1, 2026 to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Organization is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Organization has delegated certain responsibilities for the operation and administration of the Plan. American Trust Retirement Services, LLC is the recordkeeper and is responsible for maintaining participant account records and transactions. American Trust Company and Equitable Financial Life Insurance Company (collectively the "Custodians") are responsible for the custody of the assets and for executing investment transactions.

1. DESCRIPTION OF THE PLAN (continued)

Eligibility

All employees of the Organization are eligible to participate in the Plan immediately if they normally work more than 20 hours a week and are not non-resident aliens, student employees, temporary, seasonal, on-call sub-pool, or on-call employees who work fewer than 1,000 hours during the year. The Plan includes an automatic enrollment provision by which eligible employees who do not affirmatively elect a contrary deferral rate or opt out of the Plan are automatically enrolled in the Plan at a fixed percentage of 2% of eligible compensation, as defined in the Plan document.

Contributions

Participants may elect to contribute up to 100% of their annual compensation, as defined by the Plan document, on a pre-tax or after-tax (as Roth contributions) basis, up to a maximum amount allowed by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified defined benefit, defined contribution plans, and certain individual retirement accounts.

The Organization may make discretionary matching contributions. Contributions are allocated based on eligible compensation as determined by the Organization subject to certain limitations, as defined by the Plan document. The Organization made discretionary matching contributions equal to 100% of elective deferrals up to a maximum of 3% of participant compensation during the year ended December 31, 2024.

The Organization may also make non-elective discretionary contributions. The Organization made \$600,000 in non-elective contributions during the year ended December 31, 2024.

Participant accounts

Each participant's account is credited with the participant's contributions, rollovers, allocations of the Organization's contributions, if any, and investment earnings, and charged with an allocation of investment losses, if any, and administrative expenses not paid directly by the Organization. Allocations are based on participant earnings or account balances, as defined in the Plan document. Participants direct the investment of contributions to their respective accounts into the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are 100% vested in Organization contributions after one year of credited service, as defined by the Plan. In the event of death, disability or attaining normal retirement age, as defined by the Plan document, participants are vested immediately in all Organization contributions.

1. DESCRIPTION OF THE PLAN (continued)

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Repayment of principal and interest on notes receivable from participants ("participant loans" or "loans") is generally required by the Plan to be made through payroll deductions within five years or less, unless the loan is for the purchase of a principal residence, in which case it must be repaid within a reasonable time frame, not exceeding 15 years. The loans are collateralized by the remaining vested balance in the participant's account and accrue interest at a rate equal to the prime rate plus 2% at the time the loan is taken. As of December 31, 2024, interest rates on outstanding loans range from 5.25% to 10.50% with various maturity dates through May 2029.

Forfeiture accounts

Forfeited non-vested amounts are available to be used to reduce future discretionary matching contributions made by the Organization or pay Plan administrative expenses. The Plan had forfeitures in the amount of \$20,602 and \$100 available as of December 31, 2024 and 2023, respectively. During the Plan year ended December 31, 2024, \$100 of forfeitures were used to reduce discretionary matching contributions and \$19,024 of forfeitures were used to pay Plan administrative expenses.

Payment of benefits

Distributions and withdrawals are payable to participants upon retirement, termination, financial hardship, disability or to a beneficiary upon a participant's death. Upon termination, if a participant's account balance is equal to or less than \$1,000, the balance is automatically distributed in a lump-sum cash payment unless otherwise elected. Upon termination, if a participant's account balance is greater than \$1,000 and equal to or less than \$5,000, the balance shall be automatically rolled over into an individual retirement account as designated by the Plan administrator, unless otherwise elected. Upon termination, if a participant's account balance is greater than \$5,000, the participant can consent to either a distribution paid in the form of a lump-sum payment, installment payments, a direct rollover into another qualified plan or postpone payment to a later date and remain in the Plan as described in the Plan document.

Upon attaining the age of 59 ½ the participant may, while still employed by the Organization, request a withdrawal from their account balance. Hardship distributions are permitted under limited circumstances as defined in the Plan documents.

Administrative expenses

Administrative expenses are generally paid by the Organization, but may, at the discretion of the Plan administrator, be paid by the Plan. Transaction fees for certain participant-initiated activity are charged to the specific account of the participant initiating any such transaction. The Plan is not required to reimburse the Organization for expenses paid on its behalf.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets liabilities and changes therein, and disclosure of contingent liabilities. Actual results may differ from those estimates.

Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein

Investment valuation and income recognition

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4). Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts. Contract value represents contributions made under a contract, plus interest, less participant withdrawals and administrative expenses (Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions and contribution receivables

Contributions from participants are recorded based on the date the contributions or repayments have been separated from a participant's pay by the Organization, which is the pay date. Contributions from the Organization, if any, are recorded in the year earned to coincide with the year which the Organization records the contributions to its general ledger. The Plan records receivables for contributions based upon contributions recorded in the Plan year but received by the Plan subsequent to year end. Rollover contributions from participants are recorded based on the date the contributions are received by the Custodians.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. If a participant ceases to make repayments and a distributable event occurs, the Plan administrator deems the participant note to be a distribution, the notes receivable is reduced and a benefit payment is recorded if a distributable event has occurred.

Payment of benefits

Benefit payments are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred.

Subsequent events

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued. There were no material subsequent events which would require recognition or disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS (UNAUDITED)

The Plan administrator, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Custodians, determined to be qualified institutions by the Plan administrator, have certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and;
- Net appreciation in fair value of investments, dividends and interest, and interest income from notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024, and
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) as of December 31, 2024.

Accordingly, as requested by the Plan administrator, the Plan's independent auditor performed no auditing procedures on the certified information other than to agree the certified information to the related information included in the Plan's financial statements and supplemental schedule of assets (held at end of year).

4. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

The fair value hierarchy levels of inputs that may be used to measure value are as follows:

- *Level 1* - Asset value is based on actual quoted prices in active markets for identical security.
- *Level 2* - Other significant observable inputs are used to arrive at fair value (including yield, coupon rate, maturity, issue type, quoted prices for similar securities, trading characteristics, etc.).
- *Level 3* - Significant unobservable inputs (including management's own assumptions in determining the fair value of investments) are used to arrive at fair value.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported on the open market. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.

Pooled separate accounts: Valued at the Net Unit Values which represents the NAV as a practical expedient to fair value. The NAV is determined daily as reported by Equitable. Participant transactions (purchases and sales) may occur daily. There is no redemption notice period or unfunded commitments. The investment strategies for the fund classes measured at fair value based on NAV are as follows:

- Target Allocation Funds - invest in a diversified mix of assets, including aggressive stocks, international stocks, large company stocks, government bonds, foreign bonds, and money markets. The allocation to each asset type may be fixed, within a specified range, or determined at the manager's discretion. Fund managers regularly review market conditions and adjust the asset allocation to achieve optimal risk-adjusted performance, in line with the fund's stated objectives and target allocations. The fund's structure may vary based on risk tolerance or length of time to investment goal.

- Large Cap Value/Blend Funds - aim to achieve long-term capital growth or a combination of growth and income by investing primarily in stocks of large, established companies. These funds employ value and blend investment strategies, selecting stocks based on their potential for price appreciation and the income generated through dividends. Due to their focus on dividend-paying and mature companies, such as utilities and resource firms, these funds generally exhibit lower price volatility.
- Large Cap Growth Funds - primarily invest in stocks of large U.S. companies with a growth-oriented investment strategy. These funds target companies experiencing rapid growth, which typically reinvest most or all of their profits into research and development rather than paying dividends. The primary objective of growth funds is to generate capital gains rather than income. Consequently, these funds often have higher price/earnings ratios and make minimal or no dividend payments. Large capitalization companies are generally more established and exhibit lower relative volatility compared to more aggressive small and mid-cap stock funds.
- Small/Mid/Specialty Funds - include small cap, mid cap, and specialty funds, utilizing growth, value, or a blend of these investment styles. These funds aim for capital appreciation by primarily investing in stocks of small and medium-sized companies. Typically, these companies are focused on developing new products or markets and exhibit above-average earnings growth potential. Due to their smaller size, these companies may encounter greater business risks, making investments in these funds generally riskier than other domestic equity funds. Specialty or sector funds invest in stocks of companies within a specific industry, which can significantly increase the risk and volatility of these funds.
- Global/International/Emerging Markets Funds - encompass various investment strategies. Global funds invest in stocks of companies both in the United States and in developed countries outside the United States. International funds focus on stocks of companies located outside the United States. Emerging Markets funds invest in securities from developing countries, which exhibit the highest performance volatility due to the instability of their economies, political structures, and currencies. International investing can offer greater diversification benefits to a U.S.-based portfolio compared to domestic securities alone. However, foreign investments carry additional risks not present in U.S. securities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. GUARANTEED INTEREST CONTRACT WITH EQUITABLE FINANCIAL LIFE INSURANCE COMPANY

The Plan invests in a Guaranteed Interest Account ("GIA") with Equitable. The GIA is a fully benefit-responsive investment contract ("FBRIC"). Contributions into the GIA are maintained in a general account with Equitable. Equitable is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1% and ranged from 1% to 3% for 2024. The crediting rate is reviewed on a monthly basis for resetting. The GIA does not permit Equitable to terminate the agreement prior to the scheduled maturity date.

5. GUARANTEED INTEREST CONTRACT WITH EQUITABLE FINANCIAL LIFE INSURANCE COMPANY (continued)

The contract meets the FBRIC criteria and therefore is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Equitable, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

6. TAX STATUS

The Plan has adopted the American Trust & Savings Bank Volume Submitter 403(b) Plan ("volume submitter plan"). The Internal Revenue Service has issued an opinion letter dated June 26, 2017, stating that the volume submitter plan is designed in accordance with the applicable sections of the IRC and is appropriate for use by employers for the benefit of their employees. The Plan administrator believes that the Plan, as adopted and amended, is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines party-in-interest similar to a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be party-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Some fees and expenses of the Plan relating to legal, accounting, and other administrative services are paid by the Organization. The Plan is not required to repay expenses paid by the Organization on its behalf. Certain fund-level fees incurred by the funds in which the Plan invests for such services as record-keeping, and custodial services are paid through fund level revenue sharing agreements. These fees reduce the fund earnings thereby impacting the investment return applied to the participants' accounts.

The Custodians retain as compensation for services provided to the Plan, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.
