Independent Auditor's Report

To the Plan Administrators
The Arc of San Diego 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Arc of San Diego 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Arc of San Diego 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Arc of San Diego 401(k) Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Arc of San Diego 401(k) Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 - Description of Plan:

The following description of The Arc of San Diego 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement and the Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a 401(k) salary deferral plan covering substantially all employees of The Arc of San Diego (“The Arc” or “Employer”), and is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Arc is the Plan’s sponsor and serves as Plan administrator.

The Arc has appointed Mutual of America Life Insurance Company as the Custodian of the Plan assets. The Plan was amended and restated January 27, 2016. There were no significant changes to the Plan as a result of the amendment and restatement.

Eligibility

Employees of The Arc are eligible to participate in the Plan upon reaching age 21, and after completing three months of service if they are not a trainee, consumer, client, or highly compensated employee as defined in the Plan.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. The Arc makes matching contributions to the Plan equal to 50% of employee elective deferral contributions, up to 5% of eligible compensation deferred to the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, allocation of the participant’s share of The Arc’s contributions, if any, and the participant’s share of the Plan’s earnings and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their contributions and The Arc contributions into various investment options offered by the Plan. The Plan currently offers a variety of pooled separate accounts (“PSA”) and a guaranteed interest account (“GIA”). Each PSA investment option allows transfers; however, the portfolios are monitored for transfer/reallocation activity, and may be restricted under certain conditions. The transfer restriction applies to all participant-directed transfers out of the investment option, excluding transfers made under a dollar cost-averaging program, a rebalancing program or, if applicable, any asset allocation program. Employee deferral and Company matching contributions into the investment option are not impacted by such restrictions. GIA’s allow participants to make transfers as frequently as on a daily basis.

Forfeitures

Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan, and are applied in the following order: (i) first to pay any charge under the Contract made in connection with the termination of employment of the Participant whose termination resulted in the forfeiture, and any charges under the Contract which are past-due; (ii) second, if the Employer so elects, to restore the forfeited portion of the accounts of reemployed Participants, in accordance with Plan Section 7.3; (iii) third, to pay reasonable Plan expenses as determined by the Employer, and (iv) fourth, allocated to a Participant who is active in the Plan on the accounting date in the ratio that the compensation of such Participant bears to the compensation of all Plan Participants, with any remaining amount used to offset future contributions. There were no forfeitures used during the year ended December 31, 2024. Forfeited balances totaled \$5,288 and \$3,285 at December 31, 2024 and 2023, respectively.

Vesting

Participants are fully vested in their salary deferrals, plus actual earnings thereon. In general, vesting in The Arc's contributions is based on years of service. A participant is fully vested over 4 years as follows:

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time not to exceed fifteen years. Under the terms of the Plan Agreement, Plan loans will bear a reasonable rate of interest determined by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions. The rates of interest on outstanding loans ranged from 4.25% to 9.50%, and from 4.25% to 9.25%, with various maturities through January 2030, as of December 31, 2024 and 2023, respectively.

Payment of Benefits

Upon termination of service due to death, disability, or retirement (age 65, or early retirement at age 55 and four years of vesting service), or attaining age 59-½ and still working, a participant may elect to receive a lump-sum amount equal to the value of the participant's account balance, installments based on the life expectancy of the participant or designated beneficiary as an annuity, or a combination of these methods. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan permits hardship withdrawals in certain circumstances.

Note 2 - Significant Accounting Policies:

Accounting Method

The financial statements of the Plan have been prepared on the accrual basis of accounting, which is in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). Employee and employer contributions are recognized in the period that contributions are due.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Fair Value Measurements

Fair value accounting standards define fair value, establish a framework for measuring fair value, outline a fair value hierarchy based on inputs used to measure fair value, and enhance disclosure requirements for fair value measurements. The fair value hierarchy distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity (observable inputs that are classified within Level 1 or 2 of the hierarchy), and the reporting entity's own assumptions about market participant assumptions (unobservable inputs classified within Level 3 of the hierarchy).

- Level 1 inputs are quoted prices in active markets for identical investments that the investment manager has the ability to access at the measurement date.
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the investment, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the investment.

The Plan's statements of net assets available for benefits includes the following financial instruments that are required to be measured at fair value on a recurring basis:

- Pooled separate accounts ("PSA") represent units held in pooled separate accounts that are valued using the NAV of the fund. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a PSA is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund.

Investment Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Loans to participants are reported at their unpaid principal balances, plus any accrued and unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses of the Plan, including legal, audit, administrative, and Custodian expenses, are generally paid by The Arc with the exception of certain administrative expenses, which are paid for by the Plan and charged to participants' accounts. The Plan's administrative expenses totaled \$3,838 for the year ended December 31, 2024.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through August 22, 2025, the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements:

The Plan has no assets measured at fair value that are required to be reported by classification within the fair value hierarchy at December 31, 2024 and 2023.

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 4 - Information Prepared and Certified by the Custodian:

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to the Plan's investments disclosed in the accompanying financial statements, including investments held at December 31, 2024, net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Mutual of America Life Insurance Company, the Custodian of the Plan.

Note 5 - Guaranteed Interest Accounts:

The Plan has a Guaranteed Interest Account with Mutual of America Life Insurance Company which is not fully benefit responsive. Mutual of America Life Insurance Company maintains the contributions in a general account that invest primarily in fixed maturity securities, real estate and mortgages, equity securities and policy loans. Funds placed in this account earned a guaranteed interest rate for a specified period (called the guaranteed period). Each account earns its own guaranteed interest rate. A charge may apply to early withdrawals or transfers of funds from these accounts before the guarantee period ends. The contract is included in the financial statements at contract value, and totaled \$591,975 and \$546,380 at December 31, 2024 and 2023, respectively.

Note 6 - Party-in-Interest Transactions:

Certain Plan investments are shares of pooled separate accounts and other investments managed by Mutual of America Life Insurance Company, the Custodian, and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation in fair values of investments.

Note 7 - Plan Termination:

Although it has not expressed any intent to do so, The Arc has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8 - Tax Status:

On June 1, 2014, The Arc adopted the Mutual of America Life Insurance Company Prototype 401(k) Profit-Sharing Plan Basic Plan Document No. 01. This Plan received a favorable opinion letter from the Internal Revenue Service on March 31, 2014, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan may be amended since receiving the determination letter, the Plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan believes that it has appropriate support for any tax position taken, and, as such, does not have any uncertain tax positions that are material to the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2020.
