Notes to Financial Statements

December 31, 2024 and 2023

**(1) Description of Plan**

The following description of the Quincy Community Action Programs, Inc. (the “employer”) 403(b) Thrift Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan was adopted on March 1, 1990 by the Board of Trustees of the employer, as a 403(b) Thrift Plan for the exclusive benefit of eligible employees. Mutual of America Life Insurance Company (“Mutual of America”) serves as custodian for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). During 2018, management adopted a Roth provision in accordance with Section 402(A) of the Internal Revenue Code.

Plan Eligibility – All employees are eligible to participate in the Plan on their first day of employment (“Participants”). Entry dates into the plan are the first day of the month coinciding with or immediately following the employee’s date of hire.

Employee Contributions – Employee contributions to the Plan are made each payroll period as elected by the participants up to 100% of their eligible pre-tax annual compensation, as defined by the Plan, subject to dollar limits set by the Internal Revenue Code. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants who have completed 15 years or more of service are eligible to contribute an additional \$3,000 each year, to a maximum of \$15,000 for a lifetime catch-up. The contribution election percentage can be changed or stopped at any time. Rollovers from other eligible plans are allowed.

Employer Matching Contributions – Each year, the employer may make a matching contribution to the Plan. Participants are not eligible to receive employer matching contributions until they have completed one year of service. For purposes of determining the matching contributions under the Plan, participant contributions do not include catch-up contributions. Each participant who has satisfied the service requirements of the Plan, is entitled to receive an allocation of Employer matching contributions for each Plan year equal to the lesser of (a) 100% of salary reduction contributions deferred during that Plan year, or (b) 1% of compensation received during that Plan year.

Employer Base Contributions – Participants are also eligible for employer base contributions upon completion of one year of service. Each participant who has satisfied the Plan’s service requirements is entitled to receive an allocation of employer base contributions for each Plan year equal to 6% of compensation received during that Plan year.

Vesting – Participants are immediately 100% vested in their voluntary contributions, rollovers, and earnings thereon. Participants are vested in employer contributions on a graded schedule with participants becoming fully vested after five (5) years of vesting service. A participant can become fully vested upon death or disability, as defined by the Plan, or upon reaching early retirement age (55) while employed.

Investments – All contributions to the Plan are directed by the participants to be invested into any of a variety of investment choices provided under the Plan, as determined from time to time by the trustees. Participants may change their investment choices at any time.

Notes Receivable from Participants – Participants may borrow funds against their vested account balance. Loans must be in minimum amounts of \$1,000 and may not exceed the lesser of one-half of the participant's vested account balance or \$50,000. The remaining vested account balance of the participant is used to secure the loan. Interest is payable according to the loan agreement for each particular loan. The interest rate on outstanding loans was 5.85% and loans are repaid over a maximum of 5 years through employee withholdings.

Payment of Benefits – Participants are entitled to their total vested account balance upon death, disability, retirement, or termination of employment. A participant may elect to receive a lump-sum amount equal to the value of his or her accounts or in the form of an annuity. If an employee leaves the employment of the employer, the balance can be rolled into an IRA or another tax-advantaged plan, with no penalties or the participant will be issued a check equal to their balance, which is subject to a 10% federal tax penalty.

Forfeitures – Forfeitures are first used to pay outstanding administrative expenses and then to reduce the employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$23,990 and \$9,145, respectively. Forfeitures of \$23,990 and \$9,145 were used to reduce the employer's contributions for the years ended December 31, 2024 and 2023, respectively.

Mandatory Distributions – If a Participant's vested account balance is less than \$1,000, the Plan administrator, after notification, can distribute the entire non-forfeited account balance to the participant upon termination of employment.

***Basis of Accounting***

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). The significant accounting policies followed by Quincy Community Action Programs, Inc. are described below to enhance the usefulness of the financial statements to the reader.

***Use of Estimates***

The presentation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefits are recorded when paid.

**(2) Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There are no Plan assets requiring the use of Level 2 and Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

***Level 1 Fair Value Measurements***

The fair value of Pooled Separate Investments, which are mutual funds, is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The General Fund is an interest-bearing cash account.

Certain Plan investments are shares of mutual funds managed by Mutual of America. Mutual of America is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### **(4) Plan Termination**

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### **(5) Tax Status**

The Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS). The plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### **(6) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **(7) Subsequent Events**

The Plan has performed an evaluation of subsequent events through October 8, 2025, which is the date The Plan's financial statements were available to be issued. No material subsequent events have occurred since December 31, 2024 that required recognition or disclosure in these financial statements.
