Independent Auditor's Report

To the Plan Trustee
Eggleston Special Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Eggleston Special Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Eggleston Special Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Eggleston Special Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Eggleston Special Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of the Eggleston Special Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Louise W. Eggleston Center, Inc. (“Company”). The Plan is subject to the provisions of ERISA. The Plan trustee is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

The Plan trustee has entered into a merger and transfer agreement whereby the Eggleston Services 401(k) Plan will be merged into this Plan effective January 1, 2026.

Contributions: Each year, participants may contribute up to the maximum allowed by law of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company makes a prevailing wage contribution for employees who perform services subject to the Service Contract Act, Davis-Bacon Act or similar Federal, State, or Municipal Prevailing Wage statutes. Prevailing wage contributions are not subject to age or service requirements. The Company may make profit-sharing contributions to eligible participants. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant accounts: Each participant's account is credited with the participant’s contributions and Company prevailing wage contributions, as well as allocations of the Company’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative and investment expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are vested immediately in all contributions plus actual earnings thereon.

Payment of benefits: On termination of service, a participant may elect to receive a lump sum amount equal to the value of the participant’s vested interest in his or her account. In-service withdrawals are permitted for participants who have attained age 59 1/2 or for a qualified financial hardship.

2. Summary of Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan trustee determines the Plan’s valuation policies utilizing information provided by the investment adviser and John Hancock Life Insurance Company (U.S.A.) (“John Hancock”). See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from Plan participants and the Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to recordkeeping, and benefits paid are charged directly to the participant’s account and are included in administrative expenses. Fees paid directly by the Plan for investment advisory services are included in investment expenses. Investment related expenses paid indirectly through revenue sharing arrangements are included in net appreciation of fair value of investments.

Subsequent events: The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued by John Hancock, the sponsor of the pooled separate accounts, at net asset value (“NAV”). The NAV is based on the fair value of the underlying investments held by each account less its liabilities. The NAV is published daily and available to plan participants and is the basis for current transactions.

4. Related Party Transactions and Party in Interest Transactions

Plan investments are managed and sponsored by John Hancock. John Hancock is the recordkeeper for the Plan. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity. These transactions qualify as exempt party in interest transactions.

John Hancock provides a credit to participants based on the monthly balance of assets in the Plan. The Plan credit is allocated to the Plan participants monthly. The credit for the year ended December 31, 2024 was \$6,384. The credit is included in other income in the statement of changes in net assets available for benefits.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100 percent vested in their employer contributions.

6. Tax Status

The IRS has determined and informed the pre-approved plan sponsor by a letter dated June 30, 2020, that pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the pre-approved plan has been amended since receiving the opinion letter, the Plan administrator and the pre-approved plan sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

8. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock.

9. Nonexempt Transactions

Title I of ERISA requires that all employee contributions be remitted to the Plan as soon as administratively possible but no later than the 15th business day of the month following the month of being withheld from compensation. Failure to remit employee contributions to the Plan on a timely basis is considered a nonexempt prohibited transaction with a party in interest. Participant contributions of \$19,983 and \$471 were withheld from participants’ pay during

2024 and 2023, respectively, but were not remitted to the Plan's trust within the time frame required by the Department of Labor. The 2024 contributions were remitted to the Plan during 2024 and 2025; the 2023 contributions were remitted during 2024. Lost earnings related to the 2024 contributions will be corrected through procedures prescribed by the Department of Labor during 2025.

10. Operational Error

During the years ended December 31, 2024 and 2023, the Company failed to remit prevailing wage contributions totaling \$189,031 and \$353,827, respectively, to the Plan on a timely basis. Contributions for 2023 plus lost earnings were remitted to the Plan in 2024. Lost earnings of \$18,726 are included in other income. The 2024 contributions will be remitted as soon as possible. The Plan sponsor does not believe lost earnings related to the late 2024 remittance are material to net assets available for benefits.
