Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Easter Seals Serving DC|MD|VA 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Easter Seals Serving DC|MD|VA 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Basis for Opinion

Responsibilities of Management for the Financial Statements

Notes to Financial Statements

1. **Description of the Plan** The following description of the Easter Seals Serving DC|MD|VA 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Easter Seals Serving DC|MD|VA, Inc. (the "Organization"), except for nonresident aliens and employees eligible to participate in a qualified cash or deferred arrangement or eligible governmental plan. All eligible employees may enter the Plan immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan allows for discretionary matching contributions. During 2024, the Organization contributed 50 percent of the first six percent of compensation that a participant contributed to the Plan. Participants direct the investments of their contributions and Organization contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Organization's discretionary matching contributions, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,949 and \$27,898, respectively. These accounts will be used to reduce future Organization contributions or to pay Plan expenses. During 2024, \$36,431 of forfeited nonvested accounts was used to reduce Organization contributions, and \$10,491 was used to pay Plan expenses.

Easter Seals Serving DC|MD|VA 403(b) Plan

Notes to Financial Statements

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization discretionary contributions is based on years of continuous service of at least 1,000 hours per year. A participant is 25 percent vested after two years of service is completed, and vests an additional 25 percent per year until full vesting after five years.

Payment of benefits: Benefits are payable upon retirement at the later of attaining age 65 or five years of participation, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in life annuities, installments, and lump sum payments.

Notes receivable from participants: Participants may borrow from their fund accounts, held by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"), a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus two percent. Principal and interest are paid through payroll deductions.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Organization. Transaction expenses, such as loan and distribution administration fees are charged directly to the participant's account and are included in administrative expenses. Participants may also be charged asset-based fees for administrative expenses. These fees are deducted from participant accounts and included in administrative expenses.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Contributions: Participant contributions and the related Organization discretionary matching contributions are recognized in the period the participant contribution is withheld from compensation.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through October 8, 2025, which is the date the financial statements were available to be issued.

- 3. Certified information** Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Mutual of America Life Insurance Company, the custodian and insurance company of the Plan.
- 4. Fair value measurements** The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the units of pooled separate accounts is based on the net asset value (“NAV”) on the last business day of the Plan year provided by the entity holding the accounts. The NAV is used as a practical expedient to estimate fair value and is determined by the custodian and insurance company based on the fair value of the underlying assets in the account, less the liabilities.

(a) In accordance with ASC 820, certain investments that were measured at net asset value per share (or its equivalent) as of December 31, 2024 and 2023 have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statements of Net Assets Available for Benefits.

Investments in all pooled separate accounts can be redeemed immediately at the current net asset value based on the fair value of the underlying assets. There are no withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2024 and 2023.

5. Guaranteed interest account and Guaranteed investment contract

The Plan participates in a traditional benefit responsive investment contract with Mutual of America Life Insurance Company ("MOA") via an investment in a Guaranteed Interest Accumulation Account under group annuity contracts. The balance for the contract as of December 31, 2024 and 2023 was \$6,413 and \$6,273, respectively. MOA commingles the assets of the Guaranteed Interest Accumulation Account with other assets in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. MOA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value, as reported to the Plan by MOA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value.

The Plan also participated in a traditional benefit responsive investment contract with Principal via an investment in a Guaranteed Investment Contract ("GIC"). The balance for the contract as of December 31, 2023 was \$993,108. Principal commingled the assets of the GIC with other assets in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct withdrawals or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise for either investment contract.

No events limit the ability of the Plan to transact at contract value. There are no limitations for the Guaranteed Interest Accumulation Account with MOA. There was a surrender charge of five percent for an employer-level liquidation of this contract unless the employer provides 12 months advance notice with the GIC under Principal. On July 1, 2023, the Organization provided Principal with their written intent to terminate the GIC effective July 1, 2024. Due to providing the 12 months notice, participants were able to continue to transact with the contract at contract value, as such the GIC retained its benefit responsive status and was reported at contract value at December 31, 2023. All funds were liquidated from the GIC in July 2024.

- 6. Risks and uncertainties** The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 7. Plan termination** Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
- 8. Tax status** The Plan is a volume submitter plan of CCH Incorporated DBA FTWilliam Com which received an opinion letter on March 31, 2017, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Party-in-interest transactions

Certain Plan investments are managed by affiliates of Principal and Mutual of America Life Insurance Company ("MOA"). Principal and MOA are the custodian, insurance company and recordkeepers as defined by the Plan. During 2024, the Plan paid \$36,849 to Principal, MOA, and Pentegra, the Plan's investment advisor, for recordkeeping and advisory services. These transactions qualify as exempt party-in-interest transactions.

During 2024 and 2023, the Organization did not remit certain employee contributions and loan repayments, within the period prescribed by Department of Labor regulations, to the custodian totaling \$118,003. These delinquent remittances are considered nonexempt party-in-interest transactions.

10. Subsequent events

Effective February 1, 2025, the Plan was amended and restated to adopt a volume submitter plan of Pentegra Services Inc. Effective with this amendment and restatement, the exclusion of employees eligible to participate in a qualified cash or deferred arrangement or eligible governmental plan for Plan participation has been removed. Also effective with the amendment and restatement, the Plan provides for an additional discretionary matching contribution. Participants must be employed on the last day of the Plan year to be eligible to receive any additional discretionary matching contributions. The participation requirement for participants to be eligible to take a retirement distributions was reduced from five years of participation to two years effective with the February 1, 2025 amendment and restatement.

In connected with the amendment and restatement, all net assets of the Plan were transferred to Reliance Trust Company on February 26, 2025.
