### 1. Description of Plan

#### General

The following description of First County Bank Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan was established, effective August 1, 2000, most recently amended as of January 1, 2022, and most recently restated as of July 1, 2022. The Plan is a defined contribution plan covering substantially all employees of First County Bank (the Company) who have completed 90 days of service and are age 21 and over, except for leased employees, bargaining employees and residents of Puerto Rico. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the Trustee) serves as the trustee for the Plan and Principal Life Insurance Company (PLIC) serves as the recordkeeper for the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). All investments are participant directed. On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE Act 2.0) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE Act 2.0 will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

#### Eligibility

Employees become eligible to make pre-tax and/or after-tax (Roth) contributions once they have completed 90 days of service and are age 21 or older. After an employee of the Company has satisfied the eligibility requirements, they will automatically enter the Plan as a participant on the first day of the payroll period coinciding with or following the date on which the eligibility requirements are met.

The Company provides Qualified Automatic Contribution Arrangements (QACA) safe harbor matching contributions in an amount equal to 100% of participants' elective deferrals up to the first 6% of eligible compensation. For the year ended December 31, 2024, employer safe harbor matching contributions amounted to \$994,462.

Employees are eligible for QACA employer contributions as well as Company discretionary contributions after the participant is age 21 or older and completes 1,000 hours of service during an eligibility contribution period. If a participant does not complete 1,000 hours of service within the first twelve consecutive months of employment, then the service requirement would be satisfied once the participant is credited with one year of service.

#### Contributions

Participants may defer their eligible compensation up to the annual Internal Revenue Code (the Code) limit. Participants can make pre-tax contributions or Roth elective 401(k) contributions. Participants of the Plan are permitted to defer eligible compensation by a specific percentage or dollar amount. Employees who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (Rollovers).

### 1. Description of Plan (Continued)

The Sponsor automatically enrolls employees, who did not affirmatively elect otherwise, in the Plan. Employees who are automatically enrolled make a pre-tax deferral contribution in the amount of 6% for each payroll period, with automatic annual escalations of 1%, up to a maximum of 9%.

At the discretion of the Company's Board of Directors, the Company may make a discretionary contribution to the Plan. Any discretionary contributions are allocated to participants in the same ratio as each eligible participant's compensation bears to the total of such compensation to all eligible participants. For the year ended December 31, 2024, there were no discretionary contributions made to the Plan.

Participants may select the investments in which their accounts are invested from among a variety of available investment options.

#### Vesting

Participants are immediately vested in their elective contributions, including rollover contributions, plus actual earnings thereon. Participants are vested in the Sponsor's QACA contributions and discretionary contributions, plus actual earnings thereon based on years of continuous service. The vesting schedule for QACA contributions is as follows:

#### Participant Accounts

Each participant's account is credited with the participant's contributions and a proportionate allocation of any Company contributions and Plan earnings or losses, and charged with an allocation of administrative expenses, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. **Description of Plan (Continued)**

#### *Notes Receivable From Participants*

The Plan allows loans for hardship to employees participating in the Plan. The amount of any loan shall be at least \$1,000 and shall not exceed the lesser of (a) \$50,000 reduced by the individual's highest outstanding loan balance during the twelve-month period ending on the day before the date the new loan is made; or (b) 50% of the individual's vested account balance. Notes must be repaid within five years, unless the proceeds are used to buy a principal residence. The repayment term for notes used to purchase a principal residence will be the lesser of 15 years or the term currently in effect for commercial home loans. The interest rate will be based on local prevailing rates, as determined by the Plan Administrator. Interest rates ranged from 3.25% to 10.50% as of December 31, 2024 with various maturities through July 2037.

Each loan is collateralized by the borrower's interest in the Plan and is evidenced by a promissory note. Loan repayment and interest is made through payroll deduction. Loan fees are assessed against an individual participant's account.

#### *Participant Withdrawals*

On termination of service due to death, disability, or retirement, a participant will receive a lump-sum payment if the account balance is less than \$5,000. If the participant's account balance is more than \$5,000, payment will be made in the form of an annuity, unless the annuity option is waived, in which case a lump-sum payment will be made. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. The Plan permits hardship withdrawals due to financial hardship as defined in the Plan document., from participants' pre-tax elective deferral account and employer discretionary account. In-service distributions are allowed once a participant reaches the age of 59½ from the participant's vested elective deferral contributions and discretionary contributions. Participants can choose to have retirement benefits on or after the later of their early retirement age or at age 55 if they have 5 years of vesting service. In-service distributions are also allowed anytime from a participant's rollover account. Distribution payments can either be cash distributions to the participant or a tax free rollover to an individual retirement account or another qualified plan.

#### *Administrative Expenses*

Expenses resulting from participant loans, certain investment fees, and fees related to lump-sum distributions are deducted directly from participant accounts. All other administrative expenses are paid by the Company.

#### *Forfeited Accounts*

The Plan provides for restoration of forfeited funds upon re-employment of former participants in specified circumstances. Forfeited non-vested accounts are used to reduce future employer matching contributions and pay administrative expenses of the Plan. Unallocated forfeitures totaled \$4,223 and \$5,656 at December 31, 2024 and 2023, respectively.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for various investment options which are exposed to various risks such as interest rate, market volatility, liquidity and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

#### Investment Valuation and Income Recognition

Investments in mutual funds and pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

The guaranteed investment contract is reported at contract value, as determined by the insurance company, as it is considered fully benefit-responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan (see note 5).

Purchases and sales of investment securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes realized gains and losses on investments that were both bought and sold during the year as well as net unrealized appreciation on investments held at year end.

#### Contributions

Participant contributions are reported in the period in which payroll deductions are made; employer matching contributions are recorded in the same period as corresponding participant contributions. Employer discretionary contributions are recorded in the year the Company commits to make the contribution.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Notes Receivable From Participants*

Notes receivable from participants are carried at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### *Subsequent Events*

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

### 3. **Tax Status**

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not taxable.

The underlying non-standardized, pre-approved profit sharing plan has received a letter dated June 30, 2020 from the Internal Revenue Service (IRS) that the form of the Plan was acceptable under section 401(a) of the Code. Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Assets that are measured at fair value using the net asset value (NAV) per share practical expedient have not been classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Valued at the net asset value (NAV) of units of the separate account. The NAV, as provided by PLIC, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. These units are not traded on a securities exchange but are redeemable only by the issuer. The rate of return varies based upon each fund's experience. These accounts do not distribute dividends or interest to the Plan, rather investment performance is reflected in the change in the unit value. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no restrictions on the sale or transfer of investments in pooled separate accounts. There are no unfunded commitments at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Contract With Insurance Company

The Plan is invested in The Principal Guaranteed Option (PGO), a fully benefit-responsive investment contract, with Principal. Principal maintains the contributions in a general account. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Principal. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. In the PGO, the contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer by may not be less than 1%. As of December 31, 2024, the crediting rate was 2.30% and is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

### 5. **Contract With Insurance Company (Continued)**

Certain events may limit the ability of the Plan to currently transact at contract value and may result in a deferral of the payment at contract value for up to twelve months. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from Plan coverage as a result of temporary absence, change in position or other occurrence qualifying as a temporary break in service under the Plan; (2) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; or (3) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Bank's business. Such events also include: (1) removal from the Plan of one or more groups or classifications of participants; (2) partial or complete Plan and contract termination of the Contract; (3) partial or complete Plan terminations; or (4) Plan disqualification. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### 6. **Information Certified by the Trustee**

Plan asset information disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) relating to investments, related net appreciation in fair value of investments, interest and dividends, and investment transactions, participant loans, interest on participant loans, related investment transactions, and participant loan transactions, was certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, the Plan's trustee, as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The Plan has determined that Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company meets the requirements of a qualified institution as defined by the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, in accordance with the request of the Plan's Administrator and as allowed under ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, this information was not subjected to auditing procedures generally accepted in the United States of America by the Plan's independent auditors except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental Schedule of Assets (Held at End of Year).

### 7. **Party-in-Interest Transactions**

Plan investments include pooled separate accounts and a guaranteed investment account managed and held by PLIC, an affiliated company of the Trustee. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan to the trustee totaled \$7,273 for the year ended December 31, 2024. The Sponsor also paid certain administrative expenses of the Plan.

Notes receivable from participants also qualify as exempt party-in-interest transactions as defined by ERISA.

#### 8. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their balances.

#### 9. **Reconciliation of Financial Statements to Form 5500**

Notes receivable from participants are reflected as investments in the Form 5500, which differs from the presentation of a receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023. The related interest income is shown as investment income on the Form 5500, which differs from the presentation of interest and dividends on the statement of changes in net assets available for benefits for the year ended December 31, 2024.
