We have performed audits of the accompanying financial statements of

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**(1) Description of the Plan**

The following description of the Pyramid Masonry Contractors, Inc. 401(k) Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan covers all eligible employees of Pyramid Masonry Contractors, Inc. (the “Company” or “Plan Sponsor”) who have completed one year of service and are age 21 or older. Employees enter the Plan on the first day of the month on or after they meet the eligibility requirements. The Plan was established effective January 1, 1987 and was subsequently amended and restated in January 2022. The Plan was amended in January 2023 to update the non-elective contribution policy and the default form of distributions.

Contributions - Participants are subject to an auto enrollment at 6% of annual compensation for each payroll period, unless the employee elects to opt out of the Plan or elects a different deferral amount. This percentage is automatically increased annually by 1% up to a maximum of 10%, subject to limitation amounts under the provisions of the Internal Revenue Code (“IRC”). Participants may contribute up to \$23,000 for 2024 and \$22,500 for 2023, of pretax annual compensation. Participants who have attained the age of 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also “roll over” amounts representing distributions from other qualified plans. The Plan Sponsor may make matching contributions equal to a percentage of the elective deferral contribution, as defined in the Plan agreement, and determined based on the Plan provisions. The employer matching contributions were \$57,157 in 2024 and \$60,162 in 2023. The Plan Sponsor may also make discretionary contributions to the Plan. No additional non-matching discretionary contributions were made in the 2024 and 2023 Plan years.

Participant accounts - Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution, (b) Plan earnings (losses), including unrealized appreciation (depreciation), and (c) forfeited balances of terminated participants’ non-vested accounts, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their contributions, including rollovers, plus actual earnings thereon. Vesting in the Company’s matching and discretionary contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of continuous service.

Investment options - The Plan offers several investment options and participants may instruct the trustee in how they want to invest their funds without regard to their vested interest.

Participants may change their investment options and move money from one fund to another in accordance with rules established by the Plan Administrator. The Plan Administrator may change the investment options available to participants at any time.

**(1) Description of the Plan (continued)**

Forfeited accounts - Forfeited non-vested accounts may first be used to pay Plan expenses and may also be used to reduce future Company contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$748 and \$682, respectively.

Payment of benefits - Upon termination of service due to death, disability, or retirement, a participant will receive an amount equal to the vested value in the participant's account. If the participant's vested interest in their account is \$7,000 or less at termination, the amount will be paid to the participant or their beneficiary in a single sum. Participants with vested benefits in excess of \$7,000 may choose to receive their benefit in the form of a lump-sum payment or through partial withdrawals, subject to Plan provisions.

**(2) Summary of significant accounting policies**

Basis of accounting - The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Risks and uncertainties - The plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflicts. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the valuation of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Estimates - The preparation of the financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - The Plan's investments are presented at fair value in accordance with Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820: *Fair Value Measurements and Disclosures* in Note (3), based on the quoted market prices of the underlying securities within each fund at the Plan's year end. Shares of mutual funds and bond funds are valued at quoted market prices that represent the net asset value of shares and units held by the Plan at year end. The Plan follows FASB Accounting Standards Update ("ASU") 2015-07, *Fair Value Measurement (Topic 820): Disclosures for Investments in Certain Entities that Calculate Net Asset Value per Share (or its Equivalent)*, ASU 2015-12, *Plan Accounting: Defined Benefit Pension Plans (Topic 960), Defined Contribution Plans (Topic 962), Health and Welfare Benefit Plans (Topic 965): (Part I) Fully Benefit-Responsive Investment Contracts, (Part II) Plan Investment Disclosures, (Part III) Measurement Date Practical Expedient, and also follows FASB ASU 2018-09 Codification Improvement*.

Purchases and sales of securities are recorded on the trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investment income - Investment income (loss) consists of interest, dividends, gains (losses) on sales of securities and the unrealized appreciation (depreciation) in fair market value of investments. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payments of benefits - Benefits are recorded when paid.

Plan expenses - Certain expenses may be paid by the Company directly on behalf of the Plan while others may be paid from the Plan assets. The expenses paid from Plan assets will either be shared by all participants or will be charged directly to the account of the participant on whose sole behalf the expense is incurred. Expenses shared by all participants will either be paid on a pro rata basis or on an equal dollar basis.

**(3) Fair value measurements**

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of inputs used to measure fair value under FASB ASC 820 are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* These investments are stated at fair value as determined by observable Level 1 quoted pricing inputs or by quoted prices for similar assets in active or non-active markets. While some pooled separate accounts may have publicly quoted pricing inputs (Level 1), the account values of these pooled separate accounts are not publicly quoted and are therefore classified as Level 2 investments.

*Common collective trust mutual funds:* Common collective trust mutual funds are stated at fair value as determined by observable Level 1 quoted pricing inputs or by quoted prices for similar assets in active or non-active markets. While some common collective trust accounts may have publicly quoted pricing inputs (Level 1), the account values of these common collective trusts are not publicly quoted and are therefore classified as Level 2 investments.

*Mutual funds:* These investments consist of various publicly traded money market funds and mutual funds. The fair values are based on quoted market prices and are therefore classified as Level 1 investments.

*Stable value fund:* The fair value of the stable value fund is estimated based on net asset value ("NAV") as a practical expedient, as provided by the trustee, as a proxy to fair value. There are no unfunded commitments related to the stable value fund and investments in the stable value fund can be redeemed on a daily basis without restriction.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(5) Stable value fund**

The Plan invests in a stable value fund. The stable value fund has invested all of its assets in the Principal Stable Fund, a collective trust fund sponsored by Principal Global Investors Trust Company, that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the collective trust, as is provided by the fund manager. The NAV is used as practical expedient to estimate fair value. This practical expedient is used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification to ensure that securities liquidations will be carried out in an orderly business manner.

There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

**(6) Plan termination**

The Company intends to continue the Plan indefinitely for the benefit of its employees, but reserves the right to amend, modify, or terminate the Plan at any time or for any reason subject to the terms of ERISA. In the event the Plan terminates, the participants will be entitled to the full amount in their account as of the date of termination, regardless of their percent vested at the time of termination.

**(7) Tax status**

The Plan received a favorable determination letter from the IRS on June 1, 2021, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
