INDEPENDENT AUDITOR'S REPORT

Plan Sponsor and Management
Howard Industries, Inc. Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Howard Industries, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter

As discussed in Note 6 to the financial statements, the Plan sponsor is aware of a potential operational matter with respect to the Plan. The Plan sponsor is in the process of completing a voluntary compliance program application and will work directly with the Internal Revenue Service and other regulatory bodies to resolve this matter to the extent necessary. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of Howard Industries, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering employees of Howard Industries, Inc. and Subsidiaries ("Howard", "Plan Sponsor" or the "Company") who are not covered by a collective bargaining agreement, not leased employees or hourly paid production workers, quality control employees or maintenance employees of the Ballast Division of Howard Industries, Inc., mechanics or line haul truck drivers of Howard Transportation, Inc., security guards at any Howard divisions or affiliate companies and are not currently participating in the Howard Industries, Inc. Employees' Retirement Services Plan. The Plan requires the participant to have completed one year of service by the end of a twelve month period and has no age requirement. The participant will be credited with a year of service for eligibility purposes for each twelve month period during which they have completed 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions and Rollovers

The Plan allows for participants to make pretax contributions to the Plan subject to the limitations set forth in the Internal Revenue Code (the "Code"), including catch-up contributions, but not more than 50 percent of their pretax eligible annual compensation. The Company has elected to make safe harbor matching contributions in an amount equal to 100 percent of the first 3 percent and 50 percent of the next 2 percent of eligible compensation contributed to the Plan by participants as pre-tax contributions. Contributions from Plan participants and the safe harbor matching contributions from the employer are recorded in the year in which participant compensation is earned. Rollovers represent distributions from qualified plans not sponsored by the Plan Sponsor. Rollover contributions totaling \$21,021 are included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Participant Investment Programs

Contributions to the Plan are invested into any of the investment funds available under the Plan provisions in such proportions as the participants direct. Participants may change investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocation of the Company's matching contributions and Plan earnings and losses as well as an allocation of administrative expenses to the extent such expenses are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The Plan provides benefits based solely upon the amount contributed to the participant's account and any income, expenses, gains and losses on investments, which may be allocated to such participant's account.

Note 1. Continued

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon along with the safe harbor matching contributions.

Payment of Benefits

Benefits are generally payable on termination, retirement, death or disability. Benefits may be paid by either lump-sum or monthly, quarterly or annual installments over a fixed reasonable period of time. Hardship distributions are also available from the vested portion of the participant's account.

Note 2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized and unrealized gains and losses in the Plan's investments are included in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses incurred by the Plan are generally paid by the Plan. These fees totaled \$150,840 in 2024 and were allocated to participants in accordance with the Plan document.

Fidelity also certified to the completeness and accuracy of \$6,453,725 of net appreciation in fair value of investments and \$3,029,163 of interest related to the aforementioned assets for the year ended December 31, 2024, respectively.

Note 4. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of a common collective trust, mutual funds, and money market fund managed by Fidelity, the trustee of the Plan. Fidelity is considered a related party under Accounting Standards Codification ("ASC") 850 and a party-in-interest under ERISA. For the year ended December 31, 2024, Fidelity credited the Plan \$37,800 related to a reduction in recordkeeping fees, which reduced administrative expenses.

Administrative expenses paid by the Plan to Regions Bank ("Regions"), which serves as an investment advisor to the Plan, totaled \$142,921 for the year ended December 31, 2024. Regions is considered a related party under ASC 850 and a party-in-interest under ERISA.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to terminate the Plan at any time, subject to the provisions of ERISA. If terminated, the net assets of the Plan are to be set aside for the participants' vested benefits.

Note 6. Income Tax Status

The Company has adopted a volume submitter Plan whose sponsor obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The volume submitter Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTES TO FINANCIAL STATEMENTS

Note 6. Continued

The Plan Sponsor is aware of a potential operational matter with respect to the Plan that, if not corrected, could be treated by the IRS as a qualification failure and may result in contributions from the Plan Sponsor to the Plan. The Plan Sponsor is in the process of completing a voluntary compliance program application and will work directly with the IRS and other regulatory bodies to resolve this matter to the extent necessary. Accordingly, management does not believe this matter will impact the Plan's income tax status going forward.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") ASC Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

Common collective trust: The common collective trust ("CCT") includes the Fidelity Advisor Stable Value Portfolio Class I (Level 2). The fair value of the CCT is measured at NAV reported by the sponsor of the fund. The Plan's investment in the CCT is calculated by applying the Plan's ownership interest to the total reported NAV of the CCT at the end of the reporting period. Participant transactions and redemptions (purchases and sales) may occur daily.

Money market fund: Valued at the NAV of shares held by the Plan at year-end, as reflected in an active market (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
