Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Plan de Compensación Diferida 1081.01(d) de la Cooperativa de Seguros de Vida de Puerto Rico (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of Plan

The following brief description of Plan de Compensación Diferida 1081.01(d) de la Cooperativa de Seguros de Vida de Puerto Rico (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan adopted on August 1, 2008. It covers all full-time employees of Cooperativa de Seguros de Vida de Puerto Rico and Puerto Rico Sales and Marketing Agency, Inc. (PRISMA) (collectively, the Sponsor or COSVI) who have at least one year of service and are eighteen years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Puerto Rico Internal Revenue Code of 2011 (the 2011 Code), as amended.

Effective May 17, 2023, Empower Trust Company, LLC was appointed as custodian and record-keeper of the Plan.

(b) Contributions

Each year, participants may contribute an amount not to exceed the maximum deferral amount specified by the Puerto Rico tax law. Annual deferral limit under the 2011 Code is \$15,000 for the taxable years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified plans. Participants may make voluntary contributions to the Plan from 1% to 10% of their compensation, or as otherwise provided under Section 4.3 of the Plan. The Plan was amended effective January 1, 2020 to allow the Sponsor to make a discretionary contribution to be allocated to all active employees on a basis of percentage of compensation. The availability of this contribution will be determined in a year to year basis and subject to the approval of the Board of Directors of the Sponsor through duly executed corporate resolutions. For the years ended December 31, 2024 and 2023, the Sponsor made contributions to the Plan amounting to \$77,881 and \$71,704, respectively.

Participants over age 50 are permitted to make an additional \$1,500 catch up contribution after contributing the Plan limit of \$15,000 of their pre-tax annual compensation.

(c) Participant Accounts

Each participant's account is credited with the participant's contribution as well as allocations of Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Sponsor's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after completing three years of credited service.

(e) Payments of Benefits

Normal retirement pension benefits are payable upon the date a participant reaches 60 years of age. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period or over the remaining life expectancy of the participant (or designated beneficiaries) if the vested interest exceeds \$5,000. However, if the amount in the participant's account is \$5,000 or less, the participant or designated beneficiaries will receive that amount in one lump-sum payment. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

(f) Early Retirement

For participants that elect early retirement, the pension benefits are payable upon the date a participant reaches 55 years of age with 3 years of service.

(g) Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the Puerto Rico Internal Revenue Code are recoded as a liability with a corresponding reduction to contributions.

(h) Hardship Withdrawals

Under certain conditions, participants, while still employed by the Sponsor, are permitted to withdraw, in a single sum, the employee contribution portion of their account balance. These conditions include un-reimbursed medical expenses, the purchase of a principal residence, the payment of postsecondary education tuition or to prevent eviction from or foreclosure on a principal residence or any other cause that has produced an immediate financial need. A participant's right to make deferrals to the Plan will be suspended for 12 months after the receipt of the hardship withdrawal.

(i) Forfeited Accounts

Forfeitures under the Plan will be added to the employer contributions and allocated accordingly. At December 31, 2024 and 2023, available forfeitures amounted to \$801 and \$448, respectively.

(j) Rollover Contributions

Rollovers contributions to the Plan consist of monies received by a Participant from another plan qualified under the Puerto Rico Internal Revenue Code.

(k) Administrative Expenses

All administrative expenses, to the extent not paid by the Sponsor, are paid from the Plan's assets. During the years ended December 31, 2024 and 2023, administrative expenses paid by the Plan amounted to \$35,894 and \$18,582, respectively.

(l) Investments Options

Effective May 17, 2023, the Sponsor changed its plan record-keeper and custodian from Transamerica Life Insurance Company to Empower Trust Company, LLC. On June 20, 2023, the assets of the Plan were transferred to the new record-keeper and custodian. The investment options available to employees prior to June 20, 2023, also were replaced with the investment securities offered by the new record-keeper and custodian. The deposit administration contract with COSVI was settled at contract value and no penalties were assessed.

Participants may direct their contributions to various mutual funds and a group annuity contract with Empower Annuity Insurance Company of America as described in Notes 4 and 5, respectively.

(2) Summary of Accounting Policies

(a) Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

(b) Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 5 for disclosure of Group Annuity Contract with Insurance Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

<i>Mutual funds:</i>	Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. (5) Group Annuity Contract with Empower Annuity Insurance Company of America

In 2023, the Plan entered into a traditional fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (EAICA). EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and the credited interest rate established and declared to the Plan. The guaranteed minimum interest rate will be equal to 0.00%.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$2,471,942 and \$2,483,096, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0% for EAICA contract agreement. Such interest rate is reviewed on a quarterly basis for resetting.

The methodology for calculating the interest crediting rate of the contract with EAICA is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly.

Certain events might limit the Plan's ability to transact at contract value with EAICA. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal or state income taxes or any required prohibited transaction exemption under ERISA, (e) premature termination of the contract. Termination of contract may also occur by virtue of plan change in asset management. In any of these cases, the value of participants' interest in the funds is determined taking into consideration the end of the day value divided by the number of units then outstanding.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured violation of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a breach of material obligation under the contract, or (d) a material misrepresentation.

(6) Plan Termination

Although the Sponsor has not expressed any intention to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, reduction, or suspension, no further contributions are required from the Sponsor and the accounts of all participants will become fully vested and non-forfeitable.

(7) Tax Status

The Puerto Rico Treasury Department (PRTD) has determined and informed the Sponsor by letter dated March 10, 2017, that the Plan and related trust are designed in accordance with applicable sections of the 2011 Code, therefore, the Plan is qualified and tax-exempt.

On June 12, 2020, the Puerto Rico Treasury Department determined and informed the Sponsor that has no objection to the Plan amendments to include PRISMA as a Participant Employer under the Plan, effective as of June 1, 2019 and to authorize discretionary employer matching contributions under the Plan, effective as of January 1, 2020.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an

uncertain position that more likely than not would not be sustained upon examination by federal, state and/or local taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Prohibited Transactions – Participant’s Contributions Remittances

Department of Labor’s Regulation 2510.3-102, requires that participant contributions be remitted to the Plan on the earliest date on which they can be reasonably segregated from the Sponsor’s general assets but in no event later than the 15th business day following the end of the month in which amounts are contributed by employees or withheld from their wages. There were unintentional delays in the remittance of participant’s contributions during the Plan year ended December 31, 2024. The Sponsor has agreed to absorb any costs incurred by the Plan including lost interest as a result of the untimely remittances of the participants’ contributions. The accumulated loss earnings on such late remittances amounted to \$229 at December 31, 2024. In 2023, there were no delays in the remittance of participant’s contributions to the Plan.

(9) Risk and Uncertainties

The Plan invests in several investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits. Individual participants’ accounts bear the risk of loss resulting from fluctuations in investment values.

(10) Party-in-Interest Transactions

As of December 31, 2024 and 2023, the Plan held a group annuity contract that is managed by Empower. Empower is the custodian and record-keeper for the Plan, therefore, this transaction qualify as party in interest transaction permitted under the provisions of ERISA.

(11) Voluntary Compliance

During year 2024, the Plan Sponsor identified an operational error in which one eligible employee’s elective deferral withholding was not performed. As a result, the employee’s salary deferral contributions were not withheld and remitted to the Plan, resulting in a missed deferral opportunity. Corrective contributions to the participant account for \$8,319, and lost earnings, amounting to \$352 have been identified and quantified by the Sponsor. The corrective contributions were deposited in the Plan on December 11, 2024. The accrued earnings were deposited in the Plan in 2025.

The corrective contributions were based in accordance with the IRS Employee Plans Compliance Resolution System (EPCRS), the Plan Sponsor initiated a voluntary correction under the Self-Correction Program (SCP). To restore the employee's lost retirement savings opportunity, the Plan Sponsor made a Qualified Nonelective Contribution (QNEC) equal to 50% of the employee's missed deferral amount, 100% of the match the employee would have received, adjusted for lost earnings. An estimate of \$352 is recorded as Qualified Non-Elective Contribution receivable as of December 31, 2024, in the accompanying statements of net assets available for benefits. The estimate reflects investment earnings and losses based upon the affected participant's investment interest yield during the year.

(12) Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date at which the financial statements were available to be issued. The Plan Administrator has determined that except for, the matter discussed in Note 11, no events exist in that period that require disclosure in or any adjustments to the accompanying financial statements.
