## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Ace World Wide 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Ace World Wide 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended, and the related notes to the financial statements - modified cash basis.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 1.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting as described in Note 1, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits do not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audits of the Financial Statements**

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 1.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

### **Other Matter - Basis of Accounting**

We draw attention to Note 1 of the financial statements, which describes the basis of accounting. The financial statements were prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles accepted in the United States of America. Our opinion is not modified with respect to this matter.

### **ERISA-Required Supplementary Information**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Method of accounting** - The accompanying financial statements have been prepared on the modified cash basis of accounting. Under that basis, certain additions and the related assets are recognized when received rather than when earned and certain deductions are recognized when paid rather than when the obligation is incurred. That basis differs from accounting principles generally accepted in the United States of America ("GAAP") primarily because the plan does not recognize contributions receivable and the related effects on changes in net assets in the accompanying financial statements.

**Accounting estimates** - The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Risks and uncertainties** - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits - modified cash basis.

**Subsequent events** - The preparation of these financial statements includes the plan administrator's evaluation of the events and transactions occurring subsequent to December 31, 2024 through August 21, 2025, which is the date the financial statements were available to be issued.

**Key parties of the plan** - Ace Corporate Support, Inc. is the plan sponsor and plan administrator. Fidelity Management Trust Company is the trustee of the plan that holds custody of the plan's investment assets. Fidelity Workplace Services LLC is the record-keeper that maintains plan and participant records and tax counsel that performs various compliance tests. The two related entities are collectively referred to as "Fidelity". Spectrum Investment Advisors, Inc. is the plan's investment advisor.

Eligible participants of the following companies are included in the plan: Ace World Wide Holdings, Inc. and its wholly owned subsidiaries, Ace Relocation Services Joint Venture, AW2 Logistics, Inc., Ace Industrial Properties, Inc. and Ace Corporate Support, Inc.

**Investments** - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in fair value of investments bought, sold and held during the years is reflected in the statements of changes in net assets available for benefits - modified cash basis. Participants should refer to the prospectuses and annual reports of the investments for more information.

**Fair Value Measurements** - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows.

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

**Mutual funds** - Valued at the daily quoted market prices as reported by the fund. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

*Common/collective trusts* - The common/collective trusts held by the plan are direct filing entities valued at their NAV as certified by Fidelity. The NAV is used as a practical expedient to estimate fair value and is generally based on the fair value of the underlying investments held by common/collective trusts less their liabilities. This practical expedient would not be used if it is determined to be probable that the common/collective trusts would sell the investment for an amount different from the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as summarized below.

## 2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

**General** - The plan was adopted effective January 1, 1990 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

**Eligibility** - An employee is eligible for participation in the plan if they have reached twenty-one years of age and have completed two months of service. Effective December 21, 2023, the age requirement was reduced to eighteen. An employee is allowed to enter the plan on the first day of each month immediately following the employee meeting the eligibility requirements.

**Contributions** - Contributions to the plan can be made as follows:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. Effective January 1, 2024, new employees and eligible employees with no affirmative election were automatically enrolled in the plan and had 3% of compensation withheld as deferral contributions. Deferral percentages then automatically increase 1% each year up to a maximum of 12%. Such participants have the option to increase, decrease or stop the deferral by completing the necessary documentation.
- b. The individual employers may make matching contributions equal to a discretionary percentage of the elective deferral contributions, subject to certain limitations (matching contributions). The employer matching contribution percentage for all employers was equal to 50% of the first 5% of the employee compensation contributed to the plan as elective deferral contributions in 2024 and 2023.
- c. The individual employers may make nonelective discretionary contributions determined by the employers. Such contributions would be allocated to participants in the ratio that each participant's compensation bears to the compensation of all eligible participants. There were no nonelective discretionary contributions in 2024 or 2023.
- d. Participant rollover contributions are accepted by the plan from other qualified plans.

**Vesting** - Participants are always 100% vested in their elective deferral and rollover contributions and related earnings. Participants become 20% vested in their employer contributions and related earnings after completion of their second year of service. The participant's vesting then increases at the rate of 20% per year thereafter. Upon death, disability, or attainment of normal retirement age while employed, participants become 100% vested.

**Forfeitures** - Forfeitures may be used to pay administrative expenses or reduce employer contributions. Forfeitures used to reduce employer contributions totaled \$37,000 in 2024 and \$18,000 in 2023. Unapplied forfeitures were insignificant as of December 31, 2024. Unapplied forfeitures were \$9,000 as of December 31, 2023.

**Participant accounts** - Earnings, including the fair value appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of the employer contributions. Participants are allowed to transfer funds between the various investment options daily and change their deferral percentage each pay period.

**Benefits to participants** - Benefits are recorded when paid. Benefit payments may commence upon death, disability, retirement or termination of employment. Participants generally receive distributions of their accrued benefits in the form of lump sum payments. In-service distributions are permitted upon obtaining age 59½ and hardship withdrawals are also permitted under certain circumstances.

**Notes receivable from participants** - Participants may obtain a loan from their accounts with approval of the plan administrator. Each participant may only have one loan outstanding at any time. The minimum loan amount is \$1,000 and the total outstanding loan cannot exceed the lesser of 50% of the participant's vested account balance or \$50,000. The repayment term cannot exceed five years unless used to purchase a primary residence. As of December 31, 2024, loans outstanding had various repayment schedules through November 2029 with interest rates ranging from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balances plus any accrued but unpaid interest, which approximates fair value.

**Administrative expenses** - Certain administrative expenses of the plan are paid by the plan sponsor. Certain other administrative expenses are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for loan, distribution and personal planning and advice fees and nonparticipant directed charges for service and administrative fees. The nonparticipant directed charges are allocated to participants on an account value basis.

### **3. PARTY-IN-INTEREST TRANSACTIONS**

Fidelity is the trustee of the plan that holds custody of the plan's investment assets. Fidelity also manages certain of the plan's investment offerings and, as such, these investment transactions qualify as party-in-interest transactions. Fidelity also receives indirect compensation from mutual fund service providers for services Fidelity provides to the funds. The compensation received by Fidelity is used to offset amounts that would otherwise be owed by the plan to Fidelity for administrative services provided. Direct fees paid by the plan to Fidelity, recorded as a component of administrative expenses in the accompanying financial statements, were \$21,000 in 2024 and \$30,000 in 2023.

Activity related to notes receivable from participants also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### **4. TERMINATION OF PLAN**

Although they have not expressed any intent to do so, the employers have the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

### **5. INCOME TAX STATUS**

The plan adopted an FMR LLC pre-approved profit sharing plan. The pre-approved profit sharing plan received its most recent favorable opinion on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.
