### To the Plan Administrator of the Health Management Associates, Inc. Profit Sharing/401k Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Health Management Associates, Inc. Profit Sharing/401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements

---

### 1. Description of the Plan

The following description of the Health Management Associates, Inc. Profit Sharing/401k Plan (the Plan) provides only general information. Participants should refer to the Plan document, adoption agreement, and summary plan description for a more complete description of the Plan's provisions.

#### **General**

The Plan was created on January 1, 1999 and is a defined contribution plan covering all eligible employees of Health Management Associates, Inc. (the Company or Employer), who are not covered by another plan. To be eligible to participate in the Plan, employees must be at least 21 years old and has not been hired as an intern for a term less than one year or is an employee working less than 50% of full-time status. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Contributions to the Plan include: (i) salary reduction contributions authorized by participants, (ii) matching, profit-sharing, and safe harbor contributions made by the Employer, and (iii) participant rollovers from other plans.

Participants may elect to contribute a percentage of their eligible compensation, as defined by the Plan document, to the Plan each year, subject to the limitations of the Internal Revenue Code (IRC). Such contributions are excluded from the participant's taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan.

The Employer makes a matching contribution to each participant's account equal to 25% (not to exceed 1.5%) of participant contributions (up to 6% of compensation), up to the applicable statutory limits. The Employer also contributes a safe harbor contribution of 3% of eligible wages to all eligible employees. The Employer may also make discretionary non-elective contributions (profit-sharing). During 2024, the Employer did elect to make discretionary non-elective contributions.

Participants may also contribute to the Plan amounts representing distributions from other qualified defined benefit or defined contribution plans.

#### **Participant Accounts**

Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contributions and Employer matching contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants may direct the investment of their account balance into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### **Vesting**

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant whose employment commencement date was prior to January 1, 2022 became vested based on years of credited service, as follows:

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of the vested account balance or \$50,000. Participants are limited to one outstanding loan at any time. The loans are secured by an assignment of a participant’s vested interest in the Plan, and bear interest at a rate commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan Administrators. Principal and interest are paid ratably through payroll deductions or as a lump sum for the outstanding loan balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. As of December 31, 2024, participant loans had maturities through 2029 at interest rates ranging from 4.25% to 9.50%.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

***Administrative Expenses***

Plan administrative expenses may be charged directly to the Plan (either allocated to the participants or using forfeiture funds) or paid by the Employer. During the year ended December 31, 2024, the Plan paid \$103,281 of administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

***Forfeitures***

When certain terminations of participation in the Plan occur, the nonvested portion of the participant’s account represents a forfeiture. The Plan document permits the use of forfeitures to either reduce future Employer contributions or pay Plan administrative expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10 and \$42,606, respectively. During 2024, there were \$105,507 forfeited by participants, net investment gains on forfeitures totaled \$542, and employer contributions were reduced by \$137,451. Forfeitures were used to pay administrative expenses in 2024 of \$11,194.

***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

---

### ***Trustee Change***

Effective June 3, 2025, the Plan was amended and restated, and a new trustee and recordkeeper were appointed. Investment options offered at the new trustee T. Rowe Price Trust Company, were comparable to those offered by the previous trustee, Principal Trust Company.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### ***Risks and Uncertainties***

The Plan provides for investments in securities that are exposed to various risks, such as interest rate, currency exchange rate, credit, and the overall fluctuation in the market. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Investments in pooled separate accounts and the stable value fund, which is considered to be a collective investment trust, are stated at net asset value (NAV) per share as a practical expedient, which is based on the fair value of the underlying investments. Investments in mutual funds are stated at fair value based upon quoted market prices.

Net appreciation in fair value of investments includes realized and unrealized gains or losses on investments and is recognized in income currently. Amounts invested may earn interest and dividends, which in turn are reinvested. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions when the participant has a distributable event.

### ***Payment of Benefits***

Benefits are recorded when paid by the Plan.

### ***Subsequent Events***

The Plan has evaluated events and transactions for potential recognition or disclosure through September 18, 2025, which is the date these financial statements were available to be issued.

### 3. Fair Value Measurement

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Financial Accounting Standards Board established a framework for measuring fair value in the form of a fair value hierarchy, which prioritizes inputs into valuation techniques used to measure fair value into three broad levels. This hierarchy requires assets to be classified by level in their entirety based upon the lowest level of input that was significant to the fair value measurement. The three levels of the fair value hierarchy are as follows:

Level 1 – Quoted prices in active markets for identical assets or liabilities.

Level 2 – Observable inputs other than Level 1 including quoted prices for similar assets or liabilities, quoted prices in less active markets, or other observable inputs that can be corroborated by observable market data.

Level 3 – Unobservable inputs supported by little or no market activity for financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

#### **4. Guaranteed Investment Contract**

The Plan holds a traditional fully benefit responsive investment contract (FBRIC) with Principal. This contract meets the FBRIC criteria and therefore is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The traditional investment contract held by the Plan is a prospective interest crediting rate investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a semiannual basis for resetting and will never be less than the guaranteed minimum interest rate defined in the contract.

The Plan's ability to receive amounts due in accordance with FBRICs is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer or allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Additionally, the contract cannot be sold, transferred, or assigned externally, and carries a surrender charge of 5% or waiting period of 12 months in some circumstances. Other transaction restrictions may apply as specified in the contract.

#### **5. Exempt Party-In-Interest Transactions**

Certain Plan investments are managed by T. Rowe Price Trust Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, trustees of the Plan. These transactions qualify as exempt party-in-interest transactions. The notes receivable from participants are also exempt party-in-interest transactions.

#### **6. Federal Income Tax Status**

The Plan used a volume submitter prototype plan document sponsored by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company through June 3, 2024. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company received an opinion letter from the Internal Revenue Service (IRS), dated August 8, 2014, which states that the volume submitter prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Effective June 3, 2024, the Plan adopted a prototype plan document sponsored by T. Rowe Price Trust Company. T. Rowe Price Trust Company received an opinion letter from the IRS, dated August 19, 2020, which states that the submitter prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan Administrators have analyzed the tax positions of the Plan and concluded that as of December 31, 2024, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

## **7. Certification of Information Provided**

The Plan Administrators have elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under that election, the Plan Administrators instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by T. Rowe Price Trust Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, trustees of the Plan, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule:

- All investment assets held by the Plan
- Notes receivable from participants
- The recording of transactions related to all investment assets and notes receivable from participants, including related earnings (losses), interest and dividends.
