We have audited the financial statements of the Nalbach Companies ET. AL. Profit Sharing 401(k) Plan and Trust (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) for the year ended December 31, 2024, and we have issued our report thereon dated October 6, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by Voya Retirement Insurance and Annuity Company, the “qualified institution”, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America (“U.S. GAAP”). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated June 6, 2025. Professional standards also require that we communicate to you the following information related to our audit.

## **SIGNIFICANT AUDIT MATTERS**

### **Qualitative Aspects of Accounting Practices**

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management’s knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management’s assessment of the valuation inputs for each Plan investment under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, requires the Plan to assess and disclose in the financial statements the valuation input for each Plan investment. We evaluated the key factors and assumptions used to make the assessments for each Plan investment in determining it is reasonable in relation to the financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements were:

Disclosure in Note 3 regarding information certified by the qualified institution which the Plan's independent accountants did not perform auditing procedures, except for comparing such information to the related information included in the financial statements and supplemental schedule, Schedule of Assets (Held at End of Year).

The disclosure of fair value measurements in Note 4, which describes the valuation techniques used to measure each classification of the investments.

The disclosure of related party and party-in-interest transactions in Note 5, which describes the relationship between the Plan and its third party service providers.

The disclosure in Note 9 regarding non-exempt transactions resulting from the late remittance of participant contributions.

The financial statement disclosures are neutral, consistent, and clear.

**Form 5500 Procedures**

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

**Difficulties Encountered in Performing the Audit**

We encountered no significant difficulties in dealing with management in performing and completing our audit.

**Corrected and Uncorrected Misstatements**

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no corrected or uncorrected misstatements identified during the audit.

**Reportable Findings**

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable findings that are considered significant and relevant to those charged with governance but are not considered a deficiency in internal controls:

*Documentation of the Oversight Process* – To demonstrate the fulfillment of its fiduciary responsibilities, the Plan Administrative Committee should conduct regular meetings. The fiduciary guidelines of ERISA require the named fiduciaries of the Plan carry out due diligence in monitoring and administering Plan operations. While it is likely the operations of the Plan are being adequately managed and executed, without documented minutes of meetings held and decisions made, it would be difficult, if not impossible, to demonstrate management's due diligence in this area.

*Missing Personnel Files* – We noted during the audit of the Plan that employee personnel files could not be provided due to the Plan's retention policy. Improper record retention could lead to incorrect eligibility determinations or withdrawal calculations. We recommend the Plan enhance its controls over the retention of employee personnel files for all participants. The files should be retained in a secure location and filed centrally, if necessary. Additionally, we suggest that Plan management conduct audits of the employee personnel files throughout the year to ensure they have been retained and can be easily located.

### **Internal Control Communications**

In planning and performing our ERISA Section 103(a)(3)(C) audit we considered the Plan's system of internal control over financial reporting ("internal control") as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control, nor did we include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified.

However, as discussed below, we identified certain reportable findings that we consider to be significant deficiencies in internal controls.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis.

We consider the following reportable finding to be a significant deficiency in the Plan's internal controls:

*Late Remittances* – Department of Labor ("DOL") Regulation 2510.3-102 requires employers to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. Failure to remit participant contributions to the Plan in a timely manner results in prohibited transactions which must be separately reported to DOL and may result in lost earnings for the Plan and penalties to the Plan sponsor. During testing of timeliness of the remittance of participant contributions, we noted instances where participant contributions were remitted late to the Plan. We recognize Plan management worked with the third party administrator to calculate lost earnings on the late remittances and remitted lost earnings to the Plan to make affected participants whole. We recommend reviewing deferral contributions and reconciling the payroll reports to those deferral contribution remittances every payroll to ensure missed contributions can be corrected before they become late.

### **Disagreements with Management**

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

### **Management Representations**

We have requested certain representations from management that are included in the management representation letter dated October 6, 2025.

### **Management Consultations with Other Independent Accountants**

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

**Other Audit Findings or Issues**

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Nalbach Companies, et. al. Profit Sharing 401(k) Plan and Trust (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### Note 1—Description of the Plan

The following description of the Nalbach Companies, et. al. Profit Sharing 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution plan providing profit sharing and savings benefits to all employees, except union employees, of John Nalbach Engineering Co., Inc and related companies (by reason of common ownership) (collectively, the “Company”) as follows:

- Ability Metal Products, Inc.
- Chicago Metal Fabricators, Inc.
- Container Handling Solutions Corporation
- Ultra Specialties & Engineering, Inc.

Employees who have attained the age of 20½ and have completed six months of employment are eligible to participate in the Plan. Initial enrollment is available at the beginning of the quarter after reaching eligibility. Participants are not permitted to take loans on their account balance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan Trustees are responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings, and monitoring investment performance.

*Administration* – The Company has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

*Contributions* – Each year, participants may contribute a percentage of annual compensation, as defined in the Plan Agreement, on a pre-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company may make a discretionary profit-sharing contribution to the Plan. The profit-sharing contributions are determined at the discretion of the Board of Directors of the Company for each Plan year, out of current net profits or accumulated annual net profits from prior years. Participants must complete 1,000 hours of service and be employed on the last day of the Plan year to be eligible. In December 2024, the Board of Directors of the Company elected to make a discretionary profit sharing contribution to the Plan of 2.5% of each participant’s total eligible compensation for the year ended December 31, 2024. The Company made discretionary profit-sharing contributions of \$212,784 to the Plan for the year ended December 31, 2024.

Contributions are subject to certain limitations as outlined in the Internal Revenue Code (“IRC”).

*Participant Accounts* – Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions and Company contributions, and an allocation of Plan investment results. Participant accounts are charged with their withdrawals and an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, specific participant transactions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* – Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Company’s nonelective contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service, vesting 20% after two years of service, and 20% for each additional year after.

### Note 1—Description of the Plan (continued)

*Payment of Benefits* – Upon termination of service for any reason, a participant may elect to receive a lump sum, installment payments, or partial payments of amounts equal to the value of the participant's vested interest in his or her account. Employees with vested account balances less than \$5,000 as of termination will receive an involuntary distribution. Involuntary distributions of amounts over \$1,000 will be subject to the automatic rollover provisions and will be deposited into an individual retirement account. In-service distributions are also allowed for financial hardship, upon reaching the age of 59½, and for required minimum distributions at age 73.

*Forfeited Accounts* – The nonvested portion of former participants' accounts may be used to pay administrative expenses of the Plan or to reduce the amount of future employer contribution. Forfeited accounts approximated \$25,200 and \$58,900 at December 31, 2024 and 2023. During the Plan year ended December 31, 2024, approximately \$8,400 was used to pay administrative expenses and \$42,800 was used to reduce employer contributions.

*Unallocated Accounts* – At December 31, 2024 and 2023, unallocated accounts approximated \$2,300 and \$4,500, respectively. These amounts are the result of revenues received from mutual funds service providers. For the year ended December 31, 2024, approximately \$7,100 was used out of the unallocated accounts to pay Plan expenses.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan's investments are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* – Benefits are recorded when paid. There were no benefit payments requested and not yet disbursed at December 31, 2024 and 2023.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

### Note 3—Information certified by the qualified institution (unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, Voya Retirement Insurance and Annuity Company ("Voya"), a qualified institution, has certified that the following information included in the financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments at fair value as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest and dividends as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to the certified investment information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedule.

### Note 4—Fair value measurements

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Note 4—Fair value measurements (continued)**

The following are descriptions of the valuation methodologies used for assets measured at fair value. The 2023 investments have been reported differently than they were in the prior year to confirm with the December 31, 2024 presentation and to reflect a more current understanding of the investments. The change has no impact on the value of investments or net assets available for benefits in either period presented.

*Pooled Separate Accounts* – Valued at the net asset value (“NAV”) of units held by the Plan at year-end provided by the issuer of the account. NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying investment assets held through a separate account of an insurance company. This practical expedient is not used when it is determined to be probable that the accounts will sell the investment for an amount different than the reported NAV. The pooled separate accounts held by the Plan seek to provide a low-risk, stable investment option. They invest primarily in a diversified portfolio of high-quality, fixed income securities. Investments valued using NAV as a practical expedient are not reflected in the valuation hierarchy.

*Collective Trust Funds* – Valued at NAV of units held by the Plan at year-end provided by the issuer of the fund. NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV. The collective trust funds held by the Plan seek to preserve principal and maintain a stable crediting rate that is responsive to changes in interest rates. They invest primarily in a diversified portfolio of high-quality, fixed-income securities. Investments valued using NAV as a practical expedient are not reflected in the valuation hierarchy.

*Guaranteed Interest Account* – Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

**Note 5—Related party transactions and party-in-interest transactions**

Certain administrative services are provided by the Company at no cost to the Plan and certain administrative costs incurred by the Plan are paid by the Company. The Plan has entered into various service agreements with parties-in-interest. Fees are paid by the Plan to Voya, the Plan recordkeeper, for investment management, recordkeeping, and transaction processing services. In addition, UBS Financial Services provide investment advisory services to the Plan. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules of ERISA.

**Note 6—Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contributions allocated to their accounts.

**Note 7—Income tax status**

The Internal Revenue Service (“IRS”) ruled on June 30, 2020, that the pre-approved plan of Voya Retirement Insurance and Annuity Company of which the Plan is based, is designed in accordance with applicable sections of the IRC. The Plan has been amended since receipt of the opinion letter. However, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8—Risks and uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the financial statements.

**Note 9—Non-exempt transactions**

During the Plan year ended December 31, 2024, employee withholdings totaling \$16,090, were not remitted to the Plan within the appropriate time period by the Company. These transactions constitute prohibited transactions as defined by ERISA. The Company remitted the withholdings and lost earnings in 2024.
