NOTE 1 - PLAN DESCRIPTION

The following description of the Gerdau Macsteel Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which covers substantially all salaried and non-union hourly employees of Gerdau Macsteel, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Fidelity Management Trust Company ("Fidelity" or the "Trustee") is the Trustee of the Plan. The Gerdau Benefits Plans Administrative Committee (the "Committee") of the Plan, established by the Board of Directors of the Company, manages the operation and administration of the Plan and the Gerdau Macsteel Savings Plan for Bargaining Employees, a separate plan sponsored by the Company, and the Gerdau Macsteel Employees Master Trust ("Master Trust").

Contributions

Participants may elect to contribute up to 75% of their eligible compensation on either a pre-tax or after-tax basis, as defined by the Plan, subject to certain Internal Revenue Code ("IRC") limitations. Employees are automatically enrolled in the Plan at a contribution rate of 4% of their eligible compensation, unless they elect not to participate in the Plan or to contribute a higher or lower percentage of their eligible compensation. The Company contributes 100% of the first 6% of pre-tax eligible compensation that a participant contributes to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and Company matching contributions and Plan earnings. Participant accounts are charged with withdrawals and allocations of plan losses and expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings or losses thereon. Vesting in the Company's matching contributions for employees is 20% for each year of credited service and fully vests after five years. Upon death, retirement, or total and permanent disability, the participant or beneficiary becomes immediately fully vested in the Company's matching contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of the lesser of 50% of their vested account balances or \$50,000. The term of the loan may not exceed more than five years. The term for repayment of a home loan cannot exceed 15 years. Loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time funds are borrowed. Principal and interest are paid ratably through payroll deductions. Loan amounts not repaid by the participant upon termination shall be deemed distributed to the participant. Additionally, a participant may not have more than one loan outstanding at any given time.

Benefit Payments

Upon termination of service, death or disability, the participant may elect to receive a lump-sum amount equal to the amount of vested benefits in his or her account or annual installments. Terminated employees with an account balance of \$1,000 or less will automatically receive a lump-sum distribution.

Transfer of Assets

Certain employees participate in the Plan or other affiliated Gerdau Ameristeel US Inc. sponsored plans (the "Affiliate Plans"). Participation in the Plan or other Affiliate Plans is based upon the employee's job classification. Consequently, transfers of assets between the Plan and other Affiliate Plans occur as participants change job classifications. The assets are transferred at fair value. For the Plan year 2024, net transfers to the Plan from the Gerdau Macsteel Savings Plan for Bargaining Employees Plan amounted to \$148,974, and net transfers out of the Plan to the Gerdau Ameristeel US 401(k) Retirement Plan amounted to \$61,999.

Forfeited Accounts

Forfeitures of participants' account balances at termination may be used to pay Plan expenses or reduce future employer contributions. Matching contributions made as a result of the refunded pre-tax salary deferrals and matching contributions made on behalf of certain employees that exceed allowable limits may be forfeited. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2 and \$1,320, respectively. During the year ended December 31, 2024, Company contributions were reduced by \$457 from forfeited non-vested accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of Estimates

The preparation of financial statements in accordance with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment income includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Plan or by the Company, as provided in the Plan document. Plan recordkeeping and Trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Transactional fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Management fees and operating expenses charged to the Plan for investments in the mutual funds within the Master Trust are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan administrator determined that the certifications received from Fidelity meet the requirements of ERISA Section 103(a)(3)(C). Fidelity certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Plan interest in Master Trust and notes receivable from participants as shown in the statements of net assets available for benefits as December 31, 2024 and 2023.
- Plan interest in Master Trust investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - INTEREST IN MASTER TRUST

Use of the Master Trust permits the commingling of the assets of the Plan and the Gerdau Macsteel Savings Plan for Bargaining Employees (the "Participating Plans") for investment and administrative purposes. The assets of the Participating Plans are commingled in the Master Trust; however, the Trustee maintains supporting records for the purpose of allocating the net gain or loss of the investment account to the Participating Plans.

The Master Trust assets are invested and records are maintained by each investment option. Investments are allocated to the Participating Plans in accordance with the Plan provisions and participant allocation elections. The allocation of net assets is based on the respective number of units held by the plans' participants as of year-end. The allocation of the changes in net assets is calculated daily based on the units held by the plans' participants as of that day's end.

NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective trust fund - The fair values of participation units held in the collective trust are based on the net asset values ("NAVs") per unit as reported by the fund managers. The NAVs per unit are used as a practical expedient to estimate fair value. The collective trust provides for daily redemptions by the participants at reported NAVs per share, with no advance notice requirement. Plan level liquidations require notice to Fidelity and could result in the Plan's investment in the fund being placed into an investment only account for up to 12 months.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under the U.S. Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Notes receivable from participants also reflect party-in-interest transactions.

Certain Plan investments of the Master Trust and the Plan include a collective trust fund and shares of mutual funds that are managed by affiliates of Trustee. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for the investment management services were included as a reduction of return earned on each fund.

NOTE 7 - REVENUE SHARING ARRANGEMENT

The Trustee provides certain administrative services to the Plan pursuant to a Master Trust Agreement (“MTA”) between the Company and the Trustee. The Trustee receives revenue from mutual fund and collective trust fund service providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative services to the Plan.

For the year ended December 31, 2024, the Trustee made an annual payment of \$230,000, prorated across all plans in the Master Trust and the Gerdau Ameristeel Master Trust. The revenue credit was funded on a quarterly basis. Such amount may be applied to reimburse the Company for expenses paid on behalf of the Plan or to directly pay plan administrative expenses. Any amounts unused for expenses may be allocated to the accounts of the participants, provided that such allocation shall not occur more frequently than quarterly. The Plan or the Company may make a payment to the Trustee for administrative expenses not covered by revenue sharing. During the year ended December 31, 2024, revenue credit received by the Plan amounted to \$25,606 and administrative fees paid from the revenue credit account amounted to \$15,665. During 2023, the change in market value of the revenue credit account amounted to appreciation of \$302. As of December 31, 2024 and 2023, the balance in the revenue credit account amounted to \$10,381 and \$138, respectively.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in the Company's matching contributions of their account.

NOTE 9 - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated October 1, 2014 that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax- exempt as of the financial statement date.

US GAAP require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, credit risk, risks pertaining to a pandemic, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' account balances.
