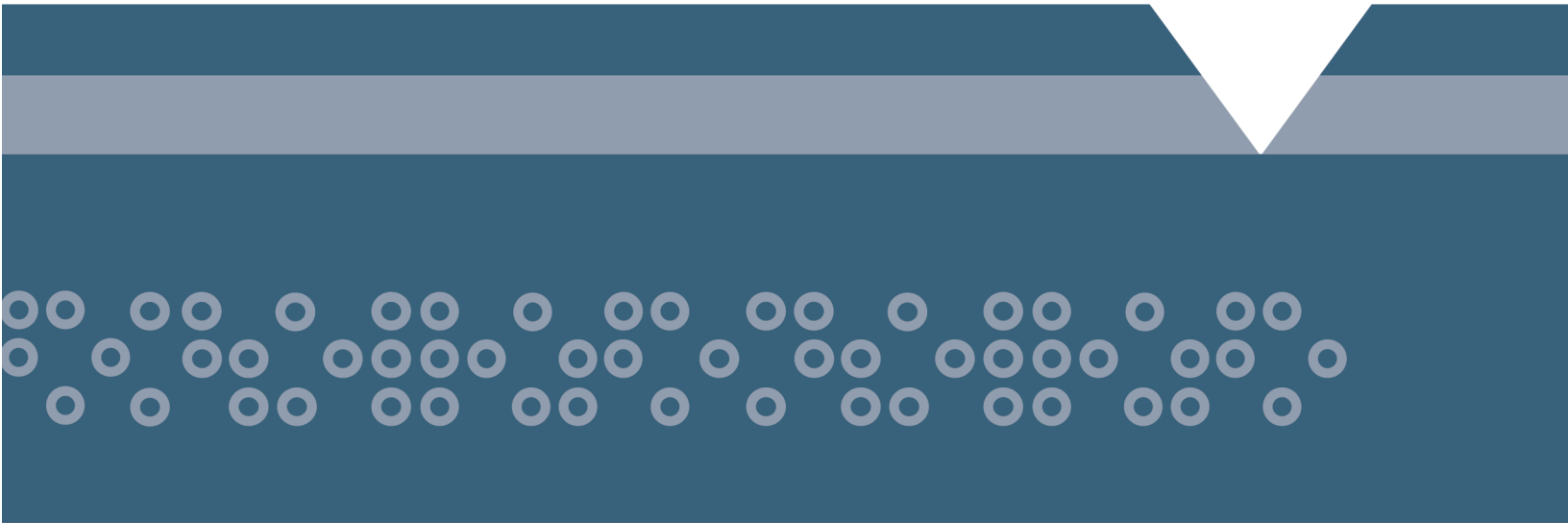

INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Highland Clinic, A.P.M.C. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 1. Description of Plan

The following description of The Highland Clinic, A.P.M.C. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) *General.* The Highland Clinic, A.P.M.C. 401(k) Profit Sharing Plan is a profit-sharing plan covering substantially all of the employees of Highland Clinic, A.P.M.C. Each employee hired is eligible to participate in the Plan upon reaching the age of twenty-one (21) years, and completion of one (1) year and 1,000 hours of service. The Plan provides for normal retirement, disability retirement and death benefits and is subject to the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

(b) *Contributions.* Participants may elect to contribute a percentage of their eligible compensation to the Plan on either a traditional (pre-tax) or roth (after-tax) basis, subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, as defined by the IRC. The Plan includes an automatic enrollment feature whereby all newly eligible employees are automatically enrolled in the Plan at a default pre-tax deferral rate of 3% of eligible compensation, unless the employee affirmatively elects a different percentage or opts out of participation. Contributions under the auto enrollment provision are invested in a designated default investment fund until changed by the participant and will automatically increase their deferral rate by 1% on the first day of each plan year up to a maximum of 10%. Participants may change their contribution percentage, investment elections, or opt out of the Plan at any time, subject to Plan provisions.

The employer may make matching and/or discretionary contributions based on the class of employee as defined in the Plan document. During 2024 and 2023, the plan elected to match 100% of the aggregate salary reduction made by the participant up to 6% of the participant compensation, except for the non-shareholder physicians which were capped at 2.5%. The employer also elected to make a non-elective contribution ranging from 3% to 7.33% that is allocated to participants on the class of employee. All contributions are subject to applicable Internal Revenue Code limits.

(c) *Participant Accounts.* Each participant's account is credited with (1) the participants' voluntary contributions, (2) the Company's contribution, (3) an allocation of the Plan earnings or losses, and (4) charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) *Vesting.* Participants are fully vested in their employee contributions plus actual earnings or losses thereon. A participant in the Plan whose employment terminates for any reason before his or her death, attainment of his or her normal retirement age or disability is entitled to receive the vested portion of his or her employer contribution account, adjusted for Plan earnings or losses thereon. If employment is terminated prior to reaching normal

retirement age, or for reasons other than death or disability, then vesting is based on years of service and is determined as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1 year but less than 2 years	0%
2 years but less than 3 years	20%
3 years but less than 4 years	40%
4 years but less than 5 years	60%
5 or more years	100%

- (e) **Payment of Benefits.** On termination of service, a participant will receive a distribution of his or her vested benefits as a lump-sum payment.
- (f) **Forfeitures.** Forfeitures of contributions are applied to reduce contributions and payment of plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,331 and \$58,050, respectively.
- (g) **Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participants vested balance. Loans generally have terms from one to ten years and are secured by the balance in the participant's account. The Plan Administrator will determine a reasonable interest rate by reviewing interest rates charged for similar types of loans by other lenders. Principal and interest is paid ratably through payroll deductions.
- (h) **Investment Options.** Participants are allowed to direct investment of their account balance among various investment pools based upon risk preferences. As of October 1, 2024, participants were also given the opportunity to invest in individual securities offered by the plan in lieu of a risk-based model.

2. Summary of Accounting Policies

- (a) **Basis of Accounting.** The financial statements of the Plan are presented on the accrual basis of accounting.
- (b) **Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires estimates and assumptions to be made that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.
- (c) **Investment Valuation and Income Recognition.** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's

investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

- (d) Administrative Expenses.** Certain administrative expenses were paid by the Plan, as permitted by the Plan document. All other administrative expenses were paid by the Company.
- (e) Payments of Benefits.** Benefits are recorded when paid.
- (f) Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

3. Information Certified by the Trustee

As permitted by Section 103(a)(3)(C) of the Employee Retirement Income Security Act of 1974 (ERISA) and in accordance with Department of Labor regulations, the Plan administrator obtained certifications from qualified institutions regarding the completeness and accuracy of certain investment information.

For the years ended December 31, 2024 and 2023, the Plan's investments and investment income were held and certified by two different qualified institutions as follows:

- For the period from January 1, 2023 to December 31, 2024, Regions Trust Company, a qualified institution as defined by ERISA, held the Plan's investments and provided a certification as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the investment information is complete and accurate.
- For the period from October 1, 2024 to December 31, 2024, Ascensus Trust Company and Newport Trust Company, LLC, also qualified institutions as defined by ERISA, held the Plan's investments and provided a certification as of December 31, 2024, and for the three month period ended December 31, 2024, stating that the investment information is complete and accurate.

The certifications from Regions Trust Company, Ascensus Trust Company and Newport Trust Company, LLC covered information included in the accompanying financial statements and supplemental schedules including (1) investments held as of the respective certification dates, (2) net appreciation (depreciation) in fair value of investments, (3) interest and dividend income, (4) Interest income on notes receivable from participants.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date. ASC 820 established a three-level fair value hierarchy that prioritizes the inputs used to measure fair value. This hierarchy requires entities to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of inputs used to measure fair value are as follows:

- Level 1 – Quoted prices in active markets for identical assets or liabilities.
- Level 2 – Observable inputs other than the quoted prices included in level 1, such as quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. This includes certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common Stocks: Valued at the closing price reported in the active market in which the individual securities are traded.

Mortgage-Backed Securities: Valued based on benchmark yields or other standard inputs from market maker sources.

Corporate Bonds: Valued at the closing price reported in the active market in which the bond is traded.

Mutual Funds: Valued at the daily closing price which is based on the net asset value (NAV) of shares held by the plan at year end.

Money Market Funds: Stated at fair value, which approximates cost.

U.S. Government Securities: Valued at the closing price reported in the active market in which individual securities are traded.

5. Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent (100%) vested in their accounts.

6. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated December 10, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. Related Party and Party in Interest Transactions

Certain Plan investments are shares of mutual funds managed by Regions Trust and Vanguard Investment. Regions Trust is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events were evaluated through October 7, 2025, which is the date the financial statements were available to be issued. The Plan was restated effective March 1, 2025 as a result in a change in recordkeepers and to add an auto-enrollment feature to the plan.
