Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **ProTrans International, LLC 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2, and

- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Notes to Financial Statements

1. Description of Plan

The following description of the ProTrans International, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 1995, covering employees of a controlled group, which includes ProTrans International, LLC; TOC Logistics International, LLC; and Millennial Transport Services, LLC (the Group or Plan Sponsor).

The Plan covers employees who have achieved three months of service and are age 21 or older. Employees are automatically enrolled to defer 3.0% of eligible compensation unless they elect to decline participation or elect to defer an amount other than 3.0% of eligible compensation. The Plan excludes collective bargaining union employees, non-resident aliens, and residents of Puerto Rico. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective April 5, 2024, the Plan adopted a Pre-Approved Defined Contribution Plan sponsored by Empower Retirement, LLC, the Plan's new recordkeeper. The Plan document changed the definition of compensation.

Effective January 1, 2025, the definition of compensation changed to include bonuses as eligible compensation and to increase the automatically enrolled deferral to 6.0% of eligible compensation unless they elect to decline participation or elect to defer an amount other than 6.0% of eligible compensation.

Contributions

Participants may contribute up to 90% of pretax annual compensation as defined by the Plan, up to the maximum allowable under the Internal Revenue Code (IRC). The Plan also allows after-tax (Roth) deferrals. Participant contributions are presented net of prior year excess contributions distributed (if any). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans in the form of rollovers.

The Group may elect to provide discretionary matching contributions each plan year. The extent and amount of each year's contributions, if any, is at the discretion of the Board of Directors. Employees become eligible for discretionary matching contributions upon entering the Plan. The Group made discretionary matching contributions of \$939,611 in 2024, which was equal to 50% of the employee deferrals up to 6% of the participants' eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Group's contributions, if any, Plan earnings or losses, and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct their investments into various options offered by the Plan. The Plan offers

25 mutual funds, two common/collective trust funds, and one stable value fund as investment options for participants.

Vesting

Participants are immediately vested in their contributions plus actual earnings or losses thereon. Vesting in the Group's contribution portion of their accounts is based on years of continuous service, as follows:

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest as specified in the Plan document, which was the prime rate at the beginning of the quarter the loan was originated. The interest rate on loans ranged from 3.25% to 8.50% at December 31, 2024. Loan repayments are made ratably through payroll deductions over a period not to exceed five years, unless the loans were used to purchase a primary residence, in which case, the loan may be repaid over a period not to exceed 30 years.

Payment of Benefits

On termination of service, death, disability, or retirement, a participant or beneficiary may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Partial distributions are also allowed. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Forfeitures

Forfeitures from non-vested participant accounts may be used to reduce future Group contributions or administrative expenses. Forfeitures of \$31,131 were used for administrative expenses in 2024. Forfeitures included in net assets were \$74,949 and \$30,174 at December 31, 2024 and 2023, respectively.

Administrative Expenses

Plan administrative fees, which include applicable recordkeeping and custodial services, are assessed on total plan assets, allocated pro-rata among the participant accounts on a quarterly basis at an annual rate of 0.55%. Distribution fees, loan initiation fees, and annual loan administration fees are charged directly to participants' accounts. Additionally, participants are charged monthly advisory fees based on a percentage of the fund balance at the end of each month, which reduces investment income.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (US GAAP). The presentation is permitted by the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Cash basis financial statements that adjust securities investments to fair value are considered to be prepared on a modified cash basis of accounting. Under the modified cash basis of accounting, certain revenue and related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred.

The principal items that would be required to be reflected in the financial statements by US GAAP (the amounts of which are not practicable to determine) are as follows:

- Accrual of all contributions owed at each year-end but not received until the following year.
- Accrual of dividends declared but not paid.
- Accrual of interest income from participant loans earned at each year-end but not received until the following year.
- Accrual of the Plan expenses and management fees incurred at year-end but not paid until the following year.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Notes Receivable from Participants

Participant loans are reported as notes receivable from participants and are measured at the unpaid principal balance. The Plan classifies all participant loans with no payments received for six months as in default. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits. During 2024 the Plan had deemed distributions of \$107,060 related to defaulted loans, which are included in benefits paid to participants and beneficiaries.

Fair Value Measurement

The Plan has determined the fair value of investments using a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV). The NAV is based on quoted prices in active markets. As a result, the fair value of the account is classified as Level 1.

Common/Collective Trusts: Valued at the NAV of units held by the Plan at year-end. The NAV, as provided by the custodian, is based on the fair value of the underlying investments held by the fund, less its liabilities, which are valued primarily through the use of directly or indirectly observable inputs. The NAV is used as the practical expedient to estimate fair value. Common/collective trusts are valued at fair value unless they are fully benefit-responsive contracts, in which case they are valued at contract value.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no Level 2 or Level 3 assets at December 31, 2024 or 2023.

Risks and Uncertainties

The Plan provides investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities may occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

The Plan had a concentration in individual investment funds greater than 10% in four funds of \$13,505,075 and \$12,776,456 at December 31, 2024 and 2023, respectively.

Excess Contributions

Amounts paid to participants for contributions in excess of amounts allowed by the IRS are recorded as a reduction to contributions when paid. The Plan distributed the 2023 excess contributions of \$26,074, net of earnings, in March 2024. There were no excess contributions in 2024.

Payment of Benefits

Benefits are recorded when paid.

3. Information Prepared and Certified by the Plan's Custodian/Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA as of December 31, 2024 and 2023, and for the year ended December 31, 2024. Accordingly, the following investment information included in the accompanying financial statements and supplemental schedules as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was obtained and derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan's custodian and trustee, Empower Trust Company, LLC (Empower) as of December 31, 2024, and the period April 5, 2024 to December 31, 2024, and Charles Schwab Trust Bank as of December 31, 2023 and the period January 1, 2024 to April 4, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

4. Investments, at Contract Value – Stable Value Fund

The Plan maintains a fully benefit-responsive insurance contract account. This account meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value is guaranteed for participant transactions by the full faith and credit of Standard Insurance Company, and it represents contributions made, less withdrawals and administrative expenses, plus accrued interest. Net deposits become part of Standard Insurance Company's general account, and there are no particular segregated or identifiable assets ascribed to the Plan's investment. Net deposits and interest credited become liabilities against Standard Insurance Company on the Plan's behalf. Daily liquidity is available for participant contributions and withdrawals at contract value, regardless of market conditions.

Liquidation of the entire contract may cause a one-time adjustment to the aggregate contract value, resulting from a fair value different from the contract value. This total liquidation is a contingent event, which cannot be initiated by the Plan participants and can be initiated only by the Plan trustees upon termination of the Plan or the entire contract. As of December 31, 2024, the liquidation of the entire contract was not considered probable.

5. Related-party Transactions and Party-in-interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. These transactions qualify as party-in-interest transactions. The Plan allows participants to obtain loans from the Plan, which are also considered party-in-interest transactions. Fees paid by the Plan for administrative services were \$126,911 for the year ended December 31, 2024. Additional investment fees paid to the custodian are netted against investment returns. These party-in-interest transactions are not prohibited under ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Group has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the accounts, and the balance of the net assets of the Plan would be allocated among the participants and beneficiaries as prescribed by ERISA.

7. Tax Status

The Plan has adopted a Non-Standardized Prototype Plan Document sponsored by Empower that obtained a favorable opinion letter on November 14, 2022, in which the Internal Revenue Service stated that the Prototype Plan Document, as then designed, was in compliance with the applicable requirements of the IRC and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the opinion letter. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore, no provision for income taxes is included in the Plan's financial statements.

The Plan reviews its tax positions for uncertainty and records a provision for tax positions, which may not be sustained based on their technical merits if examined by taxing authorities. At December 31, 2024 and 2023, there were no matters requiring a provision for uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Subsequent Events

Subsequent events were evaluated through October 7, 2025, the date the financial statements were available to be issued. Except as disclosed at Note 1, no other items were noted requiring disclosure or adjustment.
