Note 1 – Description of the Plan

General

The following description of the New York Stem Cell Foundation 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The Plan is a qualified 403(b) plan covering all eligible employees of the New York Stem Cell Foundation (the “Foundation”). All employees of the Foundation are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Foundation is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, monitors investment performance and ensures compliance with the Plan document.

Contributions

Each year, participants may make pre-tax elective and Roth contributions to the Plan subject to certain Internal Revenue Code (“IRC”) limitations. The Foundation may contribute a discretionary match, after a participant’s completion of 90 days of employment, and a nonelective contribution to the Plan. As of December 31, 2024, contributions receivable from the Foundation and participants in the Plan totaled \$43,528.

Participants may also contribute rollover amounts representing distributions from another qualified retirement plan.

Participant accounts

Each participant’s account is credited with the participant’s contribution and an allocation of the Foundation’s contributions and investment earnings, net of administrative expenses. Allocations are based on participant earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment options

Each participant may direct the investment of his/her account into certain available investment options. The assets of the Plan are allocated to the applicable funds at the direction of the participants.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the Foundation’s matching and nonelective discretionary contributions portion of their accounts plus actual earnings thereon.

Note 1 – Description of Plan (continued)

Forfeitures

The Plan had no forfeiture balances as of December 31, 2024 and December 31, 2023.

Payment of benefits

Upon termination of service, retirement, death, or total permanent disability, a participant or their beneficiary may elect to receive a distribution of his or her entire accumulated Plan balance. Distribution options include a single lump-sum payment or installments. In addition, participants may elect in-service withdrawals of their elective deferral account balances after reaching age 59-1/2. Participants may also elect in-service withdrawals of their elective deferral account balances in the case of a financial hardship or should they incur a disability. Minimum required distributions are required for participants who have reached the age established by the Internal Revenue Service (“IRS”).

Notes receivable from participants

Under the terms of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lower of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at rates equal to the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions or payment by check over no longer than a five-year period. The five-year period may be extended to a longer term if the participant is borrowing to purchase a principal residence. Participants are limited to two outstanding loans at a time. As of December 31, 2024, interest rates on the outstanding notes receivable from participants range from 4.50% to 9.50% and the outstanding notes receivable from participants totaled \$71,258. No allowance for credit losses has been recorded as of December 31, 2024 and December 31, 2023.

Note 2 – Summary of significant accounting policies

Basis of accounting

The Plan’s financial statements are prepared using the accrual basis of accounting, except for benefits paid which are recorded on a cash basis.

Investment valuations and income recognition

The Plan’s investments are stated at fair value, or contract value for fully benefit-responsive investment contracts.

Realized and unrealized gains (losses) and interest and dividend income from the assets in each account are credited to or charged against each participant’s account. Purchases and sales of securities are recorded on a trade date basis.

Investment valuations and income recognition (continued)

The aggregate of (a) the net unrealized appreciation (depreciation) in the fair value of investments for the year, and (b) the net gains or losses on disposition of investments during the year is reflected as net appreciation in the fair value of investments for the year.

Management fees and operating expenses charged to the Plan for investments are deducted from individual investments and are not reflected separately. Consequently, management fees and operating expenses are reflected as a reduction of return for such investments.

Fair value measurements

For assets measured at fair value on a recurring basis, accounting standards require quantitative disclosures about the fair value measurement separately for each major class of assets. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are as follows:

Level 1 – Unadjusted quoted prices in active markets for identical assets.

Level 2 – Quoted prices for identical assets in markets that are not active, quoted prices for similar assets in active markets, inputs other than quoted market prices, and inputs derived principally from observable market data.

Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used as of December 31, 2024.

Mutual funds

Mutual funds are valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Contributions

Contributions from participants are recorded as they are withheld from the participants' wages. Contributions from the Foundation are recorded as earned.

Payment of benefits

Benefit payments to participants or their beneficiaries are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and December 31, 2023.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Foundation. Expenses that are paid by the Foundation are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses.

Certain administrative functions are performed by employees of the Foundation. No such employee receives compensation from the Plan.

Risks and uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, credit and liquidity risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits as of December 31, 2024. The Plan's investments are not insured or protected by the Pension Benefit Guaranty Corporation, or any other governmental agency, accordingly, the Plan is subject to the normal investment risks associated with investments. Any defaults on notes receivable from participants are treated as taxable distributions to the participants.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from these estimates.

Subsequent events

The Plan has evaluated events and transactions for potential recognition or disclosure through September 26, 2025, which is the date the financial statements were available to be issued.

Note 3 – Investments, at contract value

The Plan holds an investment contract that is comprised of an insurance company general account. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Note 4 – Information certified by the Plan’s Custodians

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide Trust Company and Nationwide Life Insurance Company, the Custodians of the Plan, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and December 31, 2023 and the Supplemental Schedule H – Part IV– Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024; and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Note 5– Party-in-interest transactions

Plan investments are managed by Nationwide Trust Company and Nationwide Life Insurance Company, the Custodians as defined by the Plan, and, therefore, those transactions qualify as party-in-interest.

Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Foundation. These transactions also qualify as a party-in-interest transactions.

Note 6 – Plan termination

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to discontinue and terminate the Plan at any time, subject to the provisions of ERISA.

Note 7 – Tax status

The Internal Revenue Service has determined and informed the Plan that the Plan is designed, in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.
