1. DESCRIPTION OF PLAN

The following description of the Solomon Realty Advisors, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 2007, and most recently restated effective January 1, 2022, is a defined contribution plan covering all eligible employees of Solomon Realty Advisors, Inc. (the “Company”), excluding union employees, leased employees, and non-resident aliens. Effective November 1, 2022, seasonal and temporary employees are also excluded. Employees who have attained 21 years of age are eligible to make elective deferrals into the Plan. Employees can enter the Plan and begin making deferrals immediately upon satisfying the eligibility requirements. Employees who are 21 years of age and have completed 1 year of service are eligible to receive employer matching contributions and profit sharing contributions. The entry date for purposes of matching contributions and profit sharing contributions is the first day of each calendar month coincident with or next following the date all eligibility criteria have been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

The Plan allows for pre-tax and Roth salary deferrals. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Rollover contributions are subject to the terms of the Plan and are fully vested and non-forfeitable. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment feature under which newly eligible employees are automatically enrolled in the Plan 30 days after satisfying the eligibility requirements unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set to make pre-tax contributions to the Plan at a rate of 3% of compensation, as defined, and their accounts under the Plan are automatically invested in the Plan's Qualified Default Investment Alternative (“QDIA”), unless the employee elects otherwise. The Plan has elected the Principal LifeTime Hybrid Collective Investment Fund series as its QDIA. The Plan also includes an automatic escalation feature whereby the deferral rate of automatically enrolled participants will increase annually on January 1st by 1% up to a maximum of 6%, unless the employee elects otherwise.

The Company makes matching contributions equal to 50% of a participant's elective deferrals, capped at 6% of compensation, as defined. For the year ended December 31, 2024, the Company made \$661,703 of matching contributions to the Plan. The Company, at its discretion, may make profit sharing contributions to the Plan. The Company did not make any

profit sharing contributions to the Plan during the year ended December 31, 2024. Contributions are subject to certain statutory limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as an allocation of Company profit sharing contributions, if any, plus Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution and profit sharing contribution portions of their accounts is based on years of continuous service as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1% above the prime rate, as defined. The interest rate on outstanding loans at December 31, 2024 ranged from 4.25% to 9.50% per annum. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants are also entitled to receive in-service withdrawals upon attainment of age 59 ½ or as a hardship distribution, as defined in the Plan document.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$53 and \$2,845, respectively. These accounts may be used to reduce employer contributions or pay Plan expenses. During the year ended December 31, 2024, the Plan used \$94,441 in forfeitures to pay administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent

participant loans are recorded as distributions based on the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding deduction to contributions. At December 31, 2024 and 2023, excess contribution payable were \$16,486 and \$13,221. The amounts due at December 31, 2024 were distributed to the applicable participants before March 15th of the subsequent year. The amounts due at December 31, 2023 were distributed to the applicable participants after March 15th of the subsequent year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

3. CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments at fair value, investments at contract value, and notes receivable from participants held at December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company (“Principal Life”, certifying on behalf of itself and Principal Global Investors Trust Company), the trustee and insurance company of the Plan, respectively.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts

Collective Investment Trusts ("CITs") are not publicly quoted and are priced at net asset value ("NAV"). ASC 820 allows NAV per share to serve as a practical expedient to estimate fair value.

Pooled Separate Accounts

Pooled Separate Accounts ("PSAs") are not publicly quoted and are priced at NAV. ASC 820 allows NAV per share to serve as a practical expedient to estimate fair value.

The following tables set forth, by level within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is

5. GUARANTEED INVESTMENT CONTRACT WITH PRINCIPAL LIFE INSURANCE COMPANY

The Plan entered into a fully benefit-responsive guaranteed investment contract with Principal Life. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$99,629 and \$35,890, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1% or greater than 3%. Such interest rates are reviewed on a semi-annual basis for resetting.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with Principal Life. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (e) premature termination of the contract. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a breach of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The Plan Sponsor may terminate the agreement prior to the scheduled maturity date based on the terms detailed in the agreement.

6. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Principal Life is the recordkeeper of the Plan and therefore certain transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, administrative fees of approximately \$139,000 were paid to Principal Life.

Orenda Retirement, LLC ("Orenda") is the third party administrator of the Plan and therefore certain transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, administrative fees of approximately \$24,500 were paid to Orenda.

Participant contributions not transmitted by the Company within the time period set forth in the Department of Labor's regulation CFR 2510.3-102 are considered nonexempt prohibited transactions under ERISA. Participant contributions remitted during the year that constitute nonexempt prohibited transactions are reported by the Plan in the accompanying supplemental schedule as required.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

8. TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that other than the operational errors described in Note 10, the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

10. OPERATIONAL ERRORS

The Company has discovered that certain of the Plan’s provisions were not properly applied in the daily operation of the Plan during plan years 2018 through 2021. The definition of compensation for participant and employer contributions as per the executed Plan document was not properly applied when calculating contribution amounts. Certain eligibility provisions of the Plan document were not consistently applied and during 2021 certain participant’s matching contributions were overfunded or underfunded. During 2025, the Plan Sponsor made a voluntary submission to the IRS’ Voluntary Correction Program (“VCP”), outlining the foregoing operational issues and proposed resolution and corrective action, which in part, includes a retroactive amendment to the Plan’s eligibility provisions for affected participants and the Plan’s definition of compensation, and a reallocation of matching contributions to ensure each Plan participant received the correct amount of matching contribution under the Plan. The Plan sponsor is currently awaiting a response and intends to make the Plan whole for any amounts due, including lost earnings, once a response to the VCP application is received. These amounts are not material to the Plan’s financial statements. In the opinion of Plan management, these corrections would be accepted by the IRS upon examination.
