Note 1 - Plan Description

The following description of TreeHouse Private Brands, Inc. Retirement Income Savings Plan for Union Employees (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering certain hourly union employees of TreeHouse Private Brands, Inc. (the "Company"). Employees become participants in the Plan following completion of the eligibility requirements described in the Plan and applicable supplements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible employees may elect to make employee deferral contributions and/or Roth contributions based on provisions and limitations set forth in the applicable supplement for each participating union subject to certain Internal Revenue Service (IRS) limitations. The maximum employee deferral percentage of annual compensation varies by supplement with a maximum of 50 percent. Participants who have attained age 50 may make catch-up contributions in addition to their regular deferral contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

If provided in the applicable supplement, the Plan provides for employer matching contributions ranging from 10 percent up to 100 percent of the participant's deferral contribution, not in excess of a percentage of the participant's eligible compensation ranging from 3 percent to 6 percent.

The Company also makes employer nonmatching contributions to certain participants in an amount required by the terms of the specific collective bargaining agreement or applicable supplement to the plan agreement on behalf of participants who are in such collective bargaining unit. For the year ended December 31, 2024, the Company made \$875,824 of nonmatching contributions.

Vesting

Participants are immediately 100 percent vested in employee salary, rollover contributions, and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service defined below:

Less than 1	- %
1, but less than 2	20
2, but less than 3	40

4, but less than 5	80
5 or more	100

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their vested account balances, not to exceed \$50,000, reduced by the highest outstanding balance of notes receivable during the one-year period prior to the date the note receivable is made from the Plan. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate. Repayment terms in general may not exceed five years except for the purchase of a principal residence.

Participant Accounts and Investment Options

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation, deferrals, transactions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Plan Transfers

The Company also sponsors other qualified plans. If employees change their positions or locations within the Company's organization, their account balances are transferred into the corresponding plan. Transfers in and out are shown in the statement of changes in net assets available for benefits.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of lump-sum amounts or various installment annuities equal to the value of the vested balance of a participant's account. The Plan also allows for withdrawals at age 59½.

Hardship Withdrawals

Participants may request that a portion of their accounts, as permitted by the Plan, be distributed in the case of severe financial hardship, as defined in the plan document.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. The money market fund investment is valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Plan and the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 6, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Empower Trust Company, LLC (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee, except for the participant notes receivable balances as of December 31, 2024. Because of the change in custodian described in Note 6, a transfer was executed on December 31, 2024, and no assets are reported in the Schedule of Assets Held at End of Year.

Note 4 - Tax Status

The Plan has received a determination letter dated January 26, 2018 from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Accordingly, no provision for income taxes has been made in the accompanying financial statements. Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

There are no plan assets measured at fair value on a recurring basis as of December 31, 2024. The following table presents information about the Plan's assets measured at fair value on a recurring basis at December 31, 2023:
