## Independent Auditor's Report

To the Plan Administrator and Participants of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Moss Bros. Auto Group, Inc. 401(k) Profit-Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**NOTE 1 - SUMMARY OF THE PLAN**

**Plan Description**

The following description of the Moss Bros. Auto Group, Inc. 401(k) Profit-Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan was effective on January 1, 1999 and qualifies as a defined contribution retirement plan for Moss Bros., Inc., J.A. Moss, Inc., Moss Bros. CJD, Inc., Moss Bros. Honda, Inc., Moss Bros. Toyota, Inc., Moss Bros. Chevrolet, Inc., Moss Bros. Buick-GMC, Inc., Moss Bros. Auto Group, Inc., and MVP Cars, Inc. and Moss Bros. German, Inc. (collectively, the “Company”). This Plan was established for the purpose of providing retirement benefits to eligible employees in accordance with the Plan. The Plan is intended to satisfy the provisions of Section 401(a) of the Internal Revenue Code (“IRC”) of 1986, as amended. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Administration**

The Plan is administered by the Company. Charles Schwab Bank (“Charles Schwab”) is the custodian of the Plan effective October 4, 2017.

**Participant Eligibility**

Each of the Company’s employees is eligible to participate in the Plan if they have completed one year of service and attained age 21. Once the eligibility requirements have been met, employees are automatically enrolled on the first day of the first month after their one-year anniversary. If they choose to opt out of automatic enrollment, they can choose to start contributing to the plan at any time subsequent to that. The Plan provides for discretionary matching contributions. In order to be eligible for the discretionary employer contributions the employee must have completed one year of service (1,000 hours) and must be employed on the last day of the year.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. A participant directs the investment of the contributions to his or her account in any of the investment options offered by the Plan.

**CARES Act Amendments**

In March 2020, the Coronavirus Aid, Relief, and Economic Security Act (the "CARES Act") became law. The CARES Act, among other things, includes several relief provisions available to tax-qualified retirement plans and their participants. During 2020, the Plan adopted the following provisions to the Plan for qualified individuals, those who themselves or whose spouse/dependent was diagnosed with COVID-19 or experienced adverse financial consequences due to COVID-19:

- In-service withdrawals of up to \$100,000 of vested balance available through December 31, 2020, after first taking all available loans from the Plan.
- A temporary additional loan and relaxation of current requirements for loans taken through September 22, 2020, based on the lesser of 50% of the vested account balance or \$50,000.
- A temporary allowance for employees to defer loan repayments through December 31, 2020 for one year.

Plan management intends to formally amend the Plan regarding the above provisions by the required deadline of December 31, 2026. If the Plan is not formally amended for the above provisions, it will not be in compliance with the IRC.

**Contributions**

Eligible participants may contribute up to the IRC limit, which was \$23,000 for 2024. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 5% of their eligible compensation and their contributions are invested in a designated balanced fund until it is changed by the participants. All participants who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions up to the IRC limit, which was \$7,500 for 2024.

The Company may make a discretionary matching contribution allocated to eligible participants based on a discretionary percentage allocated proportionate to each participants contributions or levels of deferrals or flat dollar amount allocated on a uniform basis to all participants, as determined by the Company. The Company may also make a discretionary profit-sharing contribution to eligible employees. Effective April 5, 2017, the Company's matching contribution was suspended. For the year ended December 31, 2024, the Company did not make any matching contributions. For the year ended December 31, 2024, the Company did not make discretionary profit-sharing contributions.

**Vesting**

Participants are immediately one hundred percent (100%) vested in their contributions plus actual earnings thereon. Participants vest in matching contributions and profit-sharing contributions, and earnings thereon, as follows:

Years of Service	Vested Interest (%)
Less than two years of service	0
After two but less than three years of service	20
After three but less than four years of service	40
After four but less than five years of service	60
After five but less than six years of service	80
After six years of service or more	100

**Forfeitures**

Amounts forfeited from terminated participants' non-vested portion of their Company matching contributions, Company discretionary profit-sharing contribution and earnings thereon, are used first to reduce administrative expenses, then to reduce matching and discretionary profit-sharing contributions. At December 31, 2024 and 2023, forfeited non-vested balances included in the Plan's assets totaled \$1,604 and \$591, respectively.

During the year ended December 31, 2024, none of forfeited non-vested accounts were used to pay Plan expenses.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or periodic installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. The notes are repaid through payroll deductions over a period of five years or longer if the loan is used to acquire a principal residence. Interest rates on notes outstanding at December 31, 2024 were between 4.50% and 9.50%.

**Non-Discrimination for Employee and Employer Contributions**

The Plan, as required by the IRC, performs annual non-discrimination tests to ensure that highly compensated participants are not disproportionately favored under the Plan. If the Plan fails the tests, it is required to take corrective action and either refund excess deferral contributions to highly compensated employees or make a Qualified Non-Elective Contribution (QNEC) for benefit of the non-highly compensated employees. Any refundable excess contributions are accrued as a liability on the statement of net assets available for benefits and any QNEC contributions are accrued as a receivable. For 2024 and 2023 Plan years, the Plan passed all of its non-discrimination testing without having to take any corrective action.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America (“US GAAP”).

**Accounting Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held at year-end.

**Administrative Expenses**

Certain administrative expenses related to operating and maintaining the Plan are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements.

**Payment of Benefits**

Benefits are recorded when paid.

**NOTE 3 - INFORMATION CERTIFIED BY THE PLAN CUSTODIAN**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As a result, all information related to investments and notes receivable from participants held at December 31, 2024 and 2023, presented or disclosed in the accompanying financial statements and supplemental schedule, and net appreciation in fair value of investments, interest and dividends, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Charles Schwab, the custodian of the Plan during 2024 and 2023.

**NOTE 4 - INCOME TAX STATUS**

The Internal Revenue Service issued a favorable opinion in a letter dated June 30, 2020 that stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has since been amended and restated. The Plan sponsor and Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent (100%) vested in their accounts.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.<sup>1</sup>

Certain plan investments are shares of mutual funds and funds held in the are managed by Charles Schwab. Charles Schwab is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the earnings on each fund.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - SUBSEQUENT EVENTS**

The Plan has evaluated and determined that no other events have occurred subsequent to the date of the statement of net assets available for benefits through October 7, 2025, the date which the financial statements were available to be issued, which require recording or disclosure in these financial statements.
