Independent Auditor's Report

To the Plan Administrator
AW Industries Temporary Disability Benefits Plan

Opinion

We have audited the accompanying financial statements of AW Industries Temporary Disability Benefits Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits - cash basis of AW Industries Temporary Disability Benefits Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits - cash basis for the years then ended, in accordance with the cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of AW Industries Temporary Disability Benefits Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 2; this includes determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Independent Auditors' Report (Continued)

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of AW Industries Temporary Disability Benefits Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about AW Industries Temporary Disability Benefits Plan's ability to continue as a going concern for a reasonable period of time.

Note 1: Description of Plan

The following description of AW Industries Temporary Disability Benefits Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a short-term disability benefit plan established by AW Industries, Inc. (the Company) as of January 1, 1982 and most recently amended effective October 1, 2022. Participation in the Plan is completely voluntary. The Plan covers all employees who have completed one of two eligibility periods, as applicable. The general eligibility period is 60 days of active service for any employee. Plan entry dates for eligible employees are the first of the month following eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Periodically, as determined by the Company, the Company will deduct from each participant's earnings an amount equal to the periodic cost of the annual premium that would be required for each participant if the Plan benefits were insured by an insurance company. The Company may, at its discretion, make additional contributions to provide benefits to eligible participants. The Company did not make any additional contributions during the years ended December 31, 2024 and 2023.

Payment of Benefits: A participant who suffers a non-occupational disease or injury is paid a weekly benefit of 60% of the participant's average weekly earnings, up to a maximum weekly amount, for a period of up to 26 weeks during any one period of disability, as defined in the Plan. The maximum weekly benefit amount was \$400 as of December 31, 2024 and 2023.

Expenses: Administrative expenses are paid by the Plan or the Company. Administrative expenses paid by the Company are excluded from these financial statements.

Note 2: Summary of Significant Accounting Policies

The following is a description of the significant accounting and reporting policies of the Plan:

Basis of Accounting: The accompanying financial statements have been prepared on the cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under the cash basis, contributions are recognized when received rather than when due from the Plan Sponsor or participants, and disability benefits and expenses are recognized when paid rather than when the obligation is incurred. The cash basis differs from accounting principles generally accepted in the United States of America primarily because the effects of contributions receivable and disability benefits and expenses payable are not reflected in the accompanying financial statements.

Participant Contributions: Contributions from participants are recorded in the period received by the Plan.

Payment of Benefits: Benefits are recorded when paid to participants.

Subsequent Events: In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 6, 2025, the date the financial statements were available to be issued. During the period from January 1, 2025 through October 6, 2025, the Plan did not have any material recognizable subsequent events.

Note 3: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all valid claims prior to termination will be paid, and any remaining funds will be used to continue Plan benefits to the extent possible.

Note 4: Income Tax Status

The Company believes that the Plan is designed and currently operating in compliance with the applicable requirements of the Internal Revenue Code. The Plan's federal information returns are subject to examination by the Internal Revenue Service (IRS) generally for a period of three years after the returns are filed.

The Company is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Company does not believe that the Plan has any uncertain tax positions. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 5: Reconciliation of Financial Statements to Form 5500

The financial statements of the Plan for the years ended December 31, 2024 and 2023 did not differ from the amounts reported on Schedule H (Financial Information) of Form 5500 (Annual Return/Report of Employee Benefit Plan).

Note 6: Parties-in-Interest

Certain officers and employees of the Plan sponsor are administrators of the Plan acting as fiduciaries and are also participants in the Plan.

Note 7: Uninsured Balances

The Plan maintains cash balances in one financial institution. Periodically during the year, the cash balances may exceed federally insured limits. The Plan has not experienced any losses in such accounts and believes it is not exposed to significant risk on cash balances.
