December 31, 2024 and 2023

(1) Description of Plan:

The following brief description of the Morcon, Inc 401(k) Profit Sharing Plan & Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan was established by Morcon, Inc (the “Company”) on January 1, 2014 as a defined contribution retirement plan covering substantially all employees of the Company. The Plan is subject to the provisions of ERISA.

The Plan was amended and restated effective April 1, 2022 for the Cycle 3 restatement and other legislative and regulatory changes.

The Plan was amended effective February 1, 2024 to convert to the Fidelity Basic Plan Document and its Adoption Agreement. There were no changes to any of the Plan criteria or eligibility.

Eligibility – Generally, employees of the Company are eligible to participate in the Plan upon attaining the age of 18 after completing two months of service.

Contributions – Eligible employees may contribute between 0% and 90% of their annual eligible compensation on a pre-tax basis and after-tax (Roth) basis, or a combination of both, as defined by the Plan, subject to Internal Revenue Service limitations. Participants who are age 50 or older may elect to defer additional amounts called “catch-up” contributions. Rollover and transfer contributions from another qualified retirement plan or special individual retirement plan are permitted. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers an interest-bearing cash fund, mutual funds, and common collective trusts as investment options for the participants. The Company will make safe harbor matching contributions equal to 100% of the first 3% and 50% of the next 2% of the eligible participants’ compensation contributed to the Plan. The Company, at its discretion, may also make non-elective profit sharing contributions as defined in the Plan document. The Company made matching contributions of \$153,367 and \$171,955 in 2024 and 2023, respectively. The Company did not make a profit sharing contribution in 2024 or 2023.

Automatic Enrollment – The Plan provides for automatic enrollment into the Plan upon an employee’s eligibility date. Unless the employee elects otherwise, 3% of eligible compensation will automatically be deferred into the Plan on a pre-tax basis into a default investment fund selected by the Company. The Company will match the automatic deferrals as provided under the Plan’s safe harbor and safe harbor matching contribution provisions.

Participant Accounts – Accounts are participant directed. Account balances are tracked in units, and the value is updated with the daily market price. As of any business day, accounts are charged or credited with earnings (dividends, capital gains, expenses and market fluctuations) as well as account activity such as contributions, loans, distributions or hardships.

Vesting – Participants are immediately vested in their voluntary contributions and employer matching contributions, including earnings or losses thereon. Vesting in the Company’s profit sharing contribution portion of their account is based on years of service. Using a graded vesting schedule, a participant becomes 100 percent vested after six years of service.

(1) Description of Plan, continued:

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000, (b) 95% of one-half the vested balance or (c) 95% of the total vested account balance excluding Roth elective deferral balance. Participants may have no more than two loans outstanding at a time. Loan terms range from 1-5 years. The loans are collateralized by no more than 50% of the vested balance in the participant's account and bear interest at the prime rate as published by the Wall Street Journal plus 2%. The interest rates ranged from 5.25% to 10.50% for the years ended December 31, 2024 and 2023. Principal and interest are paid ratably through weekly payroll deductions.

Withdrawal Privileges – Prior to termination, a participant may withdraw all or any portion of their vested account, including earnings on elective deferrals, in the event of undue financial hardship. The participant's request for a withdrawal shall include their statement and documentation proving that such a hardship exists and explains its nature. To qualify as a financial hardship withdrawal, it must be determined that the withdrawal is to meet an immediate and financial need of the participant, and the amount of the withdrawal is not reasonably available from other sources of the participant. Hardship withdrawals are limited to the following: financial needs arising on account of a college education, purchase of a principal residence, major medical expenses, prevention of eviction or foreclosure, burial or funeral expenses, and damage to a principal residence due to fire, storm or other casualty. The Plan Administrator has established uniform, nondiscriminatory guidelines to use in determining if such a condition of undue financial hardship exists. The Plan Administrator's determination shall be final. The participant has no legal or equitable right to such a withdrawal unless the immediate and financial need as defined has been demonstrated.

Withdrawal Provisions – The Plan also provides for in-service distributions for participants that have attained age 59 ½. Such participants will be entitled to receive a distribution of all or a portion of their vested contributions.

Payment of Benefits – Upon termination of service, disability, death or retirement, participants may elect to receive a lump sum distribution, partial payments, or installments equal to the value of their accounts. The participants may also elect to roll over the funds into an IRA or to another employer's tax qualified plan. If the participant's account balance exceeds \$5,000 (excluding any rollover contributions plus earnings) he or she may also elect to receive installments or defer receiving payments until age 70 ½. If the participant's account balance is between \$1,000 and \$5,000 and they do not elect to receive a lump-sum or a direct rollover, the balance will automatically be rolled over into an IRA established by an IRA provider selected by the Company. If the participant's account balance is \$1,000 or less and they do not elect to receive a lump sum or a direct rollover, the balances will automatically be cashed out in the form of a lump-sum.

Administrative Services – The Plan states that costs incurred in administering the Plan may be paid by the Company, but if not paid by the Company when due, the costs shall be paid from the assets of the Plan. Administrative fees for loan and distribution processing are charged to the participant. The administrative fees paid from the assets of the Plan amounted to \$20,958 and \$11,832 in 2024 and 2023, respectively.

Forfeitures – Forfeitures of participants' non-vested account balances shall become available for payment of employer contributions.

(2) Summary of Significant Accounting Policies:

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with generally accepted accounting principles.

Investments held by a defined contribution plan are required to be reported at fair value, except for common collective trusts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to common collective trusts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Notes Receivable from Participants – Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Use of Estimates – The preparation of the Plan’s financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the date of the financial statements and the changes in net assets available for plan benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for plan benefits.

Investment Valuation and Income Recognition – Investments are reported at fair value, except for common collective trust funds, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 – Fair Value Measurements below for discussion of fair value. Notes receivable from participants are valued at cost, which approximates fair value.

Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned. Security transactions are recorded on a trade-date basis. Gains or losses on sales of securities are based on average cost.

The Plan presents in the statement of changes in net assets available for plan benefits the net appreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Benefit Payment Recognition – Benefits are recorded when paid.

Date of Management Review – Subsequent events were evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

(3) Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in inactive markets;
- c. Inputs other than quoted prices that are observable for the asset or liability;
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

(5) Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all amounts credited to the accounts of the participants shall vest and become non-forfeitable. The employer shall direct the Trustee to make or commence distribution to, or on behalf of, each participant the value of his or her account balance in the Plan.

(6) Tax Status:

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

(7) Related-Party and Party-In-Interest Transactions:

Plan investments are managed by Fidelity Management Trust Company, the Trustee of the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. Notes receivable from participants totaling \$69,205 and \$66,135 at December 31, 2024 and 2023, respectively, also qualify as party-in-interest transactions.
