## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the  
ENGIE 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the ENGIE 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (collectively, the financial statements).

Plan management (Management), having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1: DESCRIPTION OF THE PLAN**

The following description of the ENGIE 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). With the exception of certain union employees, nonresident aliens, inpatriates (other than an inpatriate employee who is subject to local employment terms and conditions), and leased employees, the Plan covers substantially all employees of ENGIE Holdings Inc. (the "Company"). There are no age or service requirements.

The Company acts as the Plan administrator and is responsible for the Plan. Empower Trust Company, LLC (the "Empower" or "Trustee") is the trustee of the assets of the Plan, and Empower Retirement serves as the record keeper of the Plan, maintaining individual accounts for each participant.

The Company acquired Broad Reach Power during 2024. The participants' balances of the Broad Reach Power 401(k) Plan were transferred into the Engie 401(k) Plan. The Plan was amended effective April 1, 2024, related to this merger.

***Contributions***

Participants may contribute up to 100% of their eligible compensation, as defined in the Plan.

The Company contributes 100% of each participant's elective deferrals made that do not exceed 3% of employee eligible compensation plus 50% of salary deferrals between 3% and 5% of employee eligible compensation. In addition, the Company makes a discretionary quarterly profit-sharing contribution equal to 1.5% of employee compensation. No Profit Sharing was made during 2024. The Plan is a safe harbor plan.

***Participant Accounts***

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution, and allocations of Company discretionary profit-sharing contributions and Plan earnings and charged with withdrawals and allocation of Plan losses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

If not previously enrolled, all new employees are automatically enrolled into the Plan sixty days after the employee's initial hire date. Absent an election by the employee to the contrary, 3% is automatically withheld from his/her compensation and deposited in the Plan as an employee contribution. This amount will increase by 1% each year until it reaches a maximum of 10% of participants' before-tax eligible compensation. If the employee does not select an investment option, the contributions will be invested in the Vanguard Target Retirement Fund that most closely matches the employee's target retirement year but may be subsequently redirected by the employee at any time. Investments are

participant directed; therefore, each employee is responsible for directing investments relating to his/her account.

***Vesting***

All participant and employer contributions and earnings thereon vest immediately. Upon termination of service, retirement, death, disability, or termination of the Plan, the participant may receive a lump-sum amount equal to his/her account balance.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer between the investment fund and the loan fund. Loan terms range from one to five years, or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate, as defined in the Plan document, plus 1% of interest on the date of the loan. Principal and interest are paid ratably through payroll deductions.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

***Risk and Uncertainties***

The Plan utilizes various investment instruments, including mutual funds and a common collective trust fund that is considered to be a stable value fund. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds and stable value fund are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

***Benefit Payments***

Benefits are recorded upon distribution. On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's account.

**NOTE 3: FAIR VALUE MEASUREMENTS**

ASC 820, Fair Value Measurement, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows:

- Level 1 – which refers to securities valued using unadjusted quoted prices from active markets for identical assets;
- Level 2 – which refers to securities not traded on an active market but for which observable market inputs are readily available; and
- Level 3 – which refers to securities valued based on significant unobservable inputs.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust fund (Putnam Stable Value Fund):* The Putnam Stable Value Fund (the "Fund") is a common collective trust fund sponsored by Putnam Fiduciary Trust Company. The Fund is stated at fair value as determined by the issuer of the common collective trust based on the net asset value as a practical expedient of the underlying investments.

Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4: INFORMATION CERTIFIED BY THE TRUSTEE**

Certain information in the accompanying financial statements and Schedule of Assets (Held at End of Year) related to investments and notes receivable from participants held as of December 31, 2024 and 2023, as well as net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was certified as complete and accurate by the Plan’s Trustee. This certification was provided in accordance with 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Management obtained this information and agreed to or derived it from the information certified by the Trustee.

**NOTE 5: EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Transactions with the Trustee and the funds they manage qualify as party-in-interest transactions. Investment management fees and operating fees paid by the Plan were included as a reduction of the return earned on each fund. Additionally, participant loans qualified as exempt party-in-interest transactions.

During 2024, Empower Retirement, the Plan’s record keeper, paid the Plan directly \$99,976 in unused expense credits which were payable to the Plan. This amount is netted against administrative expenses in the Statements of Changes in Net Assets Available for Benefits.

**NOTE 6: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 7: TAX STATUS**

The Plan uses a prototype plan document sponsored by Empower. Empower received an opinion letter from the Internal Revenue Service (IRS), dated November 14, 2022, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the plan's administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax position taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the taxing jurisdictions.

**NOTE 8: SUBSEQUENT EVENTS**

For the year ended December 31, 2024, subsequent events were evaluated through September 23, 2025, the date the financial statements were available to be issued. Effective June 12, 2025, ENGIE Holdings, Inc. sold ENGIE Services U.S., Inc., which was a participating employer as of December 31, 2024.
