## REPORT OF INDEPENDENT AUDITORS

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of EXCO Resources, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## 1. DESCRIPTION OF THE PLAN

### Plan Description

The EXCO Resources, Inc. 401(k) Plan (the "Plan") is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan was established on January 1, 1999 and restated on April 1, 2022. The Plan is sponsored by EXCO Resources, Inc. (the "Company" or "Plan Sponsor"). Empower Annuity Insurance Company along with Empower Trust Company, LLC were the Trustee and Custodian (collectively the "Trustees" or "Empower") of the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

On December 31, 2024, the Plan's assets were liquidated according the Sponsor's plan for transition to a new record keeper and trustee. January 1, 2025, Fidelity Workplace Services LLC began serving as record keeper for the Plan and Fidelity Management Trust Company began serving as Trustee of the Plan's assets.

### Participant Accounts and Eligibility

Employees become eligible for participation at the age of 18 and upon completing 30 days of eligible service, as defined by the Plan document. Subject to certain limitations on annual contributions, each participant's account is credited with employee salary deferrals, Company matching and discretionary contributions, if any, and an allocation of Plan earnings and administrative expenses related to loan and distribution fees, if applicable.

### Contributions

Each year, a participant may elect to contribute up to 50% of his or her pretax compensation, subject to certain maximum limitations imposed by the Internal Revenue Code ("IRC") (\$23,000 for the calendar year ended December 31, 2024 and \$22,500 for the calendar year ended December 31, 2023). Employees who are eligible to make elective deferrals under the Plan and who have attained the age of 50 before the close of the plan year are also eligible to make catch-up contributions subject to the maximum limitation imposed by the IRC (\$7,500 for the calendar years ended December 31, 2024 and 2023). Rollover contributions representing distributions from other qualified defined benefit or contribution plans are permitted and may be made prior to meeting the eligibility requirements for participation in the Plan.

The Plan Sponsor matched 100% of employee contributions up to a maximum of 6% of each employee's pay for the calendar year ended December 31, 2024 and 5% for the calendar year ended December 31, 2023.

Employees are automatically enrolled in the Plan with a contribution of 3% of compensation, unless otherwise directed. Additionally, unless the participant specifically elects otherwise, the automatic deferrals will be increased by 1% of compensation each year of the anniversary of enrollment date, to a maximum deferral rate of 6%. Automatic enrollment deferrals are defaulted into a moderate risk tolerance fund based on the participant's age.

### Vesting

Participants vest in their Company matching contributions, if any, plus actual earnings thereon based on the following schedule:

One-year anniversary of hire .....	25 %
Two-year anniversary of hire .....	50 %
Three-year anniversary of hire .....	75 %
Four-year anniversary of hire .....	100 %

### Notes Receivable from Participants

Participants can borrow from their fund accounts, with a minimum loan amount of \$1,000 and a maximum limit of 50% of their vested account balance, subject to an overall cap \$50,000. The term of any loan may not exceed five years, unless the loan is for the purpose of acquiring or constructing the participant's primary residence, in which case the loan term may extend up to 10 years. Loans to participants are secured by the balance in the participant's account and accrue interest at the prime rate, as of the loan origination date, plus 1.00%, in accordance with the Participant Loan Policy. Repayments are made via payroll deduction and are reinvested into the participant's account based on their individual investment elections.

As of December 31, 2024 and 2023, maturity dates on existing notes receivable from participants ranged from July 2025 through February 2034 and had interest rates between 4.25% and 9.50%.

*Loan Policy Update — Effective January 1, 2015*

As of January 1, 2015, new loans are permitted only in the event of a safe harbor hardship. Eligible hardship circumstances include:

- Uninsured medical expenses incurred by the participant, their spouse, or dependents;
- Costs associated with the purchase or construction (excluding mortgage payments) of the participant's principal residence;
- Post-secondary tuition expenses for the participant, their spouse, or dependents;
- Prevention of eviction from the participant's primary residence or foreclosure on the mortgage of their principal residence;
- Funeral or burial expenses for the participant's deceased parent, spouse, children, or dependents;
- Expenses for repairs to the participant's principal residence that qualify for a casualty loss deduction.

Additionally, participants are limited to one outstanding loan from the Plan at any given time.

*Hardship Withdrawal Provision — Effective January 1, 2019*

Effective January 1, 2019, the Plan's hardship withdrawal provisions were updated in alignment with the Bipartisan Budget Act. The changes include:

- The requirement for participants to take a loan before requesting a hardship withdrawal has been removed;
- Participant deferral contributions will no longer be suspended following a hardship withdrawal;
- Earnings on elective deferral contributions in a participant's account will now be included as part of a hardship withdrawal.

Moreover, the scope of qualifying financial needs has been expanded to encompass specific disaster-related events and casualty losses not associated with disasters.

### **Investment Options**

The Plan provides for contributions to be invested by the Trustees amongst a variety of mutual fund options, a pooled separate account, a guaranteed income fund, and a common collective trust, in accordance with participant investment elections and the provisions of the trust agreement.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, the net assets of the Plan would be distributed among the participants in accordance with ERISA.

### Benefit Payments

Participants withdrawing amounts from their account during the year for reasons of disability, retirement, death (withdrawn by participant's estate), or termination are entitled to their vested account balance. For vested account balances greater than \$5,000, participants may elect a distribution in the form of rollovers, lump sums, installment payments, or partial withdrawals. Upon termination, vested account balances less than \$5,000 may be automatically distributed to the applicable terminated participant. In-service distributions are permitted for participants who have either reached age 59 1/2 or who qualify for a hardship distribution.

### Forfeitures

The Plan allows for the forfeited balances of terminated participants' non-vested accounts to be utilized to reduce employer contributions or pay Plan expenses. At December 31, 2024 and 2023, unallocated forfeiture balances were \$14,282 and \$2,326, respectively.

### Administrative Expenses

Employees of the Company perform certain administrative functions with no compensation from the Plan. Other administrative expenses are paid by the Plan, including investment expenses relating to the purchase or sale of directed investment options, which are paid for directly by participant accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The financial statements of the Plan are presented on the accrual basis in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect certain reported amounts of assets and liabilities, changes therein, and associated disclosures. Accordingly, actual results may vary from the estimates used in preparing the accompanying financial statements.

### Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value (except for fully benefit-responsive investment contracts, which are recorded at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see "Note 3 - Fair Value Measurements".) Contract value is the relevant measure attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See "Note 4 - Benefit-Responsive Contracts" for discussion of the fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net realized gains or losses on investments are the difference between the proceeds received upon the sale of investments and the fair market value of investments as of the end of the preceding year or the average cost of those assets if acquired during the current year. Unrealized appreciation or depreciation of investments represents the increase or decrease in fair market value during the year.

### Payment of Benefits

Benefits are recorded when paid.

### Risks and Uncertainties

These investments are subject to market or credit risks customarily associated with debt and equity investments. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as investment expenses when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document; accordingly, no allowance for credit losses is necessary.

### 3. FAIR VALUE MEASUREMENTS

The Plan discloses fair value measurements in accordance with FASB Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements and Disclosures*, which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability ("exit price") in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

EXCO categorizes the inputs used in measuring fair value into a three-tier fair value hierarchy. These tiers include:

- Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2* Observable inputs other than quoted prices within *Level 1* for similar assets and liabilities. These include quoted prices in markets that are not active or other inputs that are observable or can be corroborated by observable market data. If the asset or liability has a specified or contractual term, the input must be observable for substantially the full term of the asset or liability.
- Level 3* Inputs to the valuation methodology that are supported by little or no market activity, generally requiring development of fair value assumptions by management.

The asset or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

In establishing a fair value hierarchy for the Plan's investments, in accordance with FASB ASC Topic 820, the following value methodologies were used for each type of investment:

*Mutual funds of registered investment companies and the pooled separate account:* Valued at the daily closing prices as reported by the fund. Daily closing prices are based on the net asset value ("NAV") of the fund.

*Common collective trusts:* Valued using the NAV computed daily closing prices each day by the trustee of the fund. The NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying assets owned by the fund, then divided by the number of shares outstanding.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. The Plan has no assets classified within Level 3 of the valuation hierarchy.

At the close of business on December 31, 2024, the plan liquidated its mutual fund and pooled separate account holdings. The cash presented on the statement of net assets represents the liquidation proceeds that were transferred to the Plan's new trustee, Fidelity Management Trust Company, on January 2, 2025.

#### 4. Benefit-Responsive Contracts

During 2024 and 2023, the Plan invested in a Guaranteed Income Fund ("GIF") with the Trustees. The GIF is a fully benefit-responsive contract and is valued at contract value. Accordingly, the contract meets all of the following criteria:

- The investment contract is affected directly between the GIF and the issuer and prohibits the GIF from assigning or selling the contract or its proceeds to another party without the consent of the issuer.
- The contract issuer is obligated to (i) repay principal and interest, or (ii) prospective crediting rate adjustments with an assurance the crediting rate will not be less than zero.
- The terms of the contract require all permitted participant-initiated transactions with the GIF to occur at contract value with no conditions, limits, or restrictions. Permitted participant-initiated transactions are those transactions allowed by the underlying defined-contribution plan, such as withdrawals for benefits, loans, or transfers to other funds within the Plan.
- An event that limits the ability of the GIF to transact at contract value with the issuer (for example, premature termination of the contracts by the GIF, plant closings, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives) and that also limits the ability of the GIF to transact at contract value with the participants in the GIF must be probable of not occurring.
- The GIF itself must allow participants reasonable access to their funds.

Contract value is the relevant measure attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The concept of a value other than contract value does not apply to this contract even upon a discontinuance in which case contract value would be paid no later than 90 days from the date the sponsor provides notice to discontinue. The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed for a specified period of time as outlined in the group annuity contract. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

There are no events that limit the ability of the Plan to transact at contract value with the issuer. There are also no events and circumstances that would allow the issuer to terminate the fully benefit-responsive investment contract with the Plan and settle at an amount different from contract value.

#### 5. INFORMATION CERTIFIED BY THE TRUSTEES

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustees.

#### 6. TAX STATUS

The Company has adopted the Empower Annuity Insurance Company of America Prototype Non-Standardized Profit Sharing Plan, which is approved by the Internal Revenue Service ("IRS") for use by employers as a qualified plan. The Plan is qualified under Section 401(a) of the IRC and is exempt from federal income taxation. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Company believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan continues to be qualified and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor ("DOL") or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 7. TRANSACTIONS WITH PARTIES IN INTEREST

The Plan investments also include shares of mutual funds, a pooled separate account, and a guaranteed income fund managed by Empower. Empower acted in its capacity as a Trustee to the Plan during the years ended December 31, 2024 and 2023; therefore, these investments qualify as party-in-interest investments, but are exempt from the prohibited transaction rules. Additionally, the Plan holds notes receivable from participants which constitute party-in-interest transactions, and which are also exempt.

## 8. SUBSEQUENT EVENTS

In accordance with FASB ASC 855, "Subsequent Events," the Company has evaluated events of transactions occurring after December 31, 2024, the Statement of Net Assets Available for Benefits date, through October 6, 2025, the date the financial statements were issued.

Effective January 1, 2025, Fidelity Workplace Services LLC began serving as record keeper for the Plan and Fidelity Management Trust Company began serving as Trustee.

Effective January 1, 2025, the Plan was amended and restated through the adoption of a pre-approved plan document. There were no significant changes in the plan provisions.
