Management's estimates are based on an independent appraisal and management's projections. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

### Note 1 - Plan Description

The following description of Catamount Constructors, Inc. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan established on January 1, 2017. The Plan is available to eligible employees of Catamount Constructors, Inc. (Catamount or the "Company") age 21 or older who have completed 1,000 hours of service in a consecutive 12-month period, excluding employees covered under a collective bargaining agreement, nonresident aliens, independent contractors, and leased employees. Employees are entered into the Plan on January 1 or July 1 coincident with or immediately following completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan operates as a leveraged employee stock ownership plan with a cash or deferred arrangement, as described by Internal Revenue Code Section 401(k), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (the "Code") of 1986, as amended.

#### **General**

In 2017, the Plan purchased 1,000,000 shares of Catamount's common stock using the proceeds of a note totaling \$26,000,000. The note is guaranteed by the Company and the shares held in a trust established under the Plan. The borrowings are to be repaid over a period of 30 years by Catamount's contributions to the Plan. The balance of the note is to be repaid in annual installments of approximately \$1,242,000, which includes 2.6 percent interest, and the note matures in December 2047. As the Plan makes each payment of principal and interest, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the Internal Revenue Code.

The Company has no rights against shares once they are allocated to participants. Accordingly, within the financial statements of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024, the assets and liabilities and changes therein pertaining to the accounts of employees with vested rights in allocated stock (allocated) and stock not yet allocated to employees (unallocated) are shown separately.

The board of directors of the Company appoints the plan trustee, GreatBanc Trust Company (the "Trustee"), to oversee the Plan and approves changes to the plan document. Principal Life Insurance Company (Principal) is the third-party administrator of the Plan. The administrative committee oversees the maintenance of the Plan's records.

#### **Contributions**

The Company is required to make cash contributions to the Plan that, when aggregated with the Plan's dividends and interest earnings, equal or exceed the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan to the Company.

The Company may also elect to make discretionary contributions to eligible participants who are employed on the last day of the plan year or retire, pass away, or become disabled during the plan year, as determined on a yearly basis by the Company. The discretionary contribution is determined and funded on an annual basis directly to the Plan.

**Note 1 - Plan Description (Continued)**

***Participant Accounts***

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

***Vesting***

Any company contributions (including forfeitures) and the earnings or losses thereon not fully vested when contributed will vest 20 percent after one year of service and another 20 percent per year thereafter until they become fully vested after five years of service.

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (65) while an employee, retirement due to disability, or termination of the Plan.

For each five years of service completed prior to January 1, 2017, a participant will be credited with one year of service for the purpose of vesting. Employees who were hired between January 1, 2017 and December 31, 2017 and remained on December 31, 2017 were credited with one year of service for the purpose of vesting, regardless of such employee's hours of service.

***Benefit Payments***

Upon death, disability, retirement, or termination of service, each participant's account balance will be distributable. The amount to be distributed is based upon the immediately preceding valuation date. The Plan allows for terminated participants' vested account balances of \$1,000 or less to be automatically rolled out and balances of \$1,000 to \$7,000 to be automatically distributed out of the Plan into an IRA. Eligible participants with vested balances in excess of \$7,000 will receive their distribution in the form of cash or shares of company stock. If employees are given company stock, the Company must immediately repurchase the company stock for the fair value of the stock. As of December 31, 2024, no participants had requested a distribution that had not been paid out by the trust as of that date. Vested balances of terminated participants as of December 31, 2024 totaled approximately \$6,865,770.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. The Company allocates forfeitures in accordance with plan provisions. The amount to be forfeited will be deducted from the participant's Catamount stock balance.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances. Upon such termination of the Plan, under the direction of the plan trustee, all liabilities and expenses of the Plan shall be paid through share sales to the extent it determines such sales to be necessary in order to repay the loan.

**Note 1 - Plan Description (Continued)**

***Diversification***

Participants who have attained the age of 55 and have completed at least 10 years of participation in the Plan are eligible to receive up to 25 percent of the value of the participant's account, less any prior diversification distributions for a 5-year period. At the end of the fifth year after the participant becomes eligible for diversification distributions, participants are eligible to receive up to 50 percent of the value of the participant's account, less any prior diversification distributions.

***Voting Rights***

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account. The Trustee is required to vote shares of common stock that have been allocated to participants but for which the Trustee received no voting instructions in the same manner and in the same proportion as the shares for which the Trustee received timely voting instructions.

***Party-in-interest Transactions***

The Plan's investment in common stock of the Company, financial obligations to the Company, and interest expense paid to the Company qualify as party-in-interest transactions; however, these transactions are exempt from prohibited transaction rules.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Benefit Payments***

Benefits are recorded when paid or in process of liquidation of underlying stock based on the request for distribution.

***Dividends***

Dividends, if and when declared by the Company, are allocated to participants based on the number of company shares each participant has in his or her account at the last day of the plan year prior to the dividend being declared.

***Put Option***

Under federal income tax regulations, if common stock that is held by the Plan and its participants is not readily tradable on an established market or is subject to trading limitations, it is subject to a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. The most significant assumptions and estimates relate to the valuation of company common stock. Application of these assumptions requires the exercise of judgment as to future uncertainties, and, as a result, actual results could differ from those estimates.

***Risks and Uncertainties***

Investment in company common stock is exposed to various risks, such as interest rate, market, and credit risks, that are concentrated specific to the Company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Administrative Expenses***

The Plan's assets, which principally consist of Catamount common stock, are held by the plan trustee. Catamount contributions are managed by the plan trustee, which makes distributions to participants. The plan administrator administers the payment of interest and principal on the note payable.

Certain administrative functions are performed by officers or employees of Catamount. No such officers or employees receive compensation from the Plan. Administrative and plan trustee fees are paid by Catamount.

***Subsequent Events***

Effective January 1, 2025, the Plan was amended to modify the eligibility requirements so that employees become eligible after completing 60 days of service and are age 21 or older.

The financial statements and related disclosures include evaluation of events up through and including September 30, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Investments in Common Stock**

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Note 4 - Fair Value Measurements (Continued)**

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using the discounted cash flow method, guideline public company method, and merger and acquisition method. The discounted cash flow method utilized expected future cash flows, coupled with a terminal value calculation, and discounted these to present value using a weighted-average cost of capital to determine fair value. The guideline public company method and merger and acquisition method are market-based methodologies based on the pricing multiples observed for comparable companies that were sold or are publicly traded to determine fair value, with a minor discount for lack of marketability.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

***Common Stock***

Fair value of the Company's stock is determined by an annual independent appraisal. All company common stock is valued based on Level 3 inputs. There were no purchases, issuances, or transfers of company stock for the year ended December 31, 2024.

***Interest-bearing Cash***

Fair value of the interest-bearing cash is based on Level 2 inputs, as the investment is not traded on an active market and is based upon the cash held in the account as of each year end.

**Note 5 - Tax Status**

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**Note 6 - Notes Payable - Employer**

The Plan has a note payable to the Company. The proceeds of the loan were used to purchase 1,000,000 shares of company common stock. The note was guaranteed by the Company and the shares held in a trust established under the Plan. The borrowings are to be repaid over a period of 30 years by Catamount's contributions to the Plan. The balance of the note is to be repaid in annual installments of approximately \$1,242,000, which includes 2.6 percent interest, and the note matures in December 2047.
