Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ensinger, Inc. Profit Sharing and 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedules of Schedule H, line 4a – Schedule of Delinquent Participant Contributions and Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

NOTE 1 PLAN DESCRIPTION

The following description of Ensinger, Inc. Profit Sharing and 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General

The Plan, established February 1, 1989, is a defined contribution savings plan established by Ensinger, Inc. (Ensinger) for substantially all employees of Ensinger, with the exception of employees covered under a collective bargaining agreement. Participation in the Plan is voluntary. Any eligible employee who has completed two months of service shall be eligible to participate in the Plan for purposes of deferring wages and to receive employer discretionary and matching contributions.

The Plan excludes leased employees, temporary employees until he or she has completed one year of service, employees of affiliated employers, and employees not considered common law employees. Employees who became employees as a result of asset or stock acquisitions, mergers or similar transactions will not be eligible employees until the expiration of the transition period from the date of the transaction to the last day of the plan year beginning after the transaction.

The plan administrator controls and manages the operation and administration of the Plan. The plan administrator has all powers necessary to carry out the provisions of the Plan and to satisfy the requirements of any applicable laws.

Contributions

An eligible employee may become a participant in the Plan by completing an enrollment form whereby the employee agrees to accept a specified reduction in salary/wage for each pay period in consideration of Ensinger contributing such amount to the Plan. Participants may elect to contribute a percentage of their compensation up to the limitations as defined by the Internal Revenue Code (IRC) to the Plan each year. Regular 401(k) contributions are excluded from the participant's taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. Roth 401(k) contributions are after tax and their earnings are not subject to federal income tax when withdrawn. A participant may increase or decrease the amount of the salary/wage reduction upon notice to the employer. If a participant terminates his/her election for reasons other than hardship, the participant must wait 30 days to make another elective deferral.

Under the Plan's automatic enrollment policy, if an employee does not submit an automatic waiver within 30 days of becoming eligible, he or she will automatically be enrolled in the Plan at a 3% deferral rate. The deferral rate will be automatically increased by 1% each subsequent year with a maximum of 6%. An employee has the option to cease enrollment, withdraw all contributions and forfeit all Company contributions within 90 days of becoming eligible.

Participants may contribute any whole percentage amount of compensation subject to certain IRC limitations.

Employer matching contributions are 100% of the first 1% and 50% of the next 5% of the employee deferral or Roth 401(k) contributions.

Each plan year, Ensinger makes a profit-sharing contribution to the Plan out of its net income in an amount determined by the board of directors. For 2024 and 2023, the contribution totaling \$831,049 and \$1,035,174 for all eligible employees represented 3.5% and 4.5% of their eligible compensation, respectively.

Participant Accounts

All of a participant's contributions, employer matching contributions, and profit-sharing contributions are credited to his or her account. The value of each of the separate funds is determined directly by Ascensus Trust Company daily. Ascensus Trust then values and increases or decreases each participant's account to reflect his or her proportionate interest in each of the funds as adjusted for fund activity since the preceding valuation date.

Investment Options

Participants may direct the investment of all contributions into various options offered by the Plan. The Plan currently offers mutual funds and common collective trust fund as an investment options.

Vesting and Distributions

Participants are 100% vested in all employer contributions.

Amounts contributed through salary/wage reductions may be withdrawn by, or distributed to, a participant only upon (1) termination of employment, (2) retirement or (3) meeting the in-service requirements set in the plan document, or to a designated beneficiary upon death. Withdrawals prior to items above are not permitted except in the event of disability or as a hardship distribution. Upon proof to the satisfaction of the plan administrator of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

Notes Receivable From Participants

Participants with specific cases of financial need may borrow money from their account. Loans may be 50% of the vested account balance from a minimum of \$1,000 to a maximum of \$50,000. The loans are secured by the balance in the participant's account or by some other means as deemed appropriate by the plan administrator. Loans bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Loan terms are not to exceed 60 months or the participant attaining normal retirement age.

Forfeited Accounts

Forfeitures are used to reduce the amount of the employer's matching contributions for each plan year. At December 31, 2024 and 2023, the remaining forfeited nonvested amounts totaled \$12 and \$672, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a description of fair value measurements.

Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses paid by the Plan Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy establishes three (3) levels of inputs that may be used to measure fair value:

- Level 1 – inputs are unadjusted quoted prices in active markets for identical assets or liabilities;
- Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Mutual funds are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund on the last day of the Plan's year end using a quoted price in an active market and are classified within Level 1 of the fair value hierarchy.

Common Collective Trust Fund: The Plan invests in the T. Rowe Price Stable Value Fund (the Fund), a common collective trust, which seeks to maximize current income while maintaining stability of principal. The Fund is valued at NAV based on the fair value of the Fund's underlying investments, which includes a variety of investment contracts such as separate account contracts and synthetic investment contracts issued by insurance companies, banks, and other financial institutions and other short-term investments. The Fund allows for daily redemption. There are no unfunded commitments for investment in the Fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain or loss includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 4 CERTIFIED FINANCIAL INFORMATION

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intention to do so, Ensinger has the right under the Plan to terminate, amend, modify, or suspend the Plan in whole or in part at any time subject to the provisions of ERISA. In the event of plan termination, participants will become one hundred percent (100%) vested in their accounts.

NOTE 6 TAX STATUS

The Plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service informed Ensinger that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has since been amended. Ensinger believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, the Plan continues to qualify under Section 401(a), as amended by the Economic Growth and Tax Relief Reconciliation Act of 2001. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated to Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan paid certain administrative fees to the custodian, third-party administrator and various investment managers. These transactions qualify as party-in-interest transactions. These fees amounted to \$91,837 and \$108,004 for the years ended December 31, 2024 and 2023, respectively. These transactions are not, however, considered prohibited transactions under Section 408(b) of the ERISA regulations.

The Plan has notes receivable from participants subject to specific guidelines as defined in the plan document (Note 1). These transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory or administrative exceptions from the IRC and ERISA's rules on prohibited transactions.

NOTE 9 DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2023, the plan failed to timely remit participant contributions and loan repayments amounting to \$23,980.

NOTE 10 SUBSEQUENT EVENTS

Subsequent events were considered through September 30, 2025, which is the date that financial statements were available to be issued. The Company is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
