NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Valley Perinatal Services 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan was established on June 1, 2017, and is a defined contribution plan covering employees of Valley Perinatal Services, LLC (the “Company”, “Sponsor”, and “Employer”). The plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The plan’s trustee is responsible for oversight of the Plan and determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Reliance Trust Company, who invests contributions and Plan earnings, makes investment transactions as directed by Plan management and provides certain recordkeeping services. The Standard Retirement Services, Inc. acts as the third-party administrator and recordkeeper for the Plan and performs certain plan administration and annual ERISA compliance testing.

Eligibility

Employees who have attained age twenty-one and who are not residents of Puerto Rico or non-resident aliens are eligible to participate in the plan after obtaining three months of service. An eligible employee may enter the plan on the first day of the month after all entry requirements have been met.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation as defined by the plan (subject to annual deferral limits). The Plan also allowed for participants to make Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The plan provision also provides for discretionary employer matching contributions and profit-sharing contributions. To be eligible for either the matching or profit-sharing contributions a participant must be employed on the last day of the plan year and be credited with 1000 hours of service during the plan year. There was no discretionary employer matching or profit-sharing contributions during the year ended December 31, 2024.

Contributions are subject to certain internal revenue service limitations.

NOTE 1: DESCRIPTION OF THE PLAN (Continued)

Participant accounts

Each participant's account is credited with the participant's contributions, employer contributions and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing portion is based on years of continuous service as shown in the table below. A participant is credited a year of service for each year the participant has at least 1,000 hours of service. A participant is 100% vested in the company's profit sharing and matching contributions if they are employed on or after their normal retirement age or if they terminate employment on account of death or disability.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is based on local prevailing rates on similar commercial loans, as determined by the plan administrator. Principal and interest is paid ratably through recurring payroll deductions. Loan terms cannot be extended beyond five years unless for a primary residence in which case they may not extend beyond ten years.

Investment options

Upon enrollment in the Plan, a participant may direct employee and Plan sponsor contributions in any of the investment options that are offered by the plan.

NOTE 1: DESCRIPTION OF THE PLAN (Continued)

Benefit payments

Benefit payments may generally be made to a participant upon the participant's retirement, death, disability, termination of employment, attainment of age 59 1/2, or upon incurring a financial hardship. Normal retirement age is 65. Benefits shall be paid to participants in an amount equal to the value of the participant's vested interest in his or her account in a single lump sum. Distribution of a deceased participant's account will be made to the designated beneficiary.

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience severe financial hardship. The participant must meet the condition that they cannot relieve the amount of the need by stopping the elective contributions to the Plan. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Forfeitures

Forfeitures are used to reduce employer contributions and to pay plan expenses. As of December 31, 2024 and 2023 there were no forfeited non-vested unallocated accounts. No forfeitures were utilized during the year ended December 31, 2024 to reduce employer contributions or to pay plan expenses.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments generally are reported at fair value but may also be reported at net asset value (NAV) or contract value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements and NAV. The Plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's custodian.

The plan held an interest in a group annuity contract with Standard Insurance Company. Plan Management had determined its interest in the contract was fully benefit-responsive and it is reported at contract value. See Note 5.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contribution liabilities as of December 31, 2024 or 2023.

Payment of benefits

Distributions to participants are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees related to participant directed transactions are charged directly to participants' accounts and are included in administrative expenses. During the year ended December 31, 2024, \$48,339 of administrative expenses related to plan advisory and administrative services were charged and allocated to participant accounts, respectively.

Risks and Uncertainties

The Plan invests in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risks associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 6, 2025. See Note 9.

NOTE 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements has been derived from information certified to be complete and accurate by Reliance Trust Company, the qualified institution, under such regulation:

- a) Investments, at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Investment, at contract value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- c) Non-interest bearing cash, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- d) Investment income information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- e) All amounts included in Note 4, Fair Value Measurements.
- f) All amounts included in Note 5, Fully Benefit-Responsive Investment.

NOTE 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of input that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, which are:
 - Observable; or
 - Can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4: FAIR VALUE MEASUREMENTS (Continued)

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual Fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023. There were no assets valued at fair value as of December 31, 2024.

NOTE 5: FULLY BENEFIT-RESPONSIVE INVESTMENT

The plan had entered into a traditional fully benefit-responsive investment that was held through a rider on Standard Insurance Company's group annuity contract with investments that totaled \$80,359 at December 31, 2023. Standard Insurance Company maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a quarterly basis for resetting with a guaranteed minimum crediting rate of 1.00%. The interest crediting rate was 1.83% as of December 31, 2023.

NOTE 5: FULLY BENEFIT-RESPONSIVE INVESTMENT (Continued)

The contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participant if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. Certain events could have limited the ability of the Plan to transact at contract value with the issuer. Such events included (1) Termination of the contract under certain situations, (2) spin-offs, divestitures, layoffs, or partial or total plan termination, (3) Retirement incentive programs, or (4) Liberalization of plan withdrawal or transfer rules.

In addition, certain events could have allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) Noncompliance with state or federal law, (2) a breach of material obligation under the contract, (3) failure to maintain assets of at least \$25,000, or (4) Plan disqualification.

Participant transactions were redeemed daily and there was no notice period for cancellation of the contract by the contract holder. This contract was terminated during 2024 and settled at its contract value.

NOTE 6: TAX STATUS

The Plan sponsor has adopted a prototype non-standardized profit-sharing plan with a cash or deferral arrangement. The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Tax positions are recognized only if it is "more likely than not" that the tax position would be sustained in a tax examination, with a tax examination being presumed to occur. Plan management has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken to require the recognition of a liability or disclosures on the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7: RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments were managed by Standard Insurance Company, an affiliate of Standard Retirement Services, Inc. Standard Retirement Services, Inc. is the recordkeeper of the Plan and, therefore, these transactions qualify as party in interest transactions.

Standard Retirement Services, Inc. provides administrative and recordkeeping services to the Plan. Fees paid by the Plan for these administrative services totaled approximately \$28,000 during 2024.

NOTE 8: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Employer contributions.

NOTE 9: SUBSEQUENT EVENT

The plan was in the process of moving its assets and custodial services from Standard Insurance Company to Fidelity Management Trust Company at December 31, 2024. In conjunction with this transition the plan was also in transition of moving its recordkeeping and administrative services from Standard Retirement Services, Inc. to Fidelity.

The Company liquidated its mutual fund holdings in December 2024 and held all funds in a non-interest bearing cash account as of December 31, 2024 in anticipation of the transition to Fidelity. Effective January 1, 2025 these funds were deposited into Fidelity Management Trust Company and all recordkeeping and administrative services transitioned effective January 1, 2025.

Additionally, effective January 1, 2025, the plan entered into a new amended and restated plan document under Fidelity's pre-approved proto-type plan document. Under the new plan document the company eliminated the requirement of attaining age 21 for eligibility purposes and also enacted a safe harbor matching contribution equal to 100% of the first 3% of participant deferrals plus 50% of the next 2% of participant deferrals.

NOTE 10: RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain amounts reported on Form 5500 differ from the financial statements as the Form 5500 is reported on a cash basis.
