Opinion on the 2024 Financial Statements

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan

The following description of ICC Holdings, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

ICC Holdings, Inc. (the Company) established the Plan effective January 1, 2017. The Plan is a defined contribution plan intended to constitute an employee stock ownership plan (ESOP) and is designed to comply with Section 4975 (e)(7) and the regulations thereunder of the Internal Revenue Code (IRC). The Plan has been amended throughout the years to comply with tax legislation. Employees are eligible to participate in the Plan the first day of the calendar month coinciding with or next following the date on which the employee reaches the age 21 and complete 90 days of service. Employees covered under a collective bargaining agreement, leased employees and nonresidential aliens are not eligible for the Plan. The Plan is designed to invest into stock of the Company and is authorized to borrow money for such investments. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan purchased Company common stock using the proceeds of a note payable to the Company and holds the stock in a trust established under the Plan. As the Plan makes debt payments, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of common stock and is guaranteed by the Company. The lender has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of and for the years ended December 31, 2024 and 2023 present separately the assets and liabilities and changes therein pertaining to:

- a) The accounts of employees with vested rights in allocated common stock (allocated) and
- b) Common stock not yet allocated to employees (unallocated).

Contributions

Each year, the Company may make a discretionary contribution to the Plan as determined annually by the Company's Board of Directors. Contributions may be in the form of cash. Contributions for each year are never less than the amount required to enable the Plan to discharge its current obligations, without regard to whether some or all of such contributions may fail to qualify for an income tax deduction by the Company. In order to receive an allocation of Company discretionary contributions, a participant must complete 500 hours of service and be employed on the last day of the Plan year unless termination is due to death, disability or retirement. Contributions by Plan participants are not permitted by the Plan. Contributions are subject to Internal Revenue Service (IRS) limitations.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the trustee from the unallocated account, forfeitures, terminated participants' nonvested accounts, Company discretionary contributions, and dividends paid on Company stock. Only those participants who have completed 500 or more hours during the Plan year and employed on the last day of the Plan year will receive an allocation, except in the case of death, disability, or retirement. Allocations are based on a participant's eligible compensation, relative to total eligible compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Vesting

Vesting of participant's accounts is based on years of credited service with the Company. A participant's Company discretionary contribution account becomes fully vested after four years of service with the Company. A participant is fully vested in their Company contribution account upon reaching normal retirement age, death, or disability.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. On all other matters, the trustee is entitled to vote all shares of Company stock held in participant's accounts and all shares of the Company's unallocated stock.

Put Option

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company will pay for the purchase with a lump sum distribution to the participant. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their account in Company common stock into diversified investments. Participants who are at least age 55 with at least 10 years of participation service in the Plan may elect to diversify their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of their shares allocated to his or her account, plus any shares previously diversified, times the diversification percentage, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

Payment of Benefits

Upon termination of service, a participant will receive a lump sum distribution of their account balance without the participant's consent by the close of the plan year following the plan year of termination of service if their balance does not exceed \$1,000. Participant accounts in excess of \$1,000 will be paid in a lump sum. The amount to be distributed is based upon the account valuation date as of the plan year prior to the date of payment.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

Forfeited Accounts

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. There were no balances in forfeited nonvested accounts at December 31, 2024 and 2023. There were 5,945 shares reallocated to participants' account for 2024.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The common shares of the Company are valued at fair value. Fair value is determined by the Company's share price as of year-end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

(3) Investment in Sponsor Company Common Stock

On February 13, 2017, the Plan purchased 350,000 shares of the Company's common stock for \$3,500,000.

The estimated fair value per share as of December 31, 2024 and 2023, was \$23.28 and \$15.30 per share, respectively.

During 2024 and 2023, 23,450 and 23,437 shares, respectively, were released and allocated to participants.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurement and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the valuation methodology used at December 31, 2024 and 2023.

(5) Note Payable

On March 13, 2017, the Plan entered into a \$3,500,000 term loan agreement bearing interest at 2.78% with the Company. The proceeds of the loan were used to purchase 350,000 shares of the Company's common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year principal and interest payments divided by the total of the current year principal and interest payments plus all future years' principal and interest payments.

(6) Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the Employee Stock Ownership Committee shall direct the trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed stock held in the loan suspense account to the extent it determines such a sale to be necessary in order to repay the loan. In the event of Plan termination, participants will become 100% vested in their accounts.

(7) Plan Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan is qualified under the IRC and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in accordance with the IRC to maintain its qualification. The plan administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the code and as such is exempt from federal taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan investment in Company common stock is exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of Company common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(9) Related Party and Party-in-Interest Transactions

The Plan's assets, which consist of Company common shares and cash, are held by the trustee of the Plan.

Company contributions are held and managed by the trustee, which invests cash received, interest and dividends income and makes distributions to participants. The trustee also administers the payment of interest and principal on the loan.

(9) Related Party and Party-in-Interest Transactions, Continued

The Plan invests in Company common stock and has indebtedness guaranteed by the Company. These are related party and party-in-interest transactions. As the Company is the Plan Sponsor, transactions involving Company common stock qualify as party-in-interest transactions. At December 31, 2024 and 2023, the Plan held 350,000 shares of Company common stock. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(10) Subsequent Events

Effective March 6, 2025 (Plan Freeze Date), the Board of Directors of the Company amended the Plan to freeze all eligibility, participation and contributions. Upon the Plan Freeze Date, the Plan ceased to be an employee stock ownership plan and was classified as a profit sharing plan under IRC Section 401(a).

On March 13, 2025, the Company entered into a merger agreement with Mutual Capital Group, Inc. and all of the outstanding stock was exchanged for cash consideration. Contemporaneous with the merger, the Board of Directors of the Company voted to terminate the Plan.

On March 31, 2025, the assets of the Plan were transferred into the Company's 401(k) plan.

(1) Description of Plan

The following description of ICC Holdings, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

ICC Holdings, Inc. (the Company) established the Plan effective January 1, 2017. The Plan is a defined contribution plan intended to constitute an employee stock ownership plan (ESOP) and is designed to comply with Section 4975 (e)(7) and the regulations thereunder of the Internal Revenue Code (IRC). The Plan has been amended throughout the years to comply with tax legislation. Employees are eligible to participate in the Plan the first day of the calendar month coinciding with or next following the date on which the employee reaches the age 21 and complete 90 days of service. Employees covered under a collective bargaining agreement, leased employees and nonresidential aliens are not eligible for the Plan. The Plan is designed to invest into stock of the Company and is authorized to borrow money for such investments. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan purchased Company common stock using the proceeds of a note payable to the Company and holds the stock in a trust established under the Plan. As the Plan makes debt payments, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of common stock and is guaranteed by the Company. The lender has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of and for the years ended December 31, 2024 and 2023 present separately the assets and liabilities and changes therein pertaining to:

- a) The accounts of employees with vested rights in allocated common stock (allocated) and
- b) Common stock not yet allocated to employees (unallocated).

Contributions

Each year, the Company may make a discretionary contribution to the Plan as determined annually by the Company's Board of Directors. Contributions may be in the form of cash. Contributions for each year are never less than the amount required to enable the Plan to discharge its current obligations, without regard to whether some or all of such contributions may fail to qualify for an income tax deduction by the Company. In order to receive an allocation of Company discretionary contributions, a participant must complete 500 hours of service and be employed on the last day of the Plan year unless termination is due to death, disability or retirement. Contributions by Plan participants are not permitted by the Plan. Contributions are subject to Internal Revenue Service (IRS) limitations.

Participant Accounts

Participants who are at least age 55 with at least 10 years of participation service in the Plan may elect to diversify their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of their shares allocated to his or her account, plus any shares previously diversified, times the diversification percentage, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

Payment of Benefits

Upon termination of service, a participant will receive a lump sum distribution of their account balance without the participant's consent by the close of the plan year following the plan year of termination of service if their balance does not exceed \$1,000. Participant accounts in excess of \$1,000 will be paid in a lump sum. The amount to be distributed is based upon the account valuation date as of the plan year prior to the date of payment.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

Forfeited Accounts

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. There were no balances in forfeited nonvested accounts at December 31, 2024 and 2023. There were 5,945 shares reallocated to participants' account for 2024.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The common shares of the Company are valued at fair value. Fair value is determined by the Company's share price as of year-end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

(3) Investment in Sponsor Company Common Stock

On February 13, 2017, the Plan purchased 350,000 shares of the Company's common stock for \$3,500,000.

The estimated fair value per share as of December 31, 2024 and 2023, was \$23.28 and \$15.30 per share, respectively.

During 2024 and 2023, 23,450 and 23,437 shares, respectively, were released and allocated to participants.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurement and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the valuation methodology used at December 31, 2024 and 2023.

Company common stock: Valued at the daily closing price as recorded by the New York Stock Exchange.

(5) Note Payable

On March 13, 2017, the Plan entered into a \$3,500,000 term loan agreement bearing interest at 2.78% with the Company. The proceeds of the loan were used to purchase 350,000 shares of the Company's common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year principal and interest payments divided by the total of the current year principal and interest payments plus all future years' principal and interest payments.

While the Company reserves the right to change the amounts and the timing of contributions to the Plan, the scheduled amortization of the Plan's loan and related Plan contributions for the next five years are as follows:

(6) Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the Employee Stock Ownership Committee shall direct the trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed stock held in the loan suspense account to the extent it determines such a sale to be necessary in order to repay the loan. In the event of Plan termination, participants will become 100% vested in their accounts.

(7) Plan Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the Plan is qualified under the IRC and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in accordance with the IRC to maintain its qualification. The plan administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the code and as such is exempt from federal taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan investment in Company common stock is exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of Company common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(9) Related Party and Party-in-Interest Transactions

The Plan's assets, which consist of Company common shares and cash, are held by the trustee of the Plan.

Company contributions are held and managed by the trustee, which invests cash received, interest and dividends income and makes distributions to participants. The trustee also administers the payment of interest and principal on the loan.

(9) Related Party and Party-in-Interest Transactions, Continued

The Plan invests in Company common stock and has indebtedness guaranteed by the Company. These are related party and party-in-interest transactions. As the Company is the Plan Sponsor, transactions involving Company common stock qualify as party-in-interest transactions. At December 31, 2024 and 2023, the Plan held 350,000 shares of Company common stock. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(10) Subsequent Events

Effective March 6, 2025 (Plan Freeze Date), the Board of Directors of the Company amended the Plan to freeze all eligibility, participation and contributions. Upon the Plan Freeze Date, the Plan ceased to be an employee stock ownership plan and was classified as a profit sharing plan under IRC Section 401(a).

On March 13, 2025, the Company entered into a merger agreement with Mutual Capital Group, Inc. and all of the outstanding stock was exchanged for cash consideration. Contemporaneous with the merger, the Board of Directors of the Company voted to terminate the Plan.

On March 31, 2025, the assets of the Plan were transferred into the Company's 401(k) plan.
