Notes to Financial Statements

Note 1: Description of Plan

The following description of the ChemDesign Products, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of ChemDesign Products, Inc. (the "Company") who have six months of service and are age 20 or older. Upon satisfying eligibility requirements, an employee is eligible to participate in making elective deferrals and receiving Company matching contributions on the first day of the following calendar month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Management of the Company is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions

Each year, participants may contribute up to 90% of annual compensation, as defined in the plan document, on a pretax or Roth basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans (rollover contributions). Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate rate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

The Company may contribute discretionary matching or profit sharing contributions to the Plan. For 2024, the Company made discretionary matching contributions of 50% of the first 6% of eligible compensation deferred by a participant, which totaled \$353,576. Participants must be employed on the last day of the plan year to be eligible to receive the Company's discretionary profit sharing contribution. There was no profit sharing contribution to the Plan during 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, and allocations of (a) Company profit sharing contribution and (b) plan earnings or losses. Participant accounts are reduced by withdrawals and charged with an allocation of administrative and investment advisory expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately 100% vested in their account balances plus actual earnings thereon.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one note outstanding at any given time. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%, as of December 31, 2024, which is based on the prime rate plus 2.00%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Plan benefits are available upon retirement (age 65), death, disability, or termination of employment with vested interests. A participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted some of these provisions, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Investment Advisory Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and the processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment advisory fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in net investment income on the accompanying statement of changes in net assets available for benefits. Certain investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Valued at the NAV provided by the administrator of the fund using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. These funds are stable value funds and their NAVs are based on the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily, and there are no restrictions as to the redemption of these funds or unfunded commitments at December 31, 2024 and 2023.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Capital Bank and Trust Company, the Trustee of the Plan.

Note 5: Party-in-Interest Transactions

Certain plan investments are units of mutual funds managed by American Funds, an affiliate of Capital Bank and Trust Company. Capital Bank and Trust Company is the Trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid to the Trustee for administrative expenses were \$3,954 for the year ended December 31, 2024. Certain fees incurred by the Plan for investment-related services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

In addition, the Plan paid fees of \$34,091 to Edward Jones for investment advisory services for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Note 7: Tax Status

The Plan has adopted a non-standardized pre-approved plan document with an IRS notification letter, dated June 30, 2020, which states the non-standardized pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
