Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tumi, Inc. Profit Sharing/401(k) Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of Plan

The following description of the Tumi, Inc. Profit Sharing/401(k) Plan (Plan) is provided for general purposes only. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide substantially all eligible non-union employees, as defined by the Plan document, of Tumi, Inc. (Company) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employment Retirement Income Security Act of 1974* (ERISA).

Eligibility

All employees of the Company other than certain excluded employees as defined by the Plan document are eligible to participate in the Plan on the first day of the month following the completion of six months of service provided that the employee has attained the age of 21 and is not covered by collective bargaining agreement for which retirement benefits have been the subject of good faith negotiations.

Participant contributions

Eligible participants may make voluntary contributions through salary reductions from 1% to 60% of their eligible annual compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the IRC (\$23,000 in 2024). Further, participants who are 50 years of age or older as of December 31, 2024, may contribute an additional "catch up" contribution (\$7,500 in 2024). The Plan also allows for the participants to make Roth deferral contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants.

Participants may also make rollover contributions from other qualified plans if certain criteria are met as outlined in the Plan document.

Employer Contributions

The Company makes safe harbor matching contributions of 100% of the employee's contribution on the first 3% of eligible compensation and 50% of the employee's contribution on the next 2% of eligible compensation.

In addition, the Company may contribute a discretionary profit-sharing contribution to those employees to have provided at least 1,000 hours of service, as defined, during the year, and who are employed on the last day of the plan year. Profit-sharing contributions are allocated based on the employee's eligible compensation for the year. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

Participants' accounts

Each participant's account is credited with their respective contribution and its allocation of (a) employer contributions and (b) Plan earnings and losses.

Vesting

Participants are 100% vested in pre-tax employee contributions, Safe Harbor contributions, Roth deferral contributions, rollover accounts, and earnings thereon.

Effective January 1, 2007, all sponsor discretionary profit-sharing contributions and earnings are vested.

Participants' accounts become fully vested upon death, total disability, reaching normal retirement age, or termination of the Plan. If a participant terminates employment for any other reason, they are entitled to their vested interest in employer contributions.

Forfeitures

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, may be used to reduce Company contributions. As of December 31, 2024 and 2023 the balance in the forfeiture accounts were \$163 and \$2,066, respectively. In 2024, approximately \$2,000 of forfeitures were used to fund employer contributions and administrative expenses.

Payment of benefits

Upon termination of employment, retirement, attainment of age 59 ½, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum payment, or installment payments, in accordance with Internal Revenue Service (IRS) regulations and Plan provisions. Withdrawals from the Plan are also available for special "hardship" reasons (as defined). Participants who have terminated service with balances of \$1,000 or less are required to take a lump-sum distribution. Participants who have terminated service with balances greater than \$1,000 can elect to receive a lump-sum distribution, in cash or in the form of a rollover to another qualified plan, monthly installments or some combination of lump sum and monthly installments. Benefits are recorded when paid.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded at December 31, 2024 or 2023, because the loans are fully secured by the participants' account balances. Delinquent participant loans are reclassified as distributions based upon the terms in the Plan document.

Participants may borrow from their vested account. The minimum amount that may be borrowed is \$1,000, and the loan amount cannot exceed the lesser of 50% of the participant's balance or \$50,000, reduced by the highest outstanding balance in the previous 12-month period. No loans are available from non-elective contributions. The maximum term of such loans is five years. Participants may only have two outstanding loans at any given time. The

interest rate will be a fixed rate comparable to that charged by commercial lenders for similar loans. Principal and interest is paid ratably through payroll deductions.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed by the Plan.

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the Plan year or at the time of purchase during the Plan year.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Other expenses are paid directly by the Plan, including fees related to the administration of notes receivable from participants which are charged directly to the participant's account, and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Fair Value

Accounting standards provide a common definition of fair value and establish a framework to make the measurement of fair value in generally accepted accounting principles more consistent and comparable. Accounting standards also require expanded disclosures to provide information about the extent to which fair value is used to measure certain financial and non-financial assets and liabilities, the methods and assumptions used to measure fair value, and the effect of fair value measures on earnings. The Plan's financial assets reflected in the financial statements at fair value include its investments (see Note 9).

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Trustee

Plan management has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Related Party Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer, or employee association or relatives of such persons. The Company provides certain administrative services at no cost to the plan.

Certain Plan investments are shares of mutual funds that are managed by Principal. Principal is the Trustee of Plan, and therefore, investment transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules, as defined by ERISA.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and their account balance will be distributed as directed by the participant.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Concentrations

Balances in three investments each accounted for more than 10% of total investments as of December 31, 2024 and 2023.

Note 9. Fair Value Measurements

Accounting standards require that financial and non-financial assets and liabilities, recognized or disclosed in financial statements on a recurring basis (at least annually), be measured at fair value. These standards define fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

These standards also establish a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. These standards describe three levels of inputs that may be used to measure fair value:

- Level 1** - Quoted prices in active markets for identical assets or liabilities that are accessible at the measurement date.
- Level 2** - Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities in active markets; quoted prices for similar assets or liabilities in markets that are not active; or model-derived valuations or other inputs that are observable or can be corroborated by observable market data for the assets or liabilities.
- Level 3** - Unobservable inputs for the asset or liability that are significant to the fair value measurement. These inputs reflect the Plan's assumptions about the assumptions a market participant would use in pricing the asset or liability.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and Level 3 inputs are only used when higher level inputs are not available.

The following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Value is based on the underlying unit value of the assets held. The assets of the underlying fund are invested primarily in certain investment contracts and other securities. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
