Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ESA Management, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audits.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule of Assets (Held at End of Year) - Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the ESA Management, LLC 401(k) Plan (the “Plan”) summarizes the key provisions of the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General—The Plan is a defined contribution plan sponsored and administered by ESA Management, LLC (the “Company” or “Plan Sponsor”). The Plan was established on January 1, 1997 and was most recently amended and restated effective November 3, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan covers all employee classifications except residents of Puerto Rico, nonresident alien, and leased employees. Employees are eligible to participate in the Plan immediately upon hire and the attainment of twenty-one years of age. Participants are eligible to receive employer contributions after 180 days of service.

The November 3, 2023 amendment allows participants to designate that a portion or all of deferred contributions made are Roth 401(k) after-tax contributions.

Administration—The Plan is administered by the Company, which serves without compensation. As the Plan Administrator, the Company has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals or third parties to perform those responsibilities. The Company has outsourced the record keeping function of the Plan to Fidelity Management Trust Company (“Fidelity”), the qualified institution of the Plan.

Contributions— Plan participants make contributions via a deferred salary reduction arrangement. Plan participants may contribute any percentage of pre-tax or after-tax compensation, as defined, up to the annual limits as determined by the Internal Revenue Code (“IRC”). The Company may make matching contributions at its discretion, as well as additional discretionary profit-sharing contributions. During the year ended December 31, 2024, the Company made matching employer contributions equal to 50% of the first 6% deferral of eligible compensation that a participant contributes to the Plan, with a maximum match of 3% of the employees applicable salary. There were no discretionary profit-sharing contributions made during the year ended December 31, 2024. Employees may rollover eligible amounts from other qualified plans as rollover contributions.

Participant Accounts—Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, allocations of Company discretionary contributions, if any, and Plan earnings and is charged with withdrawals and allocations of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments—Participants direct the investment of their contributions into various investment options offered by the Plan. As of December 31, 2024 and 2023, the Plan offered various mutual funds and common collective trusts as investment options for participants.

Vesting—Vesting in the Company’s contribution portion of participant accounts is based on years of continuous service. A participant is 33% vested after one year of continuous service, 66% vested after two years and 100% vested after three years. Participants are 100% vested immediately in their own contributions, rollover accounts and earnings thereon.

Notes Receivable from Participants—Participants are able to borrow from their accounts. The minimum loan amount is \$1,000 and the maximum amount is the lesser of one-half of the participant’s vested account balance or \$50,000, reduced by the highest outstanding loan balance in the participant's account during the prior twelve-month period. All loans are charged a fixed interest rate as determined by the Plan Administrator based on the prevailing market interest rates. Loans must be fully repaid

within five years, unless the loan is used for the purchase of a primary residence in which case the loan repayment period may not extend beyond ten years.

Payment of Benefits—At termination of service due to death, disability, retirement or termination for any reason, a participant (or a representative, if the participant is deceased or incapacitated) may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. As an alternative, employees may request a rollover distribution into another eligible plan. Withdrawals can be made in certain hardship cases as defined by the Plan, subject to penalties imposed by the IRC.

Forfeited and Unallocated Accounts—The Plan uses funds from forfeited and unallocated non-vested accounts to reduce current year employer contributions and pay administrative fees. As of December 31, 2024 and 2023, forfeited and unallocated non-vested accounts totaled \$523,925 and \$949,101 respectively. For the year ended December 31, 2024, the Plan utilized funds from forfeited accounts to offset \$508,495 of employer contributions and to pay administrative fees of \$47,393.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates—The preparation of the accompanying financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan utilizes various investment instruments, including mutual funds and common collective trusts. Investment securities are exposed to various risks, including but not limited to interest rate risk, credit risk, and market volatility. Due to the level of risk associated with investment securities, changes in the values of investment securities will occur in the near-term and long-term and such changes may materially affect fair values, including amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan’s investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains (losses) on investments bought and sold as well as those held during the year. Management fees and operating expenses charged to the Plan are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Administrative Expenses—Certain costs related to the ongoing administration of the Plan are paid by the Company and are not reimbursed by the Plan. Allowable expenses, as defined, including investment advisory fees and other party-in-interest services discussed in Note 5, are paid by the Plan.

Income Taxes—No provision for income taxes is included in the Plan’s financial statements because the Plan Administrator believes that the Plan continues to be qualified and the tax status of the related trust continues to be tax exempt.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance and include accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan. Related fees are recorded as administrative expenses and are expensed when incurred.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. As of December 31, 2024 and 2023, there were no benefit payments requested and not yet disbursed.

Excess Contributions Payable—The Plan is required to return contributions received during the Plan year in excess of the IRC limits, and they are recorded as a liability with a corresponding decrease to participant contributions. As of

December 31, 2024 and 2023, excess contributions payable were \$246,267 and \$231,030, respectively, of which \$246,267 and \$231,030 were returned to participants in early 2025 and 2024, respectively.

3. FAIR VALUE MEASUREMENTS

U.S. GAAP establishes a three-level valuation hierarchy based upon observable and unobservable inputs for fair value measurement of financial instruments:

Level 1—Observable inputs, such as quoted prices in active markets at the measurement date for identical assets or liabilities;

Level 2—Significant inputs that are observable, directly or indirectly, such as other quoted prices in markets that are not active or inputs which are observable, either directly or indirectly, for substantially the full term of the asset or liability;

Level 3—Significant unobservable inputs for which there is little to no market data and for which the Plan makes its own assumptions about how market participants would price the asset or liability.

Fair value is defined as the price that would be received when selling an asset or the price paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, the level in the fair value hierarchy within which the fair value measurement in its entirety is determined based on the lowest-level input significant to the fair value measurement in its entirety. The methods described above may produce a fair value calculation that may not be indicative of net realizable value and may not be reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of financial instruments could result in a different fair value measurement at the reporting date.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within Level 1 of the valuation hierarchy.

Collective trust funds: Valued at the NAV of units of bank collective trusts. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Collective trust funds held by the Plan are as follows:

Putnam Stable Value Fund: As of December 31, 2024 and 2023, the Fund invests in high-quality guaranteed investment contracts (GICs) and similar contracts issued by insurance companies, banks and other financial institutions. The Fund also invests up to 75% of its assets in security-backed investment contracts (SBICs), including separate account products of insurance companies. The Fund invests at least 5% of its assets in high-quality money market instruments, cash, cash equivalents and, pursuant to liquidity and deposit agreements, stable value funds with investment policies and other provisions similar to those of the fund, and may invest without limit in these investments.

Putnam Large Cap Value Trust Class I: As of December 31, 2024 and 2023, the Fund invests in common stocks of midsize and large U.S. companies, with a focus on value stocks that offer the potential for capital growth, current income, or both. Under normal circumstances, the Fund invests at least 80% of the Fund's net assets in common stocks and other equity investments that offer the potential for current income.

Cohen & Steers U.S. Realty Fund Class RS: As of December 31, 2024, the Fund invests in a diversified portfolio of common stocks of real estate companies and other permitted investments. It invests in publicly traded real estate companies that own income-producing properties or land, including real estate investment trusts (REITs) and real estate corporations, primarily domiciled in the United States.

5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity Workplace Services LLC, an affiliate of Fidelity, and therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in the net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan made the following direct payments, which were not covered by revenue sharing:

Fees paid to Fidelity totaled \$291,474 for the year ended December 31, 2024 and qualify as party-in-interest transactions.

Fees paid to Creative Planning LLC and Strategic Advisors, Inc. for investment advisory services totaled \$45,000 and \$37,945, respectively, for the year ended December 31, 2024 and qualify as party-in-interest transactions.

Fees paid to Cherry Bekaert LLP for accounting and audit-related services totaled \$26,775 for the year ended December 31, 2024 and qualify as party-in-interest transactions.

Fees paid to Austin Print Solutions for other services totaled \$3,036 for the year ended December 31, 2024 and qualify as party-in-interest transactions.

Notes Receivable from participants qualify as party-in-interest transactions.

The Plan Sponsor pays directly any other fees related to the Plan's operations.

6. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth by ERISA. If the Plan is terminated, participants will become 100% vested in the Company contributions.

7. FEDERAL INCOME TAX STATUS

The Plan has been adopted as a prototype plan and obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the Plan, as then designed, was in compliance with the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that require recognition of an asset or liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RECONCILIATION TO FORM 5500
