### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Billy Graham Evangelistic Association 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**Note 1—Description of the Plan**

*General* – The following brief description of the Billy Graham Evangelistic Association 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete explanation of the Plan’s provisions.

Beginning January 1, 1994, the Billy Graham Evangelistic Association established a defined contribution plan that is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended, covering all employees of the Billy Graham Evangelistic Association and its participating affiliated employers (the “Association”, the “Plan sponsor”, or “Employer”) who meet the eligibility requirements of the Plan. The Plan was most recently restated effective March 18, 2022. All employees who are 18 years of age and who have completed one year of service are eligible to participate.

*Administration* – The Plan is administered by the Association, which serves without compensation. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities. The Association has outsourced the recordkeeping function of the Plan to Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the “qualified institution”.

*Contributions* – Upon meeting eligibility requirements, employees are automatically enrolled in the Plan with a 6% deferral per semi-monthly pay period. Employees may choose a different deferral percentage, including zero, by completing an elective deferral agreement. The Plan allows participants to contribute to the Plan through pre-tax or Roth elective deferrals. These contributions are described as “elective deferrals”. These salary reduction contributions may not exceed 70% or be less than 1% of an employee’s compensation for the year. These elective deferrals are also subject to the Internal Revenue Service (“IRS”) maximum contribution of \$23,000 for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified plans.

Employer contributions are discretionary; however, a minimum of a 3% non-elective contribution to all employees eligible to make elective deferrals is required to take advantage of the safe harbor discriminatory testing. A discretionary annual, non-elective contribution of up to 2% of an employee’s eligible compensation and a discretionary matching of participant elected deferrals of 100% up to the first 3% will also be considered each Plan year by the Board of Directors. Employees who have worked 1,000 or more hours in the Plan year are eligible for the discretionary annual, non-elective contribution. Employees who are an active participant at any time during the Plan year are eligible for the discretionary match. For the year ended December 31, 2024, the Board of Directors approved the 3% safe harbor non-elective contribution, the 2% discretionary contribution, and a match of 100% up to the first 3% of eligible compensation.

*Catch-Up Contributions* – For the year ended December 31, 2024, if a participant is eligible to make deferral and turns 50 before the end of the calendar year, the participant may defer an additional \$7,500 into the Plan as a contribution subject to certain Internal Revenue Code (“IRC”) limitations. The Plan allows participants to make catch-up contributions through pre-tax or Roth elective deferrals.

*Participant Accounts* – Each participant’s account is credited with the participant’s contributions, the Association’s contributions, benefit payments, and allocations of Plan earnings or losses and expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Note 1—Description of the Plan (continued)**

*Vesting* – Participants are immediately vested in any safe harbor non-elective contribution and in their own voluntary deferrals. After three years of vested service (i.e., three Plan years of at least 1,000 hours of service in each Plan year), participants are 100% vested in any Employer matching contribution and any Employer discretionary annual, non-elective contribution.

*Investment Options* – Upon enrollment in the Plan, a participant may direct 100% of their allocation of contributions with the qualified institution. Participants may select between several investment options and may transfer balances periodically based on the applicable funds as defined in the custodial service agreement.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or greater for the purchase of a primary residence. Participants may not have more than one outstanding loan at a time, except for those who had taken loans under prior provisions. The loans are secured by the balance in the participant's account and bear interest at a rate based on the rates available for similar loans from commercial lending institutions. The effective interest rate for participant loans ranged from 3.25% to 8.50% with maturities through February 2040 as of December 31, 2024. Principal and interest are paid monthly through semi-monthly or biweekly payroll deductions.

*Benefits Paid to Participants* – Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments, or an annuity. For termination of service for other reasons, distribution of the value of the participant's vested interest in his or her account will begin as soon as possible after the participant's request. Withdrawals prior to attaining age 59½ are not permitted, except in the event of retirement, disability, or as a hardship distribution. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

*Forfeited Accounts* – As of December 31, 2024 and 2023, the balance in the forfeited balances of participants' nonvested Employer matching and discretionary contribution accounts was \$165 and \$149, respectively. Forfeitures are retained in the Plan and may be applied to the payment of the Plan's administrative expenses or Employer contributions to the Plan. Forfeitures of \$68,640 were used to reduce Employer contributions and \$7,505 were used to pay administrative expenses for the year ended December 31, 2024.

**Note 2—Significant accounting policies**

*Basis of Accounting* – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Note 2—Significant accounting policies (continued)**

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

*Risks and Uncertainties* – Investment securities, in general, are subject to various risks, such as interest rate, credit, and overall market volatility. Due to the levels of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

*Benefits Paid to Participants* – Benefit payments to participants are recorded upon distribution.

*Administrative Expenses* – As discussed in Note 7, certain Plan administrative expenses are paid by the Plan. The Plan sponsor pays all other administrative expenses incurred by the Plan.

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Note 3—Information certified by the qualified institution (unaudited)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institution, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule.

- Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 4—Fair value measurements**

U.S. GAAP describes three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Mutual Funds* – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

*Pooled Separate Accounts* – Pooled separate accounts invest mainly in domestic stocks. These assets are not available in an exchange or an active market; however, the fair value is determined based on the NAV of the underlying assets as traded in an exchange or active market. The fair value of the pooled separate accounts is stated at NAV as a practical expedient.

*Common Collective Trusts* – These investments are investment vehicles valued using NAV as a practical expedient. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Through July 10, 2023, the Plan invested in Goldman Sachs Stable Value Collective Trust (“Goldman Sachs Fund”) issued by Goldman Sachs Trust Company, N.A. The Goldman Sachs Fund sought to earn current income, while seeking to preserve capital and stability of principal. The Goldman Sachs Fund also sought to maintain a stable NAV of \$1.00 per unit. The Goldman Sachs Fund invested in benefit responsive contracts such as wrap agreements and insurance company separate account agreements, under which the insurance company or other financial institution contract issuer agrees, subject to certain conditions, to make payments from the contract in connection with redemptions from the Goldman Sachs Fund for Plan participant-initiated benefit payments. The Goldman Sachs Fund's stable value contracts typically related to a portfolio or portfolios of fixed income securities or units or other interests in fixed income commingled funds.

On and after July 10, 2023, the Plan invested in flexPATH Strategies - Stable Value Collective Trust (“Stable Value Fund”) issued by Great Gray Trust Company, LLC. The Stable Value Fund seeks to preserve principal and achieve high current income through a diversified portfolio of high-quality investment contracts. The Stable Value Fund invests in an underlying fund (Putnam Fiduciary Trust Company Investment Funds for Pension and Profit Sharing Trusts established and maintained by Putnam Fiduciary Trust Company, LLC) that seeks to invest in high-quality guaranteed investment contracts (GICs) and similar contracts issued by insurance companies, banks and other financial institutions. It also invests up to 75% of its assets in security-backed investment contracts (SBICs), including separate account products of insurance companies. It invests at least 5% of its assets in high-quality money market instruments, cash, cash equivalents and stable value funds. The process is focused first on liquidity and then total return and capturing market opportunities to help create return above the benchmark.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5—Income tax status**

The IRS has determined and informed the Plan prototype sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Association has chosen to rely on the determination letter issued to the Plan prototype sponsor. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax and, therefore, the Plan and related trust continue to be tax-exempt.

As required by U.S. GAAP, Plan management evaluates tax positions taken by the Plan and would recognize a tax liability for any tax position taken that is beneficial to the Plan, including any related interest and penalties, when it is more likely than not, that the position taken by the Plan would be overturned by a taxing authority upon examination. Plan management believes there are no such positions as of December 31, 2024 or 2023 that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8—Plan termination**

The Association believes the Plan will continue without interruption but reserves the right to discontinue the Plan. In the event such discontinuance results in termination of the Plan, a participant's account becomes 100% vested and non-forfeitable. The Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination.

**Note 9—Subsequent events**

Effective January 1, 2025, the Plan was restated. All employees will be automatically enrolled in the Plan after one month of service with the Association; there is no longer a service requirement for elective deferrals.

The Plan administrator has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.
