## Independent Auditor's Report

To the Participants and Plan Administrator  
Ardagh North America 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Ardagh North America 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1 - Plan Description

The following description of Ardagh North America 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a multiple-employer defined contribution plan covering all eligible employees of Ardagh Glass Inc., Ardagh Metal Beverage Inc., Ardagh Metal Packaging, and Ardagh Conversion Systems (collectively, the "Participating Companies" or the "Plan Sponsor"), as defined by the plan document. All of the Participating Companies are subsidiaries of Ardagh Group S.A. (the "Company") except for Ardagh Metal Beverage Inc., which was sold by the Company in October 2021. Upon the divestiture of Ardagh Metal Beverage Inc., the Plan became a multiple-employer plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan, along with Ardagh North America Bargaining 401(k) Plan, is a participant in the Ardagh North America 401(k) Plan and Ardagh North America Bargaining 401(k) Plan Master Trust (the "Master Trust").

The eligibility and enrollment provisions differ by the Participating Companies and/or divisions within the Participating Companies and are defined in the plan document. Enrollment dates range from the employment commencement date to the 90-day anniversary of employment. Eligible employees are automatically enrolled at contribution rates and enrollment dates defined in the plan document.

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 50 percent of earnings for any payroll period subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 50 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. The Plan provides for employer matching contributions that differ by the Participating Companies and/or divisions within the Participating Companies and that are defined in the plan document.

The Plan also provides for employer nonmatching contributions for a portion of plan participants, as defined in the plan document. Employer nonmatching contributions are calculated as a percentage of compensation based on years of service or age, without regard to participant deferrals.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Participating Companies' contributions and plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that is paid by the Master Trust. Allocations are based on participants' account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Eligible employees of Ardagh Metal Beverage Inc. and Ardagh Metal Packaging and a portion of eligible employees of Ardagh Glass Inc. are immediately 100 percent vested in employer contributions plus actual earnings thereon. Eligible employees of Ardagh Conversion Systems become fully vested in employer matching contributions after three years of service.

All actively employed and all future employed participants of Ardagh Glass Inc. are fully vested in matching contributions. All other remaining employees vest based on the following schedule:

All remaining eligible employees become fully vested in employer nonmatching contributions after three years of service.

**Benefit Payments**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. On termination of service for reasons other than death, disability, retirement, or reaching the age of 59½, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The Plan Sponsor must approve any such hardship withdrawals.

**Forfeitures**

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. At the discretion of the Plan Sponsor, forfeitures can be used to pay administrative expenses of the Plan or to reduce future company contributions. At December 31, 2024 and 2023, forfeited account balances totaled approximately \$378,000 and \$84,000, respectively. Forfeitures used during 2024 and 2023 were insignificant.

**Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The Plan allows participants to have two outstanding notes receivable that include one housing note and one general purpose note. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates determined periodically by the Plan Sponsor. Principal and interest are paid ratably through monthly payroll deductions.

### Note 1 - Plan Description (Continued)

#### *Party-in-interest Transactions*

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### *Termination*

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Additionally, each participating company has the right to cease participation in the Plan. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### *Investment Valuation*

The fair value of the Plan's interest in the Master Trust is based on the beginning of the year value of the Plan's interest in the trust plus actual contributions and allocated investment income (loss) less actual distributions and allocated administrative expenses. The Master Trust's investments are stated at fair value.

The common/collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying assets. Additionally, the Master Trust allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments in money market funds, mutual funds, and common stock and are disclosed as such in Note 4. The self-directed brokerage accounts and all other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information

#### *Participant Notes Receivable*

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### *Benefit Payments*

Benefits are recorded when paid.

#### *Administrative Expenses*

Various administrative costs are paid by the Plan Sponsor.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including September 22, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year, including master trust information included in Note 4, are based solely on information certified by the Trustee.

### Note 4 - Fair Value Measurements and Interest in Master Trust

The Plan's investments are in the Master Trust, which was established for the investment of assets of the Plan and Ardagh North America Bargaining 401(k) Plan. Each participating plan's interest in the Master Trust is based on account balances of the participants and their elected investment options. The assets of the Master Trust are held by Fidelity Management Trust Company. Investment income and administrative expenses relating to the Master Trust are allocated to the individual plans based upon average monthly balances invested by each plan.

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### **Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Master Trust has the ability to access.

#### **Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### **Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flows methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. Transferred amounts must be held in a noncompeting investment option for 90 days before subsequent transfers to a competing fund can occur.

**Note 7 - Transfers**
