Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Complete Health Care Solutions, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Complete Health Care Solutions, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General – Complete Health Care Solutions, Inc. (the "Company") established the Plan to provide employees with a systematic means of saving and investing for the future. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") for employees of the Company.

Alerus Financial, N.A. ("Alerus") serves as the Plan's custodian and participant recordkeeper. ERP Retirement Services serves as the third-party administrator. An officer of the Company serves as the Plan's trustee.

Plan Amendment – The Plan was amended effective January 1, 2024, to allow safe harbor matching contributions of 100% of an employee's salary deferrals up to 7% of compensation.

Eligibility – The Plan is open to employees of the Company, as defined by the Plan Document, who are at least 21 years old, and have completed one year of service with 1,000 hours. Union employees and nonresident aliens are not eligible for the Plan. Once the eligibility requirements have been met, an employee may enter the Plan on the first day of January or July.

Contributions – Participants may contribute any amount of their eligible compensation as pre-tax contributions or Roth contributions, as defined in the Plan, subject to certain Internal Revenue Code ("IRC") limitations. In addition, certain eligible employees, as defined by the Plan, are eligible to make catch-up contributions, in accordance with Plan provisions.

The Company makes a safe harbor matching contribution of 100% of an employee's salary deferrals up to 7% of compensation. The Company may make a discretionary profit-sharing contribution to be determined by the Company with respect to each Plan year. Eligible employees must be employed at the end of the year or complete 500 hours of service in order to receive the discretionary profit-sharing contribution. The Company did not make a discretionary profit-sharing contribution in 2024.

Participant Accounts – Each participant's account is credited with the participant's voluntary contribution, the Company's contributions, and an allocation of investment earnings (losses), and is charged with the participant's withdrawals and distributions, and an allocation of Plan expenses. Allocations of general expenses are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Options – Participants direct their elective contributions and Company contributions into any of the investment options offered by the Plan. The Plan currently offers mutual funds and a money market fund.

Forfeitures – At December 31, 2024 and 2023, forfeited, non-vested accounts totaled \$13,472 and \$10,764, respectively. Forfeitures are used to reduce employer contributions or to pay administrative expenses. No forfeitures were used during the year ended December 31, 2024.

Vesting – Participants’ contributions and the Company’s safe harbor matching contributions are fully vested at all times. The vesting schedule for the Company’s discretionary profit sharing contribution is as follows:

Payment of Benefits – Upon termination of employment, the participant, or in the case of death, the participant’s beneficiary, receives the participant’s account balance in a single lump-sum. If the vested portion of the account balance is less than \$7,000, the participant’s vested account balance will be automatically distributed if the participant does not elect to roll-over the balance to another qualified plan. Balances between \$1,000 and \$7,000 will be automatically rolled over to an IRA account, unless the participant elects to roll-over the balance to another qualified plan.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are allowed in accordance with the Plan document. Participants may also receive a distribution of all or any portion of their vested account balance upon attainment of age 59½, in accordance with the Plan Document.

Administrative Expenses – The Plan’s expenses may be paid by the Plan or the Company, at the option of the Company. During the year ended December 31, 2024, the Plan paid \$29,141 in investment advisory and administrative expenses.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, the entire balance of the participant’s account will become fully vested, and all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures. Actual results could differ from those estimates.

Contributions – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Excess Refundable Contributions – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Investment Valuation and Income Recognition – The Plan’s investments in mutual funds and money market fund are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments in variable annuities are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits – Benefit payments are reported in the year paid.

Date of Management’s Review – Management has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued, and there were no material events requiring recognition or disclosure.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies at December 31, 2024 and 2023.

Mutual Funds and Money Market Fund – Valued at the published net asset value (“NAV”) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Alerus Financial, N.A., the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value and contract value
- Net appreciation in fair value of investments
- Dividend and interest income
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. TAX STATUS

The Company adopted a Prototype Non-Standardized 401(k) Profit-Sharing Plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan pays certain fees to Alerus and ERP Retirement Services to administer the Plan. These transactions qualify as party-in-interest transactions.
