Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Fenner AEP 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of the Fenner AEP 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by FAST Houston on April 1, 1990 that provides retirement savings benefits to all eligible employees of the Plan Sponsor and any employers of the Plan Sponsor who have adopted the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2017, the Plan was amended and restated to change the Plan Sponsor to CDI Energy Products, Inc. (Plan Sponsor, Company or CDI). Effective September 1, 2017, the Plan was again amended to change the name of the Plan Sponsor to CDI Energy Products, LLC. Effective January 1, 2023, the Plan was amended to add Fenner flex workers as excluded employees. The Plan was most recently amended effective January 1, 2024, to clarify the Plan's Company matching contribution formula and update the definition of compensation.

Participating Companies and their effective dates for adoption of the Plan are as follows:

CDI Energy Products, Inc. – April 1, 1990
American Industrial Plastics (AIP) - April 1, 1990
Hallite Seals (Hallite) - January 1, 2004
Fenner, Inc. (Fenner) – May 1, 2017

Eligibility

All employees of CDI, AIP and Hallite, with the exception of co-op employees, are eligible to participate in the Plan after the completion of 3 months of service and the attainment of the age 18. Entry dates into the Plan are on the first day of the month following the date on which the eligibility requirements are met.

All employees of Fenner, with the exception of co-op, ex-pat employees, and Fenner flex workers, are eligible to participate in the Plan after the completion of 3 consecutive months of service and attainment of 18 years of age. Entry dates into the Plan are on the date on which the eligibility requirements are met.

1. DESCRIPTION OF THE PLAN – cont'd.

Participant Contributions

Participants may contribute up to 100% of their annual compensation, as defined by the Plan, on a pre-tax basis, not to exceed the maximum allowable contribution under Section 402(g) of the Internal Revenue Code (the Code), which totaled \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants may also contribute Roth elective contributions. A participant's Roth elective contributions are allocated to a separate account maintained for such contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for each of the years ended December 31, 2024 and 2023. Participants are permitted to make rollover contributions to the Plan.

The Plan includes an auto-enrollment provision for employees of Fenner whereby all newly eligible employees are automatically enrolled in the Plan upon satisfaction of the required eligibility requirements, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. There is an automatic increase provision where the automatic deferral percentage will increase 1% each January 1st up to a maximum of 6% of the eligible compensation.

Company Matching Contributions

The Plan includes a safe harbor contribution provision, which requires all Participating Companies under the Plan to make qualified matching contributions on behalf of each participant to satisfy Safe Harbor requirements. Participating Companies, except Fenner, contribute qualified matching contributions each pay period to participants who are actively participating in the Plan at any time during the pay period equal to 100% of elective deferrals up to 4% of eligible compensation, plus 50% of elective deferrals over 4% but not to exceed 6% of eligible compensation. Fenner contributes qualified matching contributions each pay period to participants who were actively participating in the Plan at any time during the pay period equal to 100% of elective deferrals up to 3% of eligible compensation, plus 50% of elective deferrals over 3% but not to exceed 6% of eligible compensation, for the year ended December 31, 2024 and 100% of elective deferrals up to 3% of eligible compensation, plus 50% of elective deferrals over 3% but not to exceed 5% of eligible compensation during the year ended December 31, 2023. Qualified matching contributions paid into the Plan totaled \$2,630,062 and \$2,696,156 for the years ended December 31, 2024 and 2023, respectively.

1. DESCRIPTION OF THE PLAN – cont'd.

Discretionary Company Contributions

The Plan provides for a discretionary Company contribution that allows Participating Companies to contribute at their discretion on behalf of all participants who are actively participating in the Plan on the last day of the Plan year-end. Such discretionary contributions are made at the end of the Plan year. No such discretionary contributions were made during the years ended December 31, 2024 and 2023.

The Plan provides for a separate discretionary Company contribution that allows Fenner to contribute at their discretion on behalf of all participants who are active on the last day of the Plan year-end. Such discretionary contributions are made at the end of the Plan year. No such discretionary contributions were made during the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is participant-directed and is credited with the participant contributions and Company contributions in accordance with the investment options selected by each participant. Any earnings, losses, and administrative expenses are allocated to a participant's account based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants of all Participating Companies, with the exception of Fenner, may borrow up to 50% of their vested account balance, not to exceed \$50,000, without regard to the intended use of the funds. The minimum loan amount is \$1,000. The notes are collateralized by the participant's vested account balance. Participants may up to three notes outstanding at any time and may not take any more than three notes within a twelve month period. Note repayments are to be made at least quarterly with interest based on interest rates comparable to those offered by financial institutions at the time of note origination. Notes receivable must be repaid within five years and spousal consent is required.

Payment of Benefits

Upon termination of service, death, disability, retirement, or attainment of age 59½, a participant or their beneficiary, in the event of death, is entitled to a distribution of their vested account balance. Distributions will be made in a lump sum equal to the value of the participant's vested interest in their account or as installment payments pursuant to the required minimum distribution rules. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts excluding qualified matching contributions may be withdrawn for a qualified hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½. Distributions are subject to the applicable provisions of the Plan agreement.

Payment of Benefits – cont’d.

Effective January 1, 2024, in accordance with the SECURE 2.0 Act (SECURE 2.0), the Plan elected to increase the threshold for mandatory distributions increased from \$5,000 to \$7,000. A formal amendment incorporating all SECURE 2.0 provisions is expected to be adopted no later than December 31, 2026, in accordance with Internal Revenue Service (IRS) guidelines. As of October 8, 2025, the Plan has not been formally amended for these provisions.

As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not been paid as of year-end.

Vesting

Effective January 1, 2017, for employees of all Participating Companies, with the exception of Fenner, participants are immediately vested in participant, Company qualified matching, discretionary and qualified non-elective contributions plus earnings thereon.

For employees of Fenner, participants are immediately vested in participant and Company matching contributions plus earnings thereon. Participants vest in discretionary contributions and earnings thereon based upon years of service according to the following schedule:

Participants will become 100% vested in their account balances upon Plan termination, death or retirement.

Forfeitures

Forfeitures of non-vested portions of Company contributions shall be used to reduce administrative expenses or to offset future Company contributions. Forfeitures not used to reduce administrative expenses or to offset future Company contributions shall be allocated with discretionary contributions according to annual contribution requirements. Forfeitures become available to the Plan immediately on the date of the distribution or if the participant is not fully vested, on the date of termination. The forfeitures account totaled \$0 and \$59 as of December 31, 2024 and 2023, respectively. There were no forfeitures used during the years ended December 31, 2024 and 2023 to offset Company contributions. There were \$27,637 and \$14,565 in forfeitures used during the years ended December 31, 2024 and 2023, respectively, to pay administrative expenses.

Plan Expenses

All expenses are paid with assets of the Plan, unless paid by the Plan Sponsor or any of the other Participating Companies, at their discretion. During the years ended December 31, 2024 and 2023, the Plan Sponsor and Participating Companies paid a portion of the direct expenses related to the Plan. Expenses paid directly by the Plan Sponsor and Participating Companies are excluded from the Plan's financial statements. Distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments. Various investment-related expenses were remitted back to the Plan and held in an unallocated revenue sharing account. Revenue sharing credits totaling \$11 were reallocated to participants during the years ended December 31, 2024 and 2023. No revenue sharing credits were used to pay administrative expenses during the years ended December 31, 2024 and 2023. The balance in the unallocated revenue sharing account totaled \$0 as of December 31, 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are presented using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – cont’d.

Risk and Uncertainties

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur and materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments, except for fully benefit-responsive contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). Fair Value Measurement – cont’d.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the methodologies used for assets measured at fair value:

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

Interests in pooled separate accounts: Valued at fair value based on the unit value of the fund as a practical expedient. Unit values are determined by the institutions sponsoring such funds by dividing the fund’s net assets at fair value by its units outstanding at the valuation dates.

Interests in common/collective trusts: Valued using the net asset value (NAV) of units held by the Plan at year-end as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through October 8, 2025, the date the financial statements were available to be issued, and determined there were no material events that warrant disclosure.

3. INVESTMENTS

All investment data contained in the accompanying financial statements and supplemental schedule as of December 31, 2024 and 2023 and, interest and dividend income and net realized and unrealized appreciation in fair value of investments for the years then ended was obtained or derived from information supplied and certified as complete and accurate by Principal Trust Company, the Trustee of the Plan.

4. GUARANTEED INTEREST CONTRACT

The Plan held a fully benefit-responsive group annuity contract with Principal as of December 31, 2024 and 2023 and for the years then ended. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the fully benefit-responsive guaranteed interest contract. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Principal asserts that fair value equals contract value for the investment.

The traditional investment contract held by the Plan is a guaranteed interest contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reviewed semiannually for resetting. The contract cannot be terminated before the scheduled maturity date.

4. GUARANTEED INTEREST CONTRACT – cont'd.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan sponsor or other Plan sponsor events that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

The Plan administrator does not believe that the occurrence of any such event, which would allow the issuer to terminate the contract and transact at contract value with participants, is probable.

5. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of pooled separate accounts and a guaranteed interest contract managed by Principal Financial Group, who acts as Custodian for the Plan. The Custodian is related to the Trustee. The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Plan Sponsor and Participating Companies provide the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

6. INCOME TAX STATUS

Effective January 1, 2022, the Plan adopted a non-standardized pre-approved profit sharing plan which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor (DOL); however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, all contributions to the Plan would cease and all affected participants would become fully vested in their Company contribution accounts.
