INDEPENDENT AUDITORS' REPORT

TO THE PLAN INVESTMENT COMMITTEE

We have performed the audits of the financial statements of Novogradac & Company LLP 401(k) Profit Sharing Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Novogradac & Company LLP 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan was established on January 1, 1996 to provide retirement benefits for employees of Novogradac & Company LLP (the “Company”). The Plan is a defined contribution plan designed to comply with section 401(k) of the Internal Revenue Code (“IRC”). The Plan covers all eligible employees providing they are at least age 21. Employees covered under a collective bargaining agreement, nonresident aliens, leased employees, and interns are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the IRC.

The Plan provides for a Plan administrator who is responsible for keeping accurate and complete records with regard to the Plan’s operations, informing participants of changes or amendments to the Plan, ensuring that the Plan conforms to the law and to government regulations, and providing participants with any reports and documents required by law. Ascensus Trust Company (“Ascensus”) is designated as a nondiscretionary trustee of the Plan and acts at the direction of the Plan administrator. Ascensus and its affiliates provide recordkeeping and trustee services to the Plan. The Investment Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Effective on December 29, 2022, the Setting Every Community Up for Retirement Enhancement (“SECURE”) 2.0 Act of 2022 (the “Act”) was signed into law. The Act is inclusive of approximately 90 provisions which offer many benefits to employers and Plan participants. Certain provision changes are related to the following, but not limited to: changes to auto-enrollment, auto-escalation and catchup contributions. Depending on the specific provision, some will take effect immediately, while others begin in a future year. As of October 7, 2025, Plan management is in the process of evaluating the subsequent adoption and related impact of certain provisions will have on the Plan. The Plan has adopted the required minimum distributions at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of the SECURE 2.0 Act by December 31, 2026.

Participant Contributions – Eligible employees who are at least 21 years of age are automatically enrolled to participate in the Plan on the first day of the calendar quarter after becoming eligible to participate. The default contribution rate is 5% of eligible pre-tax compensation; however, employees may elect to voluntarily contribute any dollar amount or percentage of their eligible compensation subject to the limitations imposed by the IRC. Participants may also elect to make post-tax (Roth) salary deferrals. For the year ended December 31, 2024, the annual limitation was \$23,000. Participants who have attained at least 50 years of age may make additional catch-up contributions up to \$7,500 annually. Participants may also make rollover contributions representing distributions from an eligible retirement plan.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Employer Contributions – For eligible participants who have completed at least 800 hours of service in six consecutive months, the Company may elect to make discretionary matching contributions and profit sharing contributions. For the year ended December 31, 2024, the Company made a profit sharing contribution between 2.17% and 9.00% of eligible compensation based on contribution rate group allocations. For the year ended December 31, 2024, profit sharing contributions totaled \$3,745,429, net of forfeitures. There was no discretionary matching contribution during 2024.

Participant Accounts – The Plan maintains an account for each participant which is credited with the participant’s contributions and the Company’s matching contributions, and allocations of the Company’s profit sharing contributions and Plan investment earnings or losses, including dividends, and is charged with an allocation of investment and administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that may be provided from the participant’s vested account.

Vesting – Participants are immediately 100% vested in their voluntary contributions, rollover contributions, and any actual earnings thereon. Vesting in the Company’s discretionary matching contributions and profit sharing contributions, if any, and related earnings thereon is in accordance with the following schedule:

However, upon disability or death, the participants become fully vested in both the Company’s discretionary matching and profit sharing contributions.

Notes Receivable from Participants – Participants may borrow from their vested account balances provided they meet the Plan’s eligibility requirements. The minimum loan amount is \$1,000 and the maximum loan amount is the lesser of one-half of the participant’s vested account balance or \$50,000. The term of the loan is not to exceed five years, except for loans used to finance the purchase of a primary residence, which could be for a longer period. Participants are allowed up to one outstanding loan at any given time. The loans are secured by the balance in the participant’s account and interest rates are based on the prevailing prime lending rate plus 2% and remain fixed throughout the life of the loan. Principal and interest are paid ratably through payroll deductions. In case of default due to termination of a participant from employment, the participant can repay the entire outstanding balance of the loan, including accrued interest, before the last day of the quarter following the calendar quarter when the termination occurred to avoid loan default.

Investment Options – The Plan currently offers various exchange traded funds and mutual funds as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

Payment of Benefits – Upon termination of service due to death, retirement, and disability or for any other reason, a participant may receive the full value of their vested account balance as a single lump-sum payment or partial payments over a period of time selected by the participant. A mandatory cash distribution will be made from a terminated participant's vested account balance if it does not exceed \$1,000. A mandatory automatic rollover distribution will be made from a terminated participant's vested account with a balance between \$1,000 and \$5,000 to an eligible retirement plan specified by the participant, or to an individual retirement account designated by the Plan administrator, if no instructions are received from such participant. Effective January 1, 2024, at the time of retirement or termination of employment, if a participant's account balance is in excess of \$7,000, the participant may delay the receipt of distributions. If a terminated participant's balance is between \$1,000 and \$7,000 and no instructions have been received from such participant, the amount will be rolled over to an individual retirement account, as designated by the Plan administrator. Mandatory distributions can be processed immediately following severance from employment. A participant may take a hardship withdrawal from his/her vested account balance for qualifying expenses, as defined in the Plan. A participant may elect to withdraw their vested account balance upon reaching the normal plan retirement age of 59½. Generally, a participant must begin distributions by the later of the year after the participant attains age 73 or the year in which the participant terminates employment.

Forfeited Accounts – The non-vested portion of a terminated participant's investments held in the Plan may be used to reduce the Company's contributions and Plan expenses. During the year ended December 31, 2024, \$80,482 and \$1,151 of forfeited amounts were used to pay the Company profit sharing contributions and Plan expenses, respectively. As of December 31, 2024 and 2023, the balance in the forfeiture account was \$109,375 and \$79,022, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The Plan's financial statements are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results may differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions – Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Concentrations – From the list of investment options, participants determine the investment funds to which their accounts are invested. As of December 31, 2024 and 2023, six and four investment funds accounted for approximately 51% of total investments, respectively.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

Payments of Benefits – Benefits are recorded when paid.

Administrative Expenses – Any fees related to the administration of the Plan or associated with the investment of Plan assets may be paid by the Plan or by the Company. Expenses paid by the Company are excluded from these financial statements. Administrative fees related to participant-directed transactions, such as loan and distribution processing fees, are charged directly to the account of the participant initiating the transaction. Fees related to investment advisory services are paid by the Plan, and are allocated to participants based on their account balances, as defined by the Plan agreement. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under this guideline are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the Plan's valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Exchange-Traded Funds (ETFs): Valued at the closing price reported on the active market on which the individual ETFs are traded.

Mutual Fund: Valued at the daily closing price as reported by the fund. The mutual fund held by the Plan is an open-end mutual fund that is registered with the U.S. Securities and Exchange Commission. This fund is required to publish its daily net asset value ("NAV") and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. The Plan administrator believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE OF THE PLAN

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, the trustee of the Plan, has authorized Ascensus, LLC. to certify the completeness and accuracy of all investments and notes receivable from participants presented in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the supplemental Schedule H, line 4i: Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment and interest income presented in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 – TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

NOTE 6 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Sharebuilder Advisor LLC (“Sharebuilder”) manages the Plan’s investments. Ascensus and its affiliates are the Plan’s nondiscretionary trustee and recordkeeper. Sharebuilder receives investment advisory fees, which consist of an asset based fee of 0.19% of managed assets, directly from the Plan. Sharebuilder remits a portion of these fees to Ascensus and its affiliates for their recordkeeping services.

The Plan incurred investment advisory fees to Sharebuilder amounting to approximately \$161,000, net of recordkeeping fees to Ascensus, which are included in administrative expenses in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

The Plan incurred administrative fees to Ascensus and its affiliates amounting to approximately \$68,000, approximately \$55,000 of which are paid through Sharebuilder, and which are qualified as party-in-interest transactions. These administrative fees are included in administrative expenses in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at anytime and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination among the funds sponsored by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – SUBSEQUENT EVENTS

The Plan's management has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.
