### **INDEPENDENT AUDITOR'S REPORT**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### 1. Description of Plan

The following description of the Fora Financial LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### *a. General*

The Plan is a defined contribution plan more commonly known as a 401(k) plan covering substantially all employees of Fora Financial LLC 401(k) Plan (the “Company”) and its wholly owned subsidiaries who have met certain requirements as to age and length of service described in the Plan Document. The Plan was adopted as of on January 1, 2013 and was amended on January 1, 2022 to name new trustee of the plan. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

#### *b. Eligibility*

Employees are eligible to participate in the Plan once they have reached age 21 and completed three months of service. Automatically excluded employees are those covered under a collective bargaining agreement (i.e., union employees) and non-resident aliens who do not receive compensation from any U.S. sources.

#### *c. Contributions*

Each year participants may contribute up to 100% of the participant’s annual compensation, as defined by the Plan, not to exceed \$23,500 in 2024 and \$22,500 in 2023. The annual compensation limit for purpose of the Plan is stated by the Internal Revenue Code (“IRC”) to be \$345,000 and \$330,000 for the years ended December 31, 2024 and 2023, respectively. Participants may also contribute certain rollover amounts representing distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 in 2024 and \$7,500 in 2023.

The employer may contribute a matching contribution in an amount and percentage at the discretion of the Company. Matching contributions were made during the years ended December 31, 2024 and 2023 of \$373,946 and \$323,206, respectively. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

#### *c. Contributions (continued)*

The Company in its sole discretion, may make Profit Sharing contributions to the Plan. Participants are eligible to receive profit sharing contributions after three months of service during the Plan year. No profit-sharing contributions were made in 2024 and 2023.

#### *d. Participants Accounts*

Each participant's account is credited with the participant's contributions, Company's matching contributions, allocations of the Company's profit-sharing contributions, if any, Plan earnings and withdrawals, and charged with an allocation of investment gains or losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transaction, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *e. Vesting*

Participants are vested immediately in their contributions and the employer matching contributions plus actual earnings thereon. Vesting in the Company's discretionary non – elective contribution or profit sharing portion of participant's accounts is based on years of continuous service. Participants vest 100% upon completion of three years of credited service, in accordance with the Plan document, or immediately if employment is terminated due to death , disability, or retirement upon attainment of the age 65.

#### *f. Notes Receivable from Participants*

The plan permits participants to borrow a minimum of \$1,000 up to 50% of their vested account balance, not to exceed \$50,000. The notes are secure by the balance in the participant's account and bear interest at the prime rate plus 1% which is commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions and notes must be fully repaid within five years unless used for the purchase of the participant's principal residence for which the repayment period is fifteen years. Participant notes are valued at their outstanding principal balance plus accrued and unpaid interest. As of December 31, 2024 and 2023, the Plan had outstanding notes receivable from participants with principal balances totaling \$27,110 and \$19,032, respectively. Interest rates range from 5.25% to 10.50%.

#### *g. Payment of Benefits*

On termination of service due to death, disability or retirement, a participant may elect to receive benefits by a lump-sum amount equal to the value of the participant's vested interest in their account in cash, by a joint and survivor annuity, a life annuity made over the remaining life of the participant or payments made over the life of the participant and a designated beneficiary.

#### *h. Forfeited Accounts*

Benefit payments to terminated participants partially vested in the Plan include their vested portion of Company contributions. Forfeitures may be used to pay plan expenses and then reduce future Company contributions to the Plan. Forfeited nonvested accounts totaled \$0 and \$0, at December 31, 2024 and 2023, respectively. Forfeitures totaling \$34,240 and \$20,558 were used to reduce future Company contributions to the Plan. No forfeitures were used to pay plan expenses in 2024 and 2023.

#### *i. New Authoritative Pronouncements and Legislation*

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

### 2. Summary of Significant Accounting Policies

#### *a. Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America, except that benefits paid to Plan participants are recorded on a cash basis.

#### *b. Use of Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein and, disclosure of contingent assets and liabilities. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

#### ***c. Investment Valuation and Income Recognition***

Investments are reported at fair value, other than fully benefit-responsive guaranteed investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on the investments bought, sold and held during the year.

#### ***d. Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. The Plan had outstanding notes receivable from participants with principal balances totaling \$27,110 and \$19,032, as of December 31, 2024 and 2023, respectively.

#### ***e. Contributions***

Contributions from participants are recorded as they are withheld from the participant's wages. Employer matching contributions are calculated, funded and recorded in the period in which the related participant contributions are withheld. Contributions receivable represent amounts not yet deposited into the participants' individual accounts.

#### ***f. Payment of Benefits***

Benefits are recorded when paid.

#### ***g. Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

#### *h. Date of Management's Review of Subsequent Events*

The company has evaluated events occurring subsequent to December 31, 2024 through September 30, 2025, the date on which the financial statements were available to be issued.

### 3. Information Prepared and Certified by Custodian (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Co.

### 4. Fair Value Measurements

Fair Value Measurements in accordance with current accounting standards, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

An asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Pooled separate accounts ("PSAs") are privately managed through insurance companies and are not publicly quoted. PSAs are comprised, primarily, of shares of registered investment companies held through sub-accounts of an insurance company. The PSAs are valued using net asset value ("NAV") as a practical expedient to estimate fair value where NAV is based on the value of the underlying investment assets held through sub-accounts of a separate account of an insurance company. There are currently no redemption restrictions or unfunded commitments on these investments.

### 5. **Guaranteed Account**

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Co. The Fixed account totaled \$111,018 and \$58,943 at December 31, 2024 and 2023, respectively. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Each premium allocated to the guaranteed investment contract buys a guaranteed minimum amount of lifetime income based on the rate schedule in effect at the time the premium is credited. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and the average for the years ended December 31, 2024 and 2023 is between 4.75% and 10.00%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The annuity contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

### 6. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

### 7. **Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the Determination Letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than now would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. **Related-Party and Party-in-Interest Transactions**

The Plan utilizes various third-party service providers who provide certain administrative services to the Plan pursuant to service agreements. Fees paid to these service providers for administrative services provided to the Plan are included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as exempt party-in-interest transactions.

### **9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits
