As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such



information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the Specialty Steel Works Incorporated Union 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions. Specialty Steel Works Incorporated ("SSWI") (the "Company") is the "Plan Sponsor" and "Plan Administrator" of the Plan.

General

The Plan is a defined contribution 401(k) plan covering employees of SSWI and related employers Corey Steel Company ("CSC"), Michigan Seamless Tube L.L.C. ("MST") and Niagara LaSalle Corporation, who are subject to collective bargaining agreements. All covered employees are eligible to participate after three months of service. Employees who elect to enter the Plan may do so on the first day of the month following their satisfaction of the eligibility requirement.

The Plan is designed to operate under the provisions of Section 401(k) of the Internal Revenue Code of 1986, as amended (the "Code"), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Participants may contribute up to 100% (subject to certain exceptions) of their pretax earnings and 100% of after-tax earnings, as defined in the Plan. Participants who have obtained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also roll over amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a money market fund, various mutual funds and one Common/Collective Trust Fund as investment options for participants.

For members of the Hammond Union hired on or before May 18, 1998, the Company makes matching contributions of 25% on the first 5% of contributions made by the participant. For employees of the Hammond Union hired after May 18, 1998, the Company makes matching contributions of 100% on the first 3% of contributions made by the participant and 50% on the percentage over 3% up to 5%. For MST employees, the Company matches 50% of employee deferrals up to 5% of eligible wages. For South Holland Union participants, the Company matches 50% on the first 3% of participant contributions and 25% on the percentage over 3% up to 5%. The Plan provides that the Company make matching contributions of 100% on the first 3% of contributions made by the participant for CSC employees. The Company may also make an additional discretionary contribution for CSC employees and Hammond Union employees hired after May 18, 1998.

The Plan allows for an auto enroll provision whereby newly eligible participants will be automatically enrolled in a salary deferral agreement at 5% of eligible compensation. In

Contributions (Continued)

In addition, the auto enroll provision will also apply to previously hired and eligible re-hired employees. All participants shall have the ability to opt out of this agreement. There is also a provision to automatically increase the deferral percentage for all participants automatically enrolled by 1% annually to a maximum of 8% of compensation. Effective July 1, 2022, participants with a zero deferral shall be automatically enrolled unless the participant elected zero deferral within seven months prior to the resolicitation date of July 1, 2022.

Effective February 1, 2023, any participant still employed by the employer may elect to have certain fully vested portions of their account be considered designated Roth contributions for purposes of the Plan, treated as a Roth conversion. In addition, eligible employees who have not yet met age or service eligibility requirements will still be able to make rollover contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contributions, employer elective contribution and the participant's share of Plan earnings, and charged with an allocation of certain administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in both their contributions and investment earnings thereon. All qualifying employees, including South Holland participants, hired prior to November 5, 2010 are immediately 100% vested in Company matching and elective contributions. Employees of the Hammond Union hired after November 5, 2010 are 100% vested in the Company matching and elective contributions. Employees of CSC are immediately 100% vested in the Company matching and elective contributions. Effective December 17, 2018, employees of CSC are immediately and fully vested in all past and future nonelective employer contributions. For former employees of the Company's closed Griffith, Indiana plant, MST employees and South Holland participants hired after November 5, 2010,

vesting in the Company matching and elective contributions is based on years of service with the Company as follows:

Forfeitures

Forfeiture of Company contributions may be used to pay administrative expenses or to reduce future Company matching contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,488 and \$56, respectively. In 2024 and 2023, employer contributions were reduced by \$33,708 and \$57,124, respectively, from forfeited nonvested accounts.

Payment of Benefits

Normal retirement age is 62. Retirement, death, disability and termination of employment benefit payments are made by a lump sum payment. Participants may receive an in-service withdrawal of their vested account balance resulting from matching upon reaching 59-1/2 years of age. Participants may also receive hardship distributions, as described in the Plan, from their deferral contribution and all vested accounts. Participants may not make withdrawals of Company contributions more frequently than twice in a 12-month period.

Notes Receivable From Participants

Participants may borrow from their account up to the lesser of (i) \$50,000 reduced by the excess, if any, of their highest outstanding loan balance in the prior year over their existing loan balance and (ii) 50% of their vested account balance. Loan terms range from one to five years, with the exception of loans used for the purchase of a primary residence. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates at the time the funds are borrowed, currently 4.25-9.50%. Principal and interest are paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments - Valuation

The Plan's investments are reflected in the financial statements at fair value as determined by the Trustee in accordance with ASC 820, *Fair Value Measurements and Disclosures*. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 7 for discussion of fair value measurements.

Investment Transactions and Income (Loss)

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. In accordance with the policy of stating investments at fair value, net appreciation or depreciation for the year (including both realized and unrealized gains and losses) is reflected in the statements of changes in net assets available for benefits. Net investment income or loss from mutual funds includes realized and unrealized gains and losses.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. During 2024 and 2023, deemed distributions were \$1,075 and \$6,730, respectively.

Contributions

Participant contributions are made through payroll deductions and are recorded as additions to net assets available for benefits when the deduction is made. Company contributions are recorded as additions to net assets available for benefits when such liability arises. Participant contributions not yet deposited and amounts not funded by the Company are recorded as contributions receivable.

Payment of Benefits

Benefits payments are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Fidelity Management Trust Company is the Trustee of the Plan. The Trustee is considered a party in interest and, accordingly, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing the information to the related information included in the financial statements and supplemental schedule.

4. Related Party Transactions and Party-In-Interest Transactions

The Plan invests in accounts maintained by the Trustee who is considered a party in interest and, therefore, these transactions qualify as exempt party-in-interest transactions. Administrative expenses paid by the Plan to the Trustee amounted to \$44,736 and \$41,750 for the years ended December 31, 2024 and 2023, respectively.

Certain costs of administering the Plan are paid by the Company.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their account balances.

6. Income Tax Status

Based upon the Trustee's receipt of a favorable determination letter from the Internal Revenue Service dated June 30, 2020 with respect to a Non-Standardized Pre-Approved plan on which the Plan is based, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in accordance with the applicable requirements of the Internal Revenue Code and that the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been recorded.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Fair Value Measurements

ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market accounts - valued at the daily quoted net asset value of shares. The money market accounts held by the Plan are deemed to be actively traded.

Mutual Funds - valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

7. Fair Value Measurements (Continued)

Common/Collective Trust - the fair value of participation units held in the Putnam Stable Value Fund (the "Fund"), a common/collective trust (CCT) is based on the net asset value, as reported by the manager of the collective trust fund, Putnam Fiduciary Trust Company, and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. The CCT investments consist of separately managed investment portfolios including traditional guaranteed investment contracts, security-backed investment contracts, a separate account guaranteed investment contract, and short-term deposits. The average weighted maturity of the Fund's portfolio is not to exceed 5 years. The average weighted maturity range, including money market instruments, is 1.5 to 5 years. The Fund will seek to diversify contract maturities by purchasing 1-year through 10-year contracts. No individual insurance contract or bank contract may be purchased with a stated maturity of greater than 10 years. However, the legal final maturity of any underlying fixed income security and wrap contracts may be longer than 10 years. The CCT generally provides for daily redemptions by the Plan at reported net asset value, with no advance notice requirements.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
