***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Alecto Healthcare Services Ohio Valley LLC Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the statement of accumulated plan benefits as of December 31, 2023, and the related statement of changes in accumulated plan benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Substantial Doubt About the Plan’s Ability to Continue as a Going Concern***

The accompanying financial statements have been prepared assuming that the Plan will continue as a going concern. As discussed in Note 1a to the financial statements, the Plan’s management has stated that substantial doubt exists about the Plan’s ability to continue as a going concern. Management’s evaluation of the events and conditions and management’s plans regarding these matters are also described in Note 1a. The financial statements do not include any adjustments that might result from the outcome of this uncertainty. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor’s Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS  
FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023**

**1. Description of Plan**

The following description of the Alecto Healthcare Services Ohio Valley LLC Pension Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General Plan Information and Going Concern

The Plan is a defined benefit pension plan covering substantially all employees of Alecto Healthcare Services Ohio Valley LLC (“Alecto” or the “Company” or the “Plan Sponsor”). The Plan was formed on January 1, 1967. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The sole member of the Company is Alecto Healthcare Services LLC. On June 16, 2023, Alecto Healthcare Services LLC filed a voluntary petition for relief under Chapter 11, Subchapter V of the United States Bankruptcy Code in United States Bankruptcy Court. Due to the Plan Sponsor not funding the 2024 and 2023 minimum employer contributions and the 2023 Pension Benefit Guaranty Corporation (“PBGC”) premium payments, and due to the financial condition of the Plan Sponsor, the Plan is considered a going concern. The Plan Sponsor is waiting for funds that are owed to them to fund the minimum employer contributions and PBGC premiums. Management believes the Plan will continue as a going concern for at least one year beyond the date of this audit report.

The Plan was frozen effective May 19, 2007, and no new entrants were allowed in the Plan after January 1, 2007. In addition, no annual additions are credited to any participant after December 31, 2006, except for certain participants who had satisfied certain requirements as of May 19, 2007, were credited with an annual addition for the 2007 Plan year.

The Plan was amended on June 1, 2017, for the purpose of changing the Plan Sponsor name and identifying number from Ohio Valley Medical Center, Inc. and Ohio Valley Health Services and Education Corporation (collectively, referred to as “OVMC”) and East Ohio Regional Hospital at Martins Ferry (“EORH”) to Alecto Healthcare Services Ohio Valley LLC.

Effective September 1, 2022, the Plan was amended to reflect a change in the trustee and to make other operational and administrative changes.

Prior to the Plan being frozen, an eligible employee automatically became a participant in the Plan after the attainment of age 21 and the completion of 1,000 hours of service during any 12-month period beginning after the employee’s date of hire. Eligible employees did not include employees covered by a collective bargaining agreement, unless the agreement specifically provides otherwise, leased employees, casual employees, resident/intern/extern or temporary/contingent employees.

b. Administration

The Pension Committee is responsible for the administration of the Plan and appoints a trustee to maintain fiscal management of the Plan assets. Members of the Pension Committee are appointed by the General Manager of Alecto Healthcare Services Ohio Valley LLC. As of December 31, 2024 and 2023, Delaware Charter Guarantee & Trust Company (“Principal Trust Company”) is the trustee and Custodian of the Plan assets.

c. Pension Benefits

The benefits for participants are based on a hypothetical account established for each participant. Upon retirement, the participant may elect to receive either a lump-sum payment equal to the account balance or an annuity, which is the actuarial equivalent of the account balance. Under the cash-balance formula, the value of the participant’s account balance is equal to the annual additions credited to his/her account and the accumulated interest thereon. Prior to the Plan being frozen, the annual additions were equal to 6% of a participant’s compensation for the year and, in general, were credited to the account of each participant who completed 1,000 hours of service during the Plan year. The Plan provides for normal, early, late, deferred vested, and disability retirement benefits.

A participant is eligible for normal retirement upon the attainment of age 65 and for early retirement upon the attainment of age 55 and the completion of ten years of service. The benefit provided is equal to the vested value of the participant’s account balance, which is actuarially adjusted if a participant retires early and elects an annuity as the form of payment. Under a late retirement, the benefit is the same as the normal retirement benefit increased by an annual addition and interest earned prior to retirement. Under a deferred vested retirement, a vested participant who terminates employment before becoming eligible for an early, normal, or disability retirement may elect to receive an immediate lump-sum benefit or defer his/her benefit until normal retirement age.

The forms of payment under the Plan include: single-life annuities, joint and survivor annuities, life annuity with ten years guaranteed, and lump-sum payments. Some annuities are payable in either increasing or equal monthly installments. However, if a participant’s account balance is \$1,000 or less, it will automatically be paid to the participant in a single lump-sum. Certain lump-sum payments under the Plan may be transferred to another employer plan or individual retirement account in the form of a direct rollover.

d. Death and Disability Benefits

To be eligible for disability retirement benefits, a participant must incur a disease or bodily injury from an unavoidable cause that lasts at least five consecutive months and qualifies the participant for federal Social Security benefits. The disability may occur at any time, including after the termination of employment. Under a disability retirement, a participant may elect to receive his/her benefits immediately, except if the participant is receiving benefits under the Alecto long-term disability plan.

The Plan also provides that upon the participant's death, the account balance will be paid to the designated beneficiary in the form of a single lump sum. However, if the designated beneficiary is the participant's spouse, the spouse may elect to receive the benefit in the form of a single-life annuity.

e. Administrative Expenses

Administrative expenses of the Plan are paid by the Plan. The Company has the option, at its sole discretion, to pay any expenses on behalf of the Plan. Certain costs are included in the transaction prices of investments bought and sold and cannot be separately quantified.

## 2. **Summary of Significant Accounting Policies**

a. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP") as set forth by the Financial Accounting Standards Board (the "FASB").

b. Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the amounts of net assets available for benefits, changes therein, accompanying notes and supplemental schedules. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Net appreciation in the fair value of investments consists of the net change in unrealized gains during the year and the realized gain on investments sold during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan does not require collateral to secure its investments.

d. Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, which are attributable under the Plan's provisions to service rendered by employees through the valuation date. Accumulated plan benefits include benefits expected to be paid to (1) retired or terminated employees or their beneficiaries, (2) beneficiaries of employees who have died, and (3) present employees or their beneficiaries.

The actuarial present value of accumulated plan benefits is determined by an independent actuary in accordance with ASC 960, *Plan Accounting – Defined Benefit Pension Plans*, and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment. This calculation is determined as of the beginning of each Plan year.

The actuarial present value of accumulated Plan benefits is determined by the Plan's actuary, Principal. The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2024. Had the valuations been prepared as of December 31, 2024, there would be no material differences.

The significant actuarial assumptions used in the valuations as of January 1, 2024 are as follows:

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

e. Payment of Benefits

Benefits are recorded when paid.

f. Subsequent Events

Management has evaluated subsequent events through October 7, 2025, the date the financial statements were available for issuance.

### 3. **Funding Policy**

The Plan's funding policy is to make annual contributions to the Plan in amounts sufficient to meet the funding requirements of the ERISA. The main source of Plan benefits are Company contributions and investment income earned on such contributions. Employee contributions are not permitted.

For the years ended December 31, 2024 and 2023, the minimum contribution levels were determined by the Plan's actuary. The actuarial method currently used to calculate the required funding is the Unit Credit actuarial cost method, as required under the Pension Protection Act of 2006. This funding policy enables the Plan to meet the minimum funding requirements of ERISA and the Internal Revenue Service ("IRS"). The calculation of accumulated plan benefits is estimated by utilizing beginning-of-the-year information.

The minimum required contribution, disregarding the credit balance, for the current Plan year as of the beginning of the year was \$263,876. The minimum required contribution is dependent on the timing of the actual deposits made. In May 2024, the Plan Sponsor contributed \$88,778 for the 2023 plan year. No cash contributions were made for the 2024 plan year.

As of December 31, 2024, the unpaid minimum required contributions for all years totaled \$1,119,968 as disclosed on Schedule SB of Form 5500. This amount includes unpaid contributions for the 2021 plan year, 2023 plan year and the first three quarterly contributions due for the 2024 plan year.

For the Plan years beginning January 1, 2024 and 2023, the Plan's actuary certified that the Plan's Adjusted Funding Target Attainment Percent ("AFTAP") was 90.83% and 84.43%, respectively.

The funding requirement under these provisions is determined under a different calculation than the relationship between the actuarial present value of accumulated plan benefits compared to Plan assets.

#### **4. Information Certified by Asset Custodian (Unaudited)**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA section 103(a)(3)(c) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments, and interest and dividends for the years then ended was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company.

The classification of the investments into the appropriate fair value hierarchy levels (1, 2 or 3) as disclosed in Note 5 is not certified by the trustee and is the responsibility of the Plan's management.

## 5. Fair Value Measurements

### a. Fair Value Hierarchy

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 — inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — inputs to the valuation methodology are unobservable and significant to the fair value.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's investments at fair value. There have been no changes in the methodologies used during the years ended December 31, 2024 and 2023.

*Mutual funds:* Valued at the quoted net asset value ("NAV") of shares held by the Plan at year end.

*Pooled separate accounts:* Investments in pooled separate accounts are valued on a net asset value ("NAV") per unit basis which approximates their fair value. Redemptions may occur on a daily basis. The use of net asset value as the fair value is deemed appropriate as the pooled separate accounts do not have a finite life, unfunded commitments relating to investments, or significant restrictions on redemptions.

## 6. Party-in-Interest Transactions

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or a relative of such persons mentioned. The Company is a party-in-interest. However, there were no transactions with the Company other than the funding of contributions to the Plan.

For the years ended December 31, 2024 and 2023, transactions with parties-in-interest primarily included investment expenses, audit fees, actuarial fees, and other expenses paid by the Plan trustee from Plan assets and totaled \$244,979 and \$146,064, respectively.

## 7. Plan Freeze and Termination

Effective May 19, 2007, the Company froze the Plan. No further benefits accrue under the Plan thereafter.

While the Company has not expressed any intent to terminate the Plan, it is free to do so at any time, subject to ERISA requirements.

Upon termination of the Plan, the net assets shall be allocated by the Plan Administrator on an actuarial basis among participants, surviving spouses and beneficiaries in the manner prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan.
- b. Other vested benefits insured by the PBGC, a U.S. government agency, up to the applicable limitations.
- c. All other vested benefits (that is, vested benefits not insured by the PBGC).
- d. All non-vested benefits.

Upon termination of the Plan, the rights of all affected participants to their benefits then accrued and funded shall fully vest and be non-forfeitable. Benefits already distributed in cash or by purchase and delivery of an annuity contract shall not be affected and are excluded for allocation purposes. Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal-age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, a statutory ceiling exists, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees.

For plan terminations occurring in calendar 2024 and 2023, that ceiling was approximately \$7,108 and \$6,750 per month, respectively. That ceiling applies to those pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or Plan termination (whichever comes later). For younger annuitants or for those who elect to receive their benefits in some form more valuable than a straight-life annuity, the corresponding ceilings are actuarially adjusted downward. Should the Plan terminate, its net assets generally will not be available on a pro rata basis to provide participants' benefits. Whether a particular participant's accumulated plan benefits will be paid depends on the priority of those benefits, the Plan's net assets to provide for accumulated benefit obligations, the financial condition of the Plan Sponsor and the level of benefits guaranteed by the PBGC at that time. Some benefits may be fully or partially provided for by the then existing assets and the PBGC guaranty, while other benefits may not be provided for at all.

## **8. Tax Status**

On February 20, 2013, the Plan received a favorable determination letter from the Internal Revenue Service, provided that those charged with governance of the Plan adopt a technical corrections qualification amendment within the Plan's governing documents. The required amendment was executed within the Plan's governing documents on September 3, 2010. Therefore, Plan management believes that the Plan is qualified and the related trust remains tax exempt as of December 31, 2024 and 2023, and for the years then ended.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **9. Risks and Uncertainties**

The Plan invests in various investment securities, including mutual funds and pooled separate accounts. Investment securities, in general, are exposed to various risks such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
