### ***Basis for Opinion***

**NOTE 1 – PLAN DESCRIPTION**

The following description of the Kikkoman Sales USA, Inc. 401(k) Savings Plus Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for more complete information.

**A. GENERAL**

The Plan is a defined contribution plan covering all eligible employees of Kikkoman Sales USA, Inc. (the “Company”), who meet the eligibility requirements having attained the age of 21 years and who have completed six months of service. The Plan excludes those employees who are: (a) leased employees, (b) independent contractors, (c) union employees, (d) non-resident aliens, (e) an employee temporarily assigned to the US and who is covered by a retirement program by the parent company in Japan, (f) an employee of Kikkoman Marketing and Planning, Inc. (KMP) for employer profit-sharing contributions. For all who are eligible and choose to participate, the entry date is immediately upon meeting age and service requirements.

**B. EMPLOYEE CONTRIBUTIONS**

Under the Plan, participants are allowed to defer a portion of their compensation under a salary reduction agreement. Compensation excludes bonuses, overtime, commissions, reimbursements, other expense allowances, fringe benefits, moving expenses, deferred compensation and welfare benefits. The agreement, which can be revoked at any time, effectively reduces a participant's salary by the amount elected, with the amount of salary reduction being placed in the participant's account. The maximum amount of pre-tax compensation that can be deferred is the lesser of 100 percent of the participant's pay or up to the limits of Internal Revenue Code (“IRC”) section 401(k), 402(g), 404 and 415.

**C. EMPLOYER CONTRIBUTION**

The Company provides an employer match, based on a percentage of the participant's base compensation, as determined annually. Employees become eligible for the match once they have completed one year of service and have reached 21 years of age. The Company made a match of fifty percent of employee contributions up to six percent of base compensation for the year ended December 31, 2024.

The Company contributes a fixed percentage profit-sharing contribution for employees that have reached one year of service and are employed on the last day of the plan year. Eligibility requirements will not apply upon death, becoming disabled or terminating upon reaching normal retirement age. The fixed percentage is 5% of a qualifying participant's compensation for the plan year.

The Company also may contribute a discretionary pro-rata profit-sharing contribution for employees that have reached one year of service, work at least 1,000 hours and remain employed as of the last day of the plan year. Eligibility requirements will not apply upon death, becoming disabled or terminating upon reaching normal retirement age. The discretionary profit-sharing amount that was allocated to eligible participants for the year ended December 31, 2024 was \$58,000.

**D. PARTICIPANT ACCOUNTS**

Each participant account is credited with the participant's elective contributions, employer contributions, and allocations of plan earnings and administrative expenses. Allocations are based on the participant earnings or account balances, as defined. Forfeited balances of terminated participants' non-vested accounts are used to reduce future employer contributions. The benefit to which a participant is entitled is the participant's vested account balance.

**E. NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of the vested account balance or your total accrued benefit, but not more than \$50,000. Participants are allowed one loan at any given time. The loan is secured by the balance in the participant's account and bears interest at a rate determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions and are recorded when received. Loan repayments may be made over a period not to extend over five years.

**F. PAYMENTS OF BENEFITS**

On termination of service due to death, disability, retirement, or other reasons, a participant can choose to have a distribution of his/her account balance equal to the value of his/her vested interest. In the case of early distribution at age 59 ½, the participant may elect to withdraw all or some of his/her salary reduction contributions (including any earnings thereon). The Plan's provisions also provide for withdrawals in the event of financial hardship, as defined by the Plan.

**G. TERMINATION PRIORITIES**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination or partial termination, each participant would become 100% vested in their account balance.

**H. VESTING**

Participants are immediately 100% vested in their deferrals, rollover contributions, as well as employer matching contributions. In the case of the employer's profit-sharing contributions, the Plan uses a cliff vesting schedule in which participants are 0% vested until after three years of service in which they become 100% vested. Upon reaching retirement age, death, or disability while employed, a participant becomes 100% vested.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. FINANCIAL REPORTING FRAMEWORK**

The accompanying financial statements are prepared according to accounting principles generally accepted in the United States of America ("GAAP"), as promulgated by the Financial Accounting Standards Board ("FASB") in the Accounting Standards Codification ("ASC").

**B. BASIS OF ACCOUNTING**

The financial statements of the plan are prepared on the accrual basis of accounting.

**C. ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**D. CONTRIBUTIONS**

Contributions from Plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

**E. VALUATION OF INVESTMENTS**

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is stated at contract value, see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

**F. PLAN EXPENSES**

Administrative expenses may be paid out of the Plan or by the Company. Administrative expenses that are paid from the Plan are first paid from forfeitures, if any, and any remaining amounts are paid from the Plan's trust funds and allocated to all participants on a pro rata basis.

**G. NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are valued at unpaid principal, plus any accrued but unpaid interest, which approximates fair value. Delinquent participant loans are reclassified as distributions based upon the repayment terms of the loan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**H. PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**I. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**J. SUBSEQUENT EVENTS**

The Plan evaluated subsequent events through October 7, 2025, which is the financial statement issuance date. All items which are required for disclosure have been included in the accompanying financial statements and notes thereto.

**NOTE 3 – FORFEITED ACCOUNTS**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$4,902 and \$3,943, respectively. In accordance with plan provisions, these funds will be used to reduce future employer profit-sharing contributions and for payment of recordkeeping fees. For the year ended December 31, 2024, forfeitures used amounted to approximately \$19,773.

**NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The Plan's investments are held in a trust fund administered by Ascensus Trust Company, the trustee of the Plan. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the trustee:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss) and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 5 – INVESTMENT IN A COMMON AND COLLECTIVE TRUST**

The Plan has entered into a synthetic investment contract that qualifies as a fully benefit-responsive investment contract (Morley Stable Value Fund) with Principal Global Investors Trust Company. The total contract value of the Plan's investment was \$2,900,159 and \$2,844,232 at December 31, 2024 and 2023, respectively. The account is credited with earnings on the underlying investments and charged for participant withdrawals and net of administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a monthly or quarterly basis.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Global Investors Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events outside the normal operation of the trust that cause a withdrawal would limit the Plan's ability to transact at contract value with Principal Global Investors Trust Company. Examples of such events include, but are not limited to, fund administration amendments or changes, merger or consolidation of investors, group terminations or layoffs, implementation of an early retirement program, termination or partial termination of the Fund, failure to meet certain tax qualifications, participant communication that is designed to influence participants not to invest in the Fund, transfers to competing options without meeting the equity wash provisions of the Fund, and plan sponsor withdrawals without the appropriate notice to the Fund and/or issuer.

**NOTE 5 – INVESTMENT IN A COMMON AND COLLECTIVE TRUST – (CONTINUED) –**

As of December 31, 2024, the occurrence of an event outside the normal operation of the trust that would cause a withdrawal from an investment contract is not considered to be probable.

In addition, issuers of investment contracts have certain rights to terminate a contract and settle at an amount that differs from contract value. Such events may include but are not limited to: management of the portfolio is not in accordance with investment guidelines, a breach of any material obligation under the wrap agreement, any representation or warranty made by the contract holder becomes untrue in any material way, a replacement of the Investment Advisor without prior consent of the issuer, the Fund is terminated or ceases to qualify as a group trust or plans cease to meet the appropriate tax qualifications, or the wrap becomes a prohibited transaction within the meaning of Section 406 of ERISA. As of December 31, 2024, the Plan administrator does not believe the occurrence of such an event is probable. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

**NOTE 6 – TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examinations by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 – FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

In accordance with the framework, the Plan groups assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 7 – FAIR VALUE MEASUREMENTS – (CONTINUED) –**

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- *Mutual Funds*: valued based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Common Stocks*: valued at the closing price reported on the active market on which the individual securities are traded.
- *U.S. Government Securities*: valued using quoted prices in active markets, when available. When quoted prices are not available for identical securities, fair value is determined using prices obtained from independent pricing services that utilize observable market inputs such as yields, credit ratings, and benchmark yields of comparable U.S. Treasury securities.
- *Certificates of Deposit*: value determined using observable market inputs such as current interest rates for similar instruments with comparable maturities. Due to their short-term nature and limited credit risk, the amortized cost plus accrued interest approximates fair value.
- *Exchange-Traded Funds ("ETFs")*: valued at the daily closing price reported on the active market on which the EFT shares are traded. EFTs held by the Plan are registered with the SEC and are considered actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
