Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of 365 Retail Markets, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of 365 Retail Markets, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of 365 Retail Markets, LLC, as well as certain affiliated entities. Collectively, these companies are referred to as 365 Retail Markets, LLC and affiliates (the "Company"). In general, the Plan covers employees who have completed 30 days of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2024, the Plan was amended to include Impulsify, Inc. as a participating entity and allow years of service earned with Impulsify, Inc. to count toward the Plan's eligibility and vesting requirements.

Contributions

The Plan provides for employee salary 401(k) contributions on a pretax and post-tax (Roth) basis up to the maximum tax-deferred limitations established by the Internal Revenue Code. Once eligible, there is an automatic employee deferral of 6 percent unless the employee elects a different percentage or amount. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions and loan repayments in 2024 and 2022 were paid after the time frame required by the Department of Labor. A contribution of participant contributions was made during 2024 relating to the 2024 contributions. A contribution of loan repayments and lost earnings was made during and subsequent to year end related to the 2024 contributions. The 2022 contributions remain uncorrected.

The Plan provides for safe harbor employer matching contributions of 100 percent of employee deferrals up to the first 1 percent of compensation deferred, plus 50 percent of employee deferrals over 1 percent, up to 6 percent of compensation deferred.

The Plan also allows for a discretionary employer matching contribution and a discretionary profit-sharing contribution. There were no discretionary matching or profit-sharing contributions made for the plan year ended December 31, 2024.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at market rates. Principal and interest are paid ratably through monthly payroll deductions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's matching contribution and discretionary employer contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants with less than two years of service are 0 percent vested and become fully vested after two years of service.

Benefit Payments

Distributions are payable upon retirement, death, disability, attainment of age 59½, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrators must approve any such hardship withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Principal Life Insurance Company (Principal Life), Principal Global Investors Trust Company (Principal Global), and Bank of America N.A. (Bank of America) or their affiliates. Principal Life, Principal Global, and Bank of America are the custodians of the Plan. Therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

During 2023 and 2022, certain amounts were inadvertently distributed to the plan sponsor, which constitute nonexempt transactions. Corrective action consisting of a contribution to refund the inadvertent distributions and related lost earnings is expected to be made to the Plan subsequent to year end.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

The common/collective trust funds and pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no unfunded commitments on these investments. The common/collective trust funds have redemption notice periods ranging from 0 to 365 days. The pooled separate accounts can be redeemed daily and have a 1-day redemption notice period. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Note 2 - Summary of Significant Accounting Policies (Continued)

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 2, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

In 2024, the Plan changed its custodians from Principal Global and Principal Life to Bank of America (collectively, the "Custodians"). The Custodians of the Plan held the Plan's investments and executed all related transactions during the periods under audit. The investment and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information provided by the Custodians. Additionally, Bank of America held and executed participant notes receivable and certified the related balances and interest income as of December 31, 2024 and for the period from November 1, 2024 to December 31, 2024.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plans have received favorable opinion letters from the Internal Revenue Services (IRS) dated June 30, 2020 indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Note 5 - Fair Value Measurements (Continued)

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
